- Budget
 - Scott Jones will have an update from CRR by the 20th, possibly sooner
 - The Natural Resources Conservation Committee (ballot initiative committee) has pledges of \$15k committed but needs an additional \$10k. This committee is unable to provide donation receipts for this since they are political contributions rather than charitable contributions. This committee needs "pledges" for this remaining \$10k.
- Resolution-Appoint Debbie Braucht as DEO
 - Shawn makes a motion to approve posting the position of DEO, Wendy seconds, all in favor, motion passes
 - Ken makes a motion to approve the hourly rate of \$60/hr for the DEO position to be paid on a part time, temporary basis, Wendy seconds, all in favor, motion passes
 - Wendy makes a motion to appoint Debbie Braucht as DEO, pending no other applicants for the position. Shawn seconds, all in favor, motion passes
- Board member
 - Ensure that all board members are continuing to pursue being a qualified board member
 - Laura will set up one on one meetings with all board members that need to finalize qualification
- Printing orders
 - We have a proposal and verbal commitment from the printer
 - Obtain written contract by next meeting so that the board can vote
 - Have not seen a direct quote yet, but will be under \$30K
