## **Treasurer's Report:**

#### **Master Financial Statement 2024/2025**

- 2 Forecast Columns:
  - The second forecast column is with grants withdrawn (federal funding that is on freeze - Bocco Mountain project)
    - Laura is working with the Foundation to fund Allegra and Greg's portions of the grant to sustain activity

- o DCT, America the Beautiful, Vence and all other programs are still being funded
- The CWCB grant for a Beyond Lawn Program Developer was not approved
  - ECCD is still committed to \$10K, and ERWSD is committed to \$5K. Can we continue to make this position work with \$15K? This position will help with strategic planning and grant writing to fund Beyond Lawn rebates starting in 2026.
    - Wendy moves to continue to commit 10K to this position and directs Laura to see if James Dilzell is interested in the position. Ken second, all approve, motion passes
- Laura would like to contract with Avid Design to take on newsletters and social media, to lighten Allegra's load.
  - The board would like to know the cost of contracting a company, and would like to meet the options before proceeding. Laura will set this up for the April board meeting
- Exemption From Audit Approval
  - Wendy moves to approve the Exemption from Audit with the two main changes,
     Scott J second, all approve, motion passes

  - We have all the appropriate forms for all board members

- Meeting with Abbey, Jim & Bret Moore:
  - What is the ability of this group to influence the title of a bill brought forward by the Statute Revision Committee.
  - First big hurdle: legislative staff attorney will review this matter and present a go/no go recommendation to the committee members (committee will likely abide by that recommendation.
  - On hold to hear from The Statute Revision Committee's attorney.
  - ECCD's goal will be to pursue this in lockstep with CACD, and with the lobbyist (Bret Moore)

#### DCT Update:

- Nox Weed Working Group Update:
  - It is now presented as a google form
  - The working group met and made changes to the application.
  - Labor rates need to be solidified
    - Last year we were doing 30\$ an hour, and there seemed to be some level of overrecording.
    - Looking to bump that to \$35 an hour to stay consistent with market rates
    - Maximum dollar amount for mechanical and chemical control?
      - Still subjective per each application leave to the discretion of the board
      - Allegra/Greg will review each application carefully before bringing to the board
      - Greg will look into what Routt County, HPP, Garfield County, does for rates
    - ADD INTO APPLICATION:
      - How many years have you been treating this area?
- Wolf Grant Update:
  - Wolf program has been launched need application in by June to distribute funds (deadline may extend), but so far ECCD has not received any applications.
- Forestry Program: Exploring forestry programs, been in contact with several foresters throughout the state. Talking to Eagle Valley Wildland to coordinate priorities
  - Lake Creek Drainage
    - They are trying to create a committee with one representative from each

- HOA, obtain funding, and grant write for mitigation
- ECCD could help landowners with representation, grants, or available funding.

### Other Program Updates

- Beyond Lawn:
  - Working group meetings are continuing
  - Working with ERWSD to solidify details for taking over their program
  - Laura will work with Magdelena with Edwards Metro, and with ToA about contributions and partnership
  - New rebate applications
  - Lots of presentations coming up
- Virtual Fencing:
  - Techs: two techs from last year, Hayes and Kim, would both like to return as techs.
  - Vehicle: see above
  - o CSU Extension: Has been working on data extraction and data analysis
  - Collars are being ordered for the summer
- FAPL:
  - On pause

Broad discussion on other events that have happened in the past month- meetings, conferences, etc.

#### **NRCS Report:**

- RCPP finished all assessments. 101 applications across the area
  - 2.5mil for the project. The request was 18.7mil dollars
  - Likely 11 or 12 projects will be funded
- EQIP 3.5mil in request for RT3, and 440K to distribute
  - 1.6mil in irrigation infrastructure request
  - 1mil in sprinkler system request

- These are engineering heavy, and there is no longer an engineer at the local office. Leadership is considering rolling the 440K into RCPP, which will take away \$ from irrigation requests, due to lack of engineers (only 28 employees in area 1 right now) and an existing backup of irrigation projects
- Likely will receive a reduction in force plan this week
- Snowpack is right around average
