Treasurer's Report: Master Financial Statement 2022/2023

- Budget Review: (December adoption)
 - 2024 is up to date with current expenses

- 2025 budget:
 - Goal: within the first 5 years, have ½ of our income (after expenditures) in reserves
 - By 2029: should be working with \$736,000
 - Main expenses:
 - Salaries: Executive Director, Program Manager, Vegetation Specialist, DCT, Education/Outreach Coordinator, Seasonal Technician
 - Health insurance for 5 employees
 - 401A Company Match
 - Potential truck expense
 - Accounting/Audit
 - Public Relations/Communications
 - Rent/Office Space
 - Contingency fund for 2025 \$60,000 that can be distributed into other funds as needed
 - Projects: \$140K allocated right away towards conservation projects, beyond the continuing grant funding and future grant funding that is coming in
 - Noxious Weeds \$40K allocated
 - We will continue grant writing for this funding. Guaranteed
 \$40K in/out each year
 - Beyond Lawn \$50K allocated
 - Conservation projects \$50K allocated
 - We will continue to grant write, bringing in a minimum of \$50K each year in grant funding
 - Updates:
 - Funds need to be set aside for board member elections funds to mail ballots to constituents
 - Shawn would like to see more funds allocated towards education/outreach within the community
 - Join the SDA in 2025, increasing dues
 - Do we want to join NACD?
 - Education/Outreach Coordinator move slowly with this position, wait to hire this position until we have a more defined role
 - Move this funding into the contingency fund, making the contingency fund \$140K (including benefits, salary, etc.)

- IKS Consulting
 - Public relations, communications, and outreach support
 - \$12,000 proposal for 2025
 - Ken makes a motion to engage Cliff for 2025 for \$12K plus the month of

December 2024 at the same rate (\$1K). Shawn seconds to motion, all favor, motion passes.

- Weekly Working Group
 - Working on creative ways for the conservation district to move forward staff, board members, and Cliff
 - Laura will keep the board updated on when these will be, for board help, support, and direction
 - Feedback from these meetings will be brought back to the board
- 432 W 5th St Property
 - This was emailed to the board. They have been reaching out to the CD about interest in buying the property to turn into a conservation center
 - Too soon, too little acreage
- CRS- 35-70- CACD reviewing resolutions next week. Needs to be sent to the policy committee by the end of this week
 - Once the language is in Laura's hands from Peggy and Bob Cole, she will work with Scott J. to bring the resolution to CACD

Envirothon:

- We are participating in Envirothon next year nationwide competition for students
- Partnering with Walking Mountain they are implementing and organizing, and we will be funding.

CACD Annual Meeting:

- \$400 for the ticket, and \$130 or so for one night of lodging
 - For both Laura and Shawn it will be around \$1000
- Wendy moves to approve sending Shawn and Laura to the CACD annual meeting and to pay for the ticket and the hotel. Scott S. seconds, all in favor, motion passes
- Scott J. requests that Laura asks WM if they would be open to hosting in the future

DCT Update:

- AtBC- Noxious weed applications
 - <u>Milbery con't</u>
 - Shawn moves to approve the Milbery application for \$652.50. Wendy seconds, all in favor, motion passes. Application approved.
 - <u>McGovern</u>

Other Program Updates

- Beyond Lawn
 - Season concluded, with 67 evaluations done by Allegra and Denyse
 - 14 turf removal applications received, 6 efficient irrigation system application received
 - We are expecting to receive more applications throughout the winter
 - 25,501 sq. ft. of turf removed
 - \$55,504.56 awarded in turf removal rebates
 - \$4,225.29 awarded in efficient irrigation upgrades
- Virtual Fencing
 - Setting up interviews with participating ranchers for 2024
 - Will be offering collars and herd manager subscriptions for 2025 to participating ranchers, we do not expect all ranchers to continue using them.
- Bocco Mountain
 - Permitee solidified Luarks will be using Halter technology on the allotment
 - Water saver built
 - Pond development on 23 ponds
 - Seeding/salting around the ponds
 - Soil moisture probes ordered, to be installed in research zones
 - Contracting with Snaplands, to perform remote sensing data analysis in collaboration with ECCD ground monitoring and data collection
