- 3. I agree to assume full responsibility of any and all risks, injuries and damages, known and unknown, of whatsoever kind and nature, which I might incur as a result of participating in shooting events at HR&GC.
- 4. I assume responsibility for the actions of any and all guests I bring to the HR&GC range.
- 5. In consideration of being permitted to participate in shooting events at the HR&GC, I knowingly, voluntarily and expressly waive any and all claims I, or my Estate, my heirs, or any person claiming under me completely and without reservation that I may have against HR&GC, its officers, employees, or representatives from any and all kinds of injuries or damages that I may sustain as a result of participating in shooting range activities.
- 6. I consent to receive medical treatment, which may be deemed advisable in the event of injury, accident and/or illness during the activities at the shooting range.
- 7. This release shall remain in full force and effect so long as I participate in activities at the HR&GC.
