Every entry made on this entry blank shall constitute an agreement and affirmation that all participants (which shall include, without limitation, the owner, lessee, trainer, manager, agent, coach, driver, rider, handler and the horse) for themselves, their principals, representatives, employees and agents: (1) shall be subject to the rules of the **Burbank Showcase Horse Show**; (2) represent that every horse, rider, driver and handler is eligible as entered; (3) **agree to be bound by the rules of the Burbank Showcase Horse Show**, and will accept as final the decision of the hearing committee on any question arising under said rules, and agree to hold the **Burbank Showcase Horse Show, its officers, directors and employees** harmless for any action taken; and (4) agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death and by participating they expressly assume any and all risks of injury or loss, and they agree to indemnify and hold the **Los Angeles Equestrian Center, Burbank Showcase Horse Show and their officers, directors, employees and agents** harmless from and against all claims including for any injury or loss suffered during, or in connection with the competition, whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officers, directors, employees or agents of the **Burbank Showcase Horse Show**.

- In accordance with Rule 22 in the premium book, dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. No dogs or other pets (excluding horses) are allowed in any arena.
