Notice To All Participants: Rules and Regulations

Please read through this entire document and sign. If you are under that age of 18 you must have a parent or legal guardian sign for you. These rules and regulations are strictly enforced by the creator of the competition (*Jill Nesi*) and the production team behind the **Can U Sing, LLC** competitions. We strive to create a safe and healthy environment for all of our participants, so they may feel valued and protected while exploring their artistic abilities.

- I. Participation in this competition PART I: By filling out and signing all paperwork regarding your participation in the **Can U Sing USA**, **LLC** competition you are agreeing to the terms set forth herein. You will agree to all terms or none at all. If you do not agree with the terms, you will not be able to participate in this or any competition in the future until you accept these terms. These terms are enforced to keep all participants, including, but not limited to, contestants, judges, hosts, producers, creative team members, crew members, production team, company staff, sponsors, partners, affiliates, associated production companies, associated vendors, parents or family members of aforementioned parties and others affiliated, safe.
- II. Participation in this competition PART II: You release the use of your photos, headshots, performance videos, interviews and any other content collected by **Can U Sing USA**, **LLC** to be used exclusively by **Can U Sing USA**, **LLC** in any matters pertaining to the company. This can include, but is not limited to: announcements, flyers, posters, radio advertising, television advertising, interviews, social media advertising and announcements, newspaper articles and advertising. Your private personal information including, but not limited to your home address, phone numbers, social security number, and the like will never be made public by **Can U Sing USA**, **LLC**.

III. Competition Conduct:

a) At no time during your active participation or inactive participation in regards to the competition with Can U Sing USA, LLC is it ever permissible to bully, harass, threaten, slander or make false claims about anyone affiliated with Can U Sing USA, LLC (past, present or future). This includes, but is not limited to, contestants, judges, hosts, producers, creative team members, crew members, production team, company staff, sponsors, partners, affiliates, associated production companies, associated vendors, parents or family members of aforementioned parties and others.

- b) The use of vulgar, defamatory or derogatory language, including bullying, harassment and slander, to defame any member of the competition including, but not limited to, contestants, judges, hosts, producers, creative team members, crew members, production team, company staff, sponsors, partners, affiliates, associated production companies, associated vendors, parents or family members of aforementioned parties and others affiliated with Can U Sing USA, LLC is strictly prohibited.
- c) Being under the influence of, or consuming drugs (not prescribed by a doctor) or alcohol before or during a rehearsal or performance is strictly prohibited and will not be tolerated and will result in your immediate removal from and possible permanent ban from Can U Sing USA, LLC.
- d) Any unscripted or unstaged violence while in virtual rehearsals or during a virtual performance of any kind will not be tolerated and is strictly prohibited. Failure to follow this rule will result in your immediate removal of and possible permanent ban from **Can U Sing USA**, **LLC**. Appropriate legal action will be taken.
- e) The disclosure of company details regarding the process of all competitions, (audition submissions, round by round progression submissions, artistic choices, the run of the competition, the finals, announcements etc.) proprietary information, personal information of any party involved with **Can U Sing USA**, **LLC** to public/private entities not involved with **Can U Sing USA**, **LLC** is strictly prohibited and will result in necessary legal action.
- f) The recording or videography of any round of competition or performance by any participating member of the competition is strictly prohibited unless a member of the **Can U Sing, LLC** team expressly consents to such videography.
 - FAILURE TO ABIDE will result in participants immediate disqualification from the competition. Previous winners must abide by these regulations as well or risk being stripped of their title as a "WINNER."
- IV. Prizes: When the winner or winners are announced, they will be informed of the prizes they have won. Due to the amount of participants fluctuating each competition, there is no singular guaranteed prize amount for each winner for reach competition.
- V. Previous Winners: Out of fairness to all of our competitors in every competition, previous winners must wait one (1) year to compete again for our competition. The **Can U Sing USA**, **LLC** team keeps a running list of past winners and the dates for the competition they won.
