Reflections of Judy Clements

Recently I had the lovely experience of visiting Bertha Henrichs in a care facility in Houston. Last year as Bertha's health declined, it was necessary for her to be closer to family members who would look after her best interests so she left Fort Worth and moved to Houston. When I saw Bertha she had just recently celebrated her 100th birthday.

This is my personal story about a woman who was a pioneer among us.



Unknown to her, Bertha was one of the reasons I joined Network. I had learned of a networking group from my very good friend, Jeanette Alexander. When describing women who made up the group, Jeanette told me about Bertha and her Connections Book Store, which frequently held book reviews and study groups. I was definitely interested. I had just moved to Fort Worth and knew only Jeanette and her husband, so a collective group of interesting women was just what I needed. As I attended each Friday morning breakfast, I became drawn to this most engaging woman—she seemed to know everyone, rarely spoke and, simply with her presence, lit up where ever she was. I was soon to learn that this was Bertha Henrichs.

In the many years to follow, I am only one of many who continued to learn and be impressed by her unique qualities: Bertha and Lee have raised three sons, she was a talented pianist and organist, at sixty she returned to college and received a degree in General Studies from TCU, and in the early 1980's she took a shelf lined corner at the Public House to start what would soon be Connections Book Store. Before she became ill, her interests included music, her yard, her church, and being adamant in her selections of books and tapes for the store in order "to feed people's souls." Not surprisingly, she had grave concerns for "the planet...and its problems." One of the great joys of my life is not just having known her and being considered one of her much loved friends, but having the privilege of being able to observe this incredible woman as she went quietly about the city simply being the woman she was.

ELECTION PROCEDURE 2018

The President appoints 3 members to be the Nominating Committee.

- The Nominating Committee (NC) presents to the membership, the criteria & job descriptions for each position to be filled. (See within)
- The N.C. (Nominating Committee) reviews all the nominated members for each position checking their eligibility and comparing their skills with the job descriptions. (*Oct*)
- The N.C. presents a slate of candidates for consideration at the October Board meeting for their review. (*Date not set yet.*)
- The N.C. creates a ballot and develops a procedure and deadline for members to vote on the candidates in November.
- The N.C. counts the votes and presents the newly elected Board to the membership.

NOMINATIONS ARE OPEN

The Nominating Committee of the Board is looking for nominations for the following positions of the Board:

President 1stVice President 2nd Vice-President Secretary Treasurer

Only those women who have been members for at least two full years are eligible for a board position. In addition the President must have served on the Board (past or present) for at least 1 year. Check the Handbook for the years of membership. The calculations of **two full years**, means that members are not eligible unless they joined sometime in 2015.

The Nominating Committee for 2018: Toni Allison, Chair, Nancy Clyde, Anita Robinson

Forms may be given or sent to Toni Allison, Chair, no later than October 26th. Nominations may be sent via e-mail: toni.allison@outlook.com

Notes:

- 1. You do not need to check on the eligibility of those you nominate. The committee will do that.
- Your nomination does not mean that the person is put on the slate: the person 's skills and eligibility will be researched and the person must agree when called by the committee. If the committee does not call the one nominated, that would mean that she did not meet the eligibility requirements.

Duties of the Board Members

A. The President shall:

- 1. Preside at all Board meetings and general meetings of the Association.
- 2. Establish policies for conducting the business of the Association in cooperation with the Board of Directors. These policies are reviewed every year.
- Contribute to newsletters.
- 4. Assign committees to make all plans and arrangements for special events including but not limited to the Spring/Summer Social, the Holiday/Winter Social, and, the Ruth Marie Cox Award Presentation. The president is an ex-officio member of all committees except the Nominating Committee.
- 5. Appoint a Nominating Committee by September 15th for the upcoming year's election of Board of Directors.
- 6. Appoint a committee for the Ruth Marie Cox Award.
- 7. Appoint a committee to do the planning for the Annual Meeting including location, date, time, program format, installations of officers and any other business deemed necessary.
- 8. Promote attendance and participation in Network events, meetings and activities.

B. The 1st Vice President shall:

- 1. Attend all Board meetings and general meetings of the Association. If unable to attend, provide a written proxy to another member, to vote in her place.
- 2. In the absence of the President, assume all the powers and duties as is appropriate.
- 3. Coordinate conveners and Spotlight Speakers for all Friday morning meetings from February to January of the following year. Provide a written conveners' script and give to conveners **prior** to the first Friday of their assigned month.
- 4. Train the conveners individually or as a group (as needed).
- 5. Ensure that all materials be available for the conveners and spotlight speakers, i.e., Scripts, bell, folder for visitors.
- 6. See that the "brag" money is given to the Treasurer.
- 7. See that the list of conveners and speakers is given to the Communications Director and the President, no later than January 20th each year.
- 8. Develop/revise a set of guidelines for the spotlight speakers including the length of time they should speak and the type of presentation they should make.
- 9. Perform any other duties as assigned by the President.
- 10. Promote attendance and participation in Network events, meetings and activities.

D. The Secretary shall:

- 1. Attend all Board meetings and general meetings of the Association. If unable to attend, provide a written proxy to another member, to vote in her place.
- 2 Write the minutes of the Annual Meeting and give a copy to the new president and new secretary within 14 days after the Annual Meeting.
- 3 Keep a record of all Board Meetings, and provide each board member a copy of such minutes within one week **after** each meeting.
- 4 If requested, furnish the Finance Review committee a copy of all Board minutes for the year being reviewed (See VI, C in this document).
- 5 Perform other duties as assigned by the President
- 6. Promote attendance and participation in Network events, meetings and activities.

E. The Treasurer shall:

- 1. Attend all Board meetings and general meetings of the Association. If unable to attend, provide a written proxy to another member, to vote in her place.
- 2.At each Board meeting, present a written report of the Association's current finances.
- 3. Present a yearly financial report at the Annual Meeting in January.
- 4. Maintain all financial records, including bank statements, deposits and expenses so that these may be used for the annual financial review each year.
- 5. Keep all financial records for five years after which they should be shredded or burned.
- 6. Pay all bills of the Association in a timely manner.
- 7. Collect all dues and other income and deposit them into the bank as soon as possible after their collection.
- 8.As a member of the Budget Committee, assist in the preparation of the next year's budget.
- 9. Perform other duties as assigned by the President
- 10. Promote attendance and participation in Network events, meetings and activities.
