Use of semen is limited to one mare covered by this contract. A single Breeding Certificate will be issued for single foal. Breeding unapproved mare, multiple breedings, misuse of semen, or embryo transplant breedings resulting in multiple foals being born will be prosecuted in civil court with Mare Owner agreeing to pay fees/fines. SEMEN SERVICE CONTRACT

Rebreeding – no charge for semen – but all other charges apply; collection, vet fees if any, etc.

"Live foal guarantee" translates to a standing, viable foal. Should non-viable conditions be confirmed by vet (i.e., abortion, stillborn, mares' failure to conceive), a return season is guaranteed, as agreed by Stallion & Mare Owner/Custodian, providing notification has been given with no less than 30 days in advance. We will try to be as responsive as possible.

No LFG on third re-breed.

Should mare fail to settle after 3rd shipment, Mare Owner/Custodian has option to substitute mare or stallion, based on mutual agreement & documents completed by both mare & stallion owner.

A licensed vet must provide written confirmation/theory regarding slipped/non-viable foal after heartbeat is determined.

Contract guarantees are void if loss is associated w/ failure to maintain mare in proper health; i.e. shelter, nourishment, parasite eradication, poor nutrition, endophyte graze, trauma by other horses, timely inoculations during gestation or appropriate vet attention for infection or mare in distress. Vet statement required.

Inoculation labels are to be retained on documents for verification (pneumabort, etc.)

Vet care excused for any reason makes contract null & void.

Should foal loss be result of mares' lack of shelter, issues of being born amongst wildlife, etc., guarantees are null & void.

Should named stallion become unfit for service, sold, etc., by mutual agreement, mare custodian/owner and stallion custodian/owner will choose another select stallion owned or under custody of signatory agent. This encompasses only stallions offered to public.

Semen collector agrees to ship semen to previously identified vet/servicing agent PRE APPROVED FEDEX COUNTER. All fees to be paid in full – for semen, collection, equipment deposit - prior to shipment. Contract is bound by laws governing state of PA.

Contract not transferrable to any other stallion owned by Breeder, unless agreed by Breeder with no less than 14 days notice – and only those stallions being offered to public.

Stallion owner not liable for any shipping concerns, including, but not limited to: late shipments, etc.

Upon notification of birth and satisfaction of all fees owed, Stallion Owner/Custodian will issue breeders certificate. Should any issue remain unsatisfied, certificate will not be issued in order to register foal.
