Mail in Application Check list

- Concealed Carry Weapon Application
 - Fill out with black ink
 - No corrections, no white out
 - Sign and date to match fingerprints card
- Photocopy of Firearms Training Certificate
 - Verify name in the certificate is the same as ID and fingerprints card
- Fingerprints Card
 - Make sure information Matches CCW application
 - No corrections, no white out
- One (1) Passport photograph
 - Write down your full name and CCW application “T” Number in the back of the photo.
- Photocopy of US Passport if US Citizen or Green Card if Legal Permanent Resident.
- Photocopy of your ID
- \$97.00 Money Order
 - Payable to F.D.A.C.S
 - Make sure to fill out purchaser’s information and keep the receipt/tab for your records. Purpose of Money order is “790.06”

- ☞ Take pictures or scan all documents you are mailing so you have a record of what was sent.

- ☞ Make a note of the CCW application “T” number so you can track the status of your application online.

- ☞ Mail the documents via USPS certified mail so you can receive proof of delivery record.



Applying in person in a regional office

Using a web browser make an appointment by visiting

<https://www.fdacs.gov/Divisions-Offices/Licensing/Regional-Offices>

There are regional offices in the following locations: Jacksonville, Miami-Dade, North Port, Orlando, Plantation, Tallahassee, Tampa and West Palm Beach

Once you've selected the most convenient regional office, click on the **"Apply for a new concealed weapon license"** button.

A calendar will pop up, select date and time and fill out the personal information form with your information: Name(s), Last name, Phone Number, email, and contact method: Phone, email or text messages.

Once you've filled out the form, click on the **"Create Appointment"** so the system creates the appointment and gives you a unique appointment ID. Make a note of that ID or take a picture of the screen.

You will need your picture ID (drivers license or ID) your US Passport or certificate of naturalization if US citizen or Permanent Resident Card (Green Card) if you are a US Resident. A staff member will direct you to fill out the Concealed Weapon License Application, take your fingerprints and photograph as well as pay the \$97 for the License and Fingerprints processing.

NOTES:

Follow the FDACS protocols, you might have to wait in your car until called in.

If you have ever been arrested, you should bring certified copies of the court documentation reflecting the final disposition of the charge(s) filed against you.

FDACS has a 7-minute grace period. If you're late to the appointment you will have to request a new appointment! Be on time!

👉 Read chapter 790 it in its entirety, this is a requirement of the class and must be completed on your own time. This statute contains the law passed by legislature to regulate Weapons and Firearms in the State of Florida. Pay special attention to 790.06 statute that list places where you are restricted from carrying a weapon or firearm even if you have a license.

👉 It is **Mandatory** that you read [statue 790](#) (weapons and firearms) and **recommended** that you become familiar with [statue 776](#) (justifiable use of force).



While reading Florida Statutes 790 and 776, pay attention and become familiar with:

☞ **The Reasonable and Prudent Person doctrine:**

“What would have a prudent and reasonable person done in the same situation you were in, knowing what you knew at the time of the situation”

☞ **Florida’s Gun Owners Rights and Responsibilities**

☞ **Understand that after you use force for self-defense, there are many actors that will determine your future (go home to your family or end up in jail as a criminal)**

Suspects / Attackers

Prosecutors

Witnesses -Human and Electronic

Defense Attorneys

Responding Police Officers

Judge(s)

Investigating Officers

Jury(ies)

☞ **Understand the Elements of Ability, Opportunity, and Jeopardy**

Ability means that the attacker possesses the means of causing death or great bodily harm.

Opportunity means that the attacker has the opportunity to carry out a deadly force attack using the ability(ies) previously cited

Jeopardy means that the attacker had the unequivocal intention to carry out an attack.

NOTE: Please understand that this class is intended to provide you with the minimum legal requirements to be able to apply for a concealed weapon license and is not to make you an expert in use of lethal force. At the end of this booklet, you will find a list of classes that provide more training in the subject.

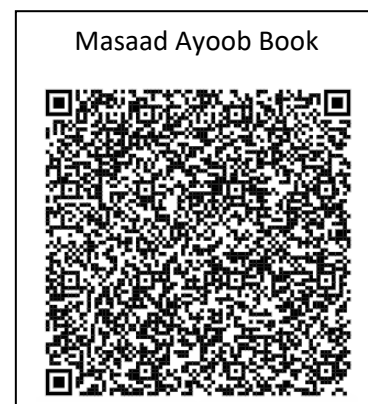

In a person's own home or place of business.	✓	✓

Public places not otherwise prohibited by law.	✓	⊘
Property of any public or private school, school bus, school bus stop, or school activity or event, career center, college, technical school, or university	⊘	⊘
Any school, college, or professional athletic event not involving firearms.	⊘	⊘
Hospitals that do not provide mental health services.	✓	⊘

Firearm Safety Rules

Gun Safety is **everyone's** responsibility.

The NRA three most important rules of gun safety are:

1. ALWAYS keep the gun pointed in a safe direction.
2. ALWAYS keep your finger off the trigger until ready to shoot.
3. ALWAYS keep the gun unloaded until ready to use.

Guns are neither safe or unsafe by themselves.

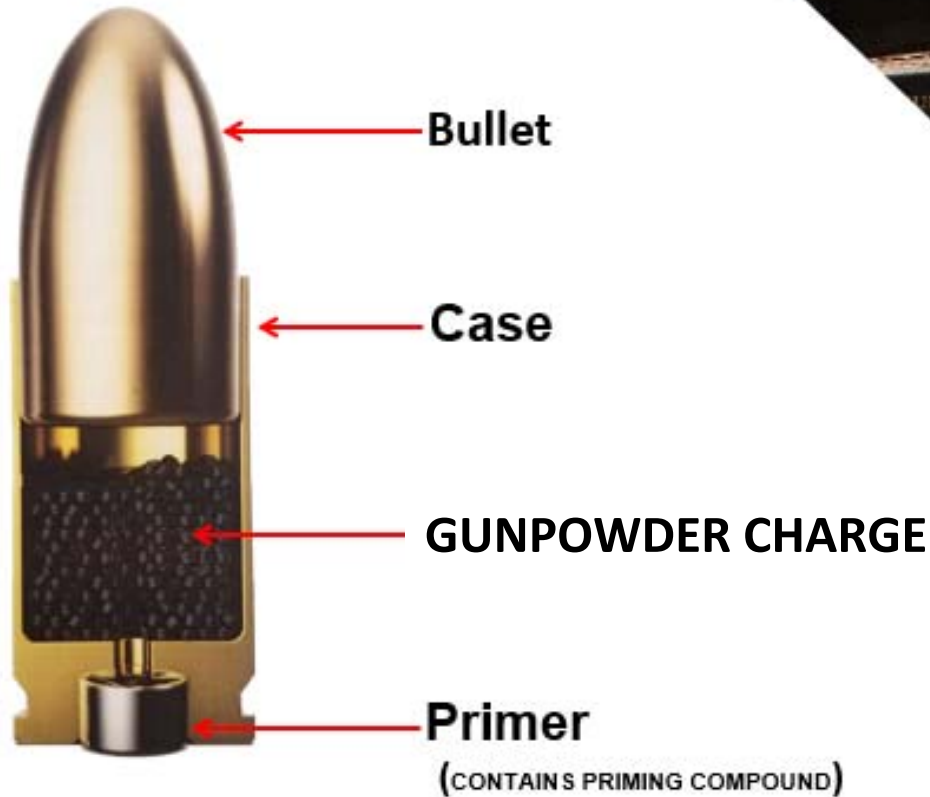
When people **practice** responsible gun safety, firearms are safe.
