As your cake decorator, it is my pleasure to offer my service to you. With that, I agree to deliver the above described baked good(s) in a timely manner, with the following conditions:

- 1) For items less than \$100, a non-refundable \$25 deposit is required at the time the order. For orders greater than \$100, a security deposit of 50% of the total amount is due at the time the order is placed. This deposit ensures that and holds the specified date, time, and the current price agreed upon.
  - a) For large orders that are over \$200, to include all wedding cakes, the remaining balance is due two (2) weeks prior scheduled delivery date. For all other orders, the remaining balance must be paid in full no later than 48 hours to scheduled delivery.
  - b) For all wedding and/or large orders (greater than \$200) that are placed within two weeks of specified/desired delivery date, full payment is due at the time of the order.
  - c) Any desired change(s) to the placed order(s) must be made no later than two weeks prior to scheduled delivery.
  - d) A \$30 deliver/setup fee is required for cakes that have more than 3 tiers. The individual is also subject to other delivery fees that will be assessed depending on where the good(s) are to be delivered.
  - e) Please note: Prices are subject to change if there has been no deposit made guaranteeing the price agreed upon at the placement of the order(s).
- 2) In the case of fresh flower usage to be displayed on the cake and or good, the responsibility of the flower safety and safe food practices will rest with the florist, NOT with "Piece of Cake". The individual placing this order should contact a florist to obtain a notice of plant safety.
- 3) Colors PINK, BLUE, PURPLE, BLACK, or any shade of these colors cannot be guaranteed and is sold "as-is". These specified colors are unstable and tend to fade and/or bleed into the surrounding colors/frostings.

- 4) NOTICE: Ingredients or machinery may have come in contact with nuts, milk, and wheat products. "Piece of Cake" is not responsible for any allergic reactions to any individual consuming the good(s), nor is "Piece of Cake" responsible for any individual who consumes the good(s) who become ill.
- 5) In the case of an unavoidable occurrences (i.e. car accidents/poor road conditions) during delivery, "Piece of Cake" cannot be held liable for more than the price of the good(s) ordered.
- 6) The Client will provide clear driving instructions to the location and inform "Piece of Cake" of any adverse road hazards, conditions, and/or obstacles that may hamper the delivery and quality of the finished good(s).
  - a) Please note: Excessive jarring due to "potholes", road construction, or any unseen road condition may damage the product or cause the product to become unstable.
