COUNTY WHEEL TAX REFERENDUM

Shall Resolution No. 05-18-10 as amended, be approved? Said Resolution, passed according to Tennessee Code Annotated 5-8-102, by the Roane County Commission, levies a wheel tax in the amount of \$50.00 per vehicle upon all vehicles taxable by the State of Tennessee and registered to Roane County residents, with said wheel tax to automatically expire after 15 years, and during years one through ten, the entire proceeds of the wheel tax to be directed toward funding the school building and consolidation plan adopted by the Roane County Board of Education on April 19, 2018, and during years 11 through 15, \$30.00 of each \$50.00 collected to be directed toward funding the aforesaid school building and consolidation plan, and \$20.00 of each \$50.00 collected to be directed toward Roane County's debt service fund.
