Breeding Contract for Fresh or Frozen Semen

This **"Agreement** is made effective as of _____ by and between Rabbit Hole Dressage Ltd. ("RHD") and the breeder ("Breeder") identified below (Page 3) for the 2026 breeding season. The purpose of which is breeding to the Stallion identified as Gaudi (KWPN registration # 528003201100630) to the Breeders mare identified below (Page 3) with the goal of producing one Live Foal. RHD offers with this agreement a live foal guarantee defined as a foal that stands, nurses and survives the first 48 hours after birth. A LFG is valid for a term of three (3) years ending September 15, 2029, subject to the following terms and conditions.

1. FEES

Breeding fee of \$2,400 + GST (CDN) (\$1,750 USD Tax Exempt)

Includes:

3 Year Live Foal Guarantee

Fresh or Frozen Dose

- a) Payment of Fees. The Breeding fee plus applicable taxes are payable immediately upon signature of this contract.
- b) Fresh Collection Fee of \$350 +GST and Shipping Fees will be organized and payable separately to Okanagan Equine Veterinary Services Ltd. (OKEVS)
- c) Methods of Payment Etransfer, Paypal, credit or debit. Etransfers to info@rhdressage.ca. Online payment can be made through our website at www.rhdressage.ca. A 3% credit card processing fee will be applied for credit card payments.

2. SEMEN COLLECTION AND SHIPMENT REQUEST

RHD receipt of the above Stallion Breeding Fee confirms the Mare's reservation to breed to the stallion for the present breeding season which shall extend from March 1st to September 15th. All fresh semen requests must be received by 8am PST 48 hours prior to the requested collection by filling out the Semen request form (can be found at www.rhdressage.ca) Semen request form can be sent by email to info@rhdressage.ca. Breeder will receive receipt acknowledgment from the RHD office. It is the Breeder's responsibility to ensure that the office has received the semen and collection request.

Initial _____

Collection is available Monday through Thursday.

Fresh semen will be shipped overnight via Federal Express. It is the Breeder's responsibility to verify that Federal Express offers 24-hour delivery service to the shipping address provided in this contract.

Semen provided under this Contract may not be used to breed any mare other than the mare identified in the Contract or to re-breed the Mare once a Live Foal has been produced.

3. PREGNANCY CHECKS

Milestone pregnancy checks are 14-18 days, 30-35 days, and 90 days post ovulation checks.

4. EMBRYO TRANSFER

There will be no additional charge if Breeder does embryo transfer and recovers two embryos but only one (1) live foal guarantee will apply.

5. RETURN OF SERVICE

Breeder shall not be entitled to a refund of any fees paid with the exception of point 6 below. The Mare shall have the right of return to the Stallion's service in the following breeding season only in the following circumstances:

If the Mare does not settle during Present Breeding Season, she is eligible for a return of service to the stallion the year following the signature of this contract if the Breeder submits a veterinarian's certificate to that effect. Prior to the mare's return to service, The Breeder recognizes RHD's right to a veterinary reproduction health certificate indicating healthy uterus and ovaries on ultrasound exam, no fluid production in the uterus, and good estrus (heat) of the uterus.

If the mare becomes barren after conception or if the foal that is born is unable to survive the first 48 hours the mare is eligible for return with veterinary report.

If the Mare becomes unfit for breeding or otherwise unbreedable, Breeder may substitute another mare. Breeder must request this change in writing.

6. DEATH OR UNFITNESS OF THE STALLION

The fees paid or incurred under this agreement are nonrefundable with the exception of death of the stallion or unfit for collection and there is no frozen semen available to fulfill the contract then a full refund will be issued by RHD.

7. NON-ASSIGNMENT

This contract cannot be assigned or transferred by Breeder. There shall be no right of return to the Stallion if the Mare is sold or otherwise changes ownership after having been served by the Stallion.

WARRANTY

RHD is not responsible for lost, delayed or damaged semen and makes no representations of warranties of any kind with respect to any semen furnished hereunder except that it is the Stallion's. All warrantied or merchantability and fitness for purpose are hereby excluded.

8. GOVERNING LAW

This contract shall be governed by the laws of the province of British Columbia and shall be binding upon the parties hereto and their personal representatives
