# **TODAY'S 107<sup>th</sup> ENGINEER BATTALION:**

The 107<sup>th</sup> Engineer Battalion had the pleasure of welcoming home 5 separate entities from overseas deployment, along with numerous individual deployments.

On 16 December 2005, the 40 Soldier Assault & Obstacle Platoon led by 1LT Thomas LaFave and SFC James Wallis returned home after nearly 15 months of duty with the 224<sup>th</sup> Engineer Battalion from the Iowa Army National Guard. The A & O was attached to A Co, 224 EN BN. LT LaFave had this to say about their mission:

"The first mission that we had for A&O was a school mission in Najaf. We sent out some of our equipment operators out to do some repairs and beautification for a local school. We sent out different people with the Bobcat and the SEE's. They were there for about a week. While that was going on we also had some FOB projects going on for Camp Duke, we were digging for showers and latrines.

Form there we started getting ready for the move up north to Ramadi. This also largely included our equipment operators driving our 916's hauling the tracks and dozers. Once we got to Ramadi we were split up. The Assault squads were separated in to the line platoons. And Obstacle was left to do the FOB projects and run equipment to TQ as well and other places in Iraq. The line plts were set up for convoy escorts. We started running convoys all over Iraq. Shortly after getting to Ramadi we were selected to run a MOAG (Mother of all generators) mission which consisted of the whole battalion. That took nine days to finish that mission. When we got back from that we started running Task Force Ironhawk and convoys. First Platoon with our second squad did convoy escorts and the Second Platoon did Ironhawk missions. It stayed that way for most of the time over there. We switched some time around July. 1st Platoon was sent out to do cache sweeps and 2nd Platoon took over the convoys. When 1st Platoon got route clearance they also got the Meerkat and Husky so they started doing mechanical route clearance which was the first time we as A Co had that equipment. The company switched back again in September. And that is how we finished out the rest of the time there.

While this was going on the Obstacle crew had jobs that took them to other FOB's such as Shark base to make a pad for additional troops as well as ripping up a landing pad for the helo's. They had another mission

that brought them to Al Quim on the Syrian border there they made a parking lot and a garbage dump. They also had one mission out side the FOB to reduce a berm that was being used by insurgents to place IED's in. there were some special missions that they were included in as well such as bull dozing houses that were out side Blue Diamond. They also had to go to check points along route Mobile to help fortify them.

The last mission we had was with the "Protector" which is an electrical IED hunting machine. This mission encompassed the whole platoon. The Obstacle Section was in charge of running the HEET's and the Assault Sections were in charge of the security.

As far as injuries, we as a platoon only had one and that was SGT Jannaush. He received the Purple Heart when a mortar hit the building he was in and threw him into another room. Other awards were given out as well such and the Michigan Legion of Merit, along with many ARCOM'S and AAM's."

Also on 16 December 2006, a platoon of 33 Soldiers, mostly from B Company returned from nearly a year-long deployment to Kuwait. The platoon was led by 1LT Daniel Eady and SFC Michael Wheeler. LT Eady writes this synopsis of their mission:

"Our mission in Kuwait consisted of port security for a sea port called SPOD just south of Kuwait City. We got attached to the 227 Engineers out of Hawaii for the duration. After our mobilization we arrived in country and were supposed to get at least a few days to acclimate and get over the jet lag but hardly before a day was through our Michigan platoon was sent out on a detail. We were to construct single strand concertina wire obstacles to make a road boundary just outside the compound where we were staying. This did not bother us, for it was an engineer task we were all well versed on. At the time we didn't know that it would be the last engineer task that we would accomplish while we were in Kuwait. In the few fallowing days we went out to more ranges to re-zero our weapons.

After all that we had become acquainted with the 227 Engineers and were to move out to where they were staying on SPOD. Once we were moved in, a normal day consisted of getting up and going to work at an ECP (Entrance Control Point) or riding in one of the roving patrols on some location around the port. Part of the job consisted of working with the KMOI (Kuwaiti Ministry Of Interior) which was the Kuwaiti police. If there was anything that happened involving suspicious individuals or vehicles the KMOI was contacted and they were allowed to take care of the situation by themselves as much as possible.

Working on an ECP consisted of checking ID's, searching TCN's (Third Country Nationals) raising and lowering gorilla arms, and just generally keeping a lookout. The ECP's worked directly with the BDOC (Base Defense Operations Center). If anything happened out of the ordinary or if any of the ECP's needed anything the BDOC was contacted and they would decide what to do about the problem. All the senior leadership worked in the BDOC.

In an attempt to give the sea port back to the Kuwaitis we could no longer live on SPOD and were relocated to another base west of SPOD. It was about a 15-20 minute commute to the SPOD every day after the move. We lived in big 58 man bays rather than the 8 man tents that we had previously been living in on SPOD. The new base that we were living on was quite nice. It had gyms, PX, outdoor food court, dining facility, outdoor stage for performances, and even a pool, not too far away from were the 58 man bays were located.

The only major injury sustained by a soldier was a torn ACL. All the Michigan soldiers really did an outstanding job and bring great credit to their unit back in Michigan. While deployed there were many awards presented to the solders."

The 107<sup>th</sup> celebrated the beginning of 2006 by welcoming home the Utility Detachments from A Company and C Company, both on 25 January.

The A and C Company Utility Detachments were re-organized in the fall of 2004 from Mechanized Engineers to Utility Engineers. The Utilities consisted of Plumbers, Carpenters, and Electricians. Each Detachment spent nearly 1 year in Iraq. The A Co Utility spent most of their deployment helping rebuild the notorious Abu Ghraib prison, while C Co built and improved the areas in and around Camp's Liberty and Hope. The A Company Utility was led by CPT Mark McNeill and 1SG James Baker. C Company Utility was led by CPT George Rollins and 1SG John Smith.

Here is what CPT McNeill had to say about A Co's deployment:

"The A Company Utility Detachment mobilized through Camp Atterbury, Indiana and arrived at Camp Beuhring, Kuwait early in February 2005. After additional weapons and convoy training and adding armor to our vehicles most of the unit flew north into Iraq to our first assignment at LSA Anaconda near Balad. The rest of the unit convoyed the newly armored vehicles into Iraq. We fell under the 507th EN BN and were situated next door to the 1436<sup>th</sup> En Co, both Michigan National Guard units so there were a lot of friends and familiar faces. Our first missions were construction missions in support of LSAA.

At the end of March the unit received a mission to begin construction of a 400 man detainment facility called Redemption at the infamous Abu Ghraib Prison just west of Baghdad. This was a challenging task since the site was under water. An advance party began the task of draining the area and established what began a long and productive partnership with Kellogg, Brown and Root (KBR). The 507<sup>th</sup> enhanced the unit with several augmentations of Soldiers and equipment from several units including the 1436<sup>th</sup> and the 463<sup>rd</sup>. Eventually the entire Det was relocated to FOB Abu Ghraib. About mid way through the project control of the A Utility Det was transferred to the 194<sup>th</sup> En Bde, an Army National Guard unit from Tennessee. The 194<sup>th</sup> continued to offer Soldiers and equipment from the 891st and 230<sup>th</sup> Engineer Battalions, to ensure the success of the project. The facility was completed in mid June.

A Co Det continued to support FOB Abu Ghraib with DPW support and additional construction improvements for detainee operations. A Co, with a lot of help, eventually built another 400 man facility called Remembrance, and 2 other "special holding facilities", along with hundreds of FOB improvement projects. A portion of the unit was involved in a project on Camp Victory, near where C Co Utility Det was located, so again we were close to familiar faces. One interesting meeting involved an old A Co squad leader, retired SSG Tom Sipe who was operating a wretch for KBR at a Class IV yard on Camp Victory. The 194<sup>th</sup> rotated home in December and the Det fell under the 130<sup>th</sup> En Bde for the remainder of the deployment. The Det came home at the end of January. Awards for the Soldiers included AAM's, ARCOM's, MSM's and BSM along with the Iraqi Campaign Medal and the Global War on Terrorism Medal. Thankfully there were no Purple Hearts.

All the members of the unit would like to thank the community and the Family Readiness Group for their outstanding support throughout our deployment; we couldn't have done it with out you, Thank You."

Finally, on 21 April 2006, the 107<sup>th</sup> welcomed home the 29 Soldier Sapper Platoon. The Sapper Platoon was deployed to Afghanistan for nearly a year with the 3-141<sup>st</sup> Infantry Battalion from the Texas Army National Guard. The Platoon was led by 2LT Jason Rolling and SFC Jeffrey Gibson. The Sappers were assembled with Soldiers from all 4 companies of the 107<sup>th</sup>, with most of them coming from B Co.

SFC Gibson tells us about his platoon's time spent in Afghanistan:

"The 107<sup>th</sup> Engineers mobilized a Platoon of 29 soldiers for deployment to Afghanistan on 07 March 2005. The platoon headed by SFC Jeff Gibson and 2LT Jason Rolling, mobilized from Company B, but was comprised of personnel from every armory of the 107<sup>th</sup>. After completing mobilization station activities at Fort Hood Texas, the Platoon arrived in Afghanistan on 10 May 2005.

Originally the Platoon (better known as the "Yooper Platoon") was designed to split up and support the 3/141 Infantry Battalion, performing Engineer missions at PRT's (Provincial Reconstruction Teams) across the country. However, immediately upon arrival in Afghanistan the plans changed. The Yooper Platoon was given orders to reconsolidate and take over Operations and Force Protection of the Kandahar PRT in Southern Afghanistan. This involved security, TOC operations, logistics, and even mess operations. In addition to PRT Operations, the Platoon performed over 500 missions outside the wire. Everything from escorting Civil Affairs teams to project sites, job site security, escorting and securing Generals and Ambassadors, to a 10 day mission with the Dutch Army. If this wasn't enough... the Yoopers where ordered to ready the PRT for turn over to the NATO Forces (the Canadian Army in this case). This proved to be quite a challenge logistically. But, in fine Yooper fashion, the Platoon performed all these tasks (originally performed by a Company size element) without fail.

After a short refit, the "Yoopers" where then assigned to Task Force Sword (Engineer Operation for Afghanistan) and attached to perform Force Protection for TF Pace Maker (864<sup>th</sup> Engineer Battalion). The task... Force Protection and Security for the TK (Taren Kot to Kandahar) Road construction project in Central Afghanistan. Due to numerous attacks on the Task Force, the Task Force Commanders instructions where, to 'Keep the Bad Guy away, while we finish the Road'. This mission lasted about 2 months and required splitting the Platoon in half for Northern and Southern Security. After countless hours, missions, dust, windstorms, and escorts, the Platoon accomplished just that... zero attacks on the TF while the "Yoopers" controlled the road, allowing the road project to be completed ahead of schedule.

After completion of the TK Road project, the Platoon stayed with TF Pacemaker and moved to FOB Sharana (Eastern Afghanistan). The reputation and abilities of the Platoon continued to spread throughout the country. Now on the Afghanistan and Pakistan border, the Platoons Force Protection mission required numerous FOB (Forward Operating Base) tasks. Rebuilding the Entry Control Point (ECP), and "miles" of Triple Standard Concertina fence just to mention a few. Once again, the mission... 'Keep the bad guy away, while the TF works on a road reconstruction project'.

After 1589 missions, 24/7 ECP/VCP operations, and countless miles of escorts, the Platoon arrived home on 21 April 2006. The Country of Afghanistan, many Active Duty Units and Coalition Forces, now know who the 107<sup>th</sup> Engineer Battalion and a "Yooper" is. Your soldiers performed impeccably and represented you well!!!"
