

TERMS & CONDITIONS

HIRE AGREEMENT

By signing Funny Bunnies Soft Play Short List Hire Agreement on the day/date of your hire, you the “Hirer” will be entering into a Legal Contract with Miss Kirsty Weston trading as Funny Bunnies Soft Play Hire. You the “Hirer” are agreeing to abide by both the Full Terms and Conditions set out by Funny Bunnies in the Full Hire Agreement version detailed below and the Short List Hire Agreement provided by Funny Bunnies on the day/date of your hire. The contract commences when instructions have been received from the hirer and are accepted by Funny Bunnies Soft Play Hire and terminates when all parties have discharged their contractual obligations.

You the hirer, will be asked to sign a copy of Funny Bunnies Short List Hire Agreement Terms and Conditions and Disclaimer as well as being asked to provide photo Identification on the day of your hire before any Hire Equipment is set up by Funny Bunnies. Without a signature or failure to provide acceptable Identification on the day of your hire will result in our Funny Bunnies cancelling your booking.

Identification Accepted by Funny Bunnies Soft Play Hire:

-Acceptable Identification we are able to accept are the hirer’s Driving Licence or Passport (these must be current and up to date).

-On the day of your hire Funny Bunnies will take a photo of the hires proof of identity before they commence in setting up your Hire Equipment and once the hirer has accepted and signed Funny Bunnies Short List Hire Agreement Terms and Conditions document.

-Upon collection of the Hire Equipment so long as all the Terms and Conditions have been adhered to by the hirer, the photos which were taken of the hirer’s proof of identity at the beginning of the hire will be discarded off in front of the hirer by Funny Bunnies upon the termination of the Hire Agreements with Funny Bunnies Soft Play Hire.

-If any of the Terms and Conditions have not been adhered to by the hirer at any time, Funny Bunnies reserve the right to keep the hirer’s proof of identity photos on file until such time they are no longer required. This information will be used by Funny Bunnies Soft Play Hire to legally obtain any outstanding balances owed to them, caused by or arising from the hirer breaching his or hers contractual agreement with Funny Bunnies Soft Play Hire Agreement Terms and Conditions. Funny Bunnies reserves the right to invoice the hirer within seven (7) days to recover any outstanding balance owed.

1. Please ensure that the following safety instructions and protocol are adhered to at all times:

A) It is the sole responsibility of the individual who is hiring the Hire Equipment from Funny Bunnies Soft Play Hire to ensure that all necessary steps and producers set out in both this full and short Hire Agreement are taken to avoid injuries or damages to the Hire Equipment. The hirer shall not use the Hire Equipment for any purpose other than that is described in both the full and short Hire Agreement, and they shall not sub-hire or use the Hire Equipment or allow the Hire Equipment to be used for any unlawful purpose or in any unlawful way.

B) Funny Bunnies Soft Play Hire accepts no responsibility or liability for any damages to our Hire Equipment whilst our equipment is under hire to you. The hirer shall assume full responsibility for any damage to or loss of the Hire Equipment or part thereof, howsoever caused. Where the Hire Equipment is lost or stolen and cannot be retrieved, the hirer agrees to pay Funny Bunnies Soft Play Hire the full manufacturer’s cost to replace the lost or stolen Hire Equipment. The hirer agrees to pay Funny Bunnies Soft Play Hire all costs incurred in rectifying the condition of Hire Equipment returned damaged by prohibited items or excessively unclean.

C) Funny Bunnies Soft Play Hire accept no responsibility or liability for injuries to any personnel caused by misuse of any Hire Equipment. The hirer agrees that the Hire Equipment is used at the users' own risk. The hirer hereby agrees to indemnify Funny Bunnies Soft Play Hire against claims or proceedings of any sort or in respect of any personal injury whatsoever (including injury of the hirer). We suggest that you take out your own personal public liability day insurance covering your own liability should anything arise from the use of the Hire Equipment whilst under hire to you the hirer.

D) The hirer MUST accept full responsibility for ensuring all children using our Hire Equipment are to be constantly supervised by at least one adult, over the age of 18 and who is NOT under the influence of alcohol or who is intoxicated under the influence of prescribed and/or non-prescribed drugs whilst our Hire Equipment is on hire to you.

E) ONLY children up to the age of five (5) years old may use our Hire Equipment; equipment/items MUST not be climbed or sat on by adults or children over five (5).

F) It is the hire's and other supervising adult's responsibility to ensure the Hire Equipment does not become over crowded; limiting numbers according to the age and size of the children using the Hire Equipment, ensuring all children have sufficient room for safe play; try to avoid large and small children from using the same Hired Equipment at the same time. The hirer must at all times prevent horseplay behaviour ensuring children do not push, collide, fight or behave in a manner likely to injure themselves or cause injury and or distress to others.

G) Any injured person should receive professional medical assistance within two hours of the event causing them injury. Any injuries MUST be reported to Funny Bunnies upon collection of the Hire Equipment and an accident form will be completed with you, the hirer; any records of the medical treatment obtained will be made available for Funny Bunnies Soft Play Hire inspection. Accident forms will not be completed after Funny Bunnies have departed from your venue/premises.

H) Suitable clothing MUST be worn by all children/users at all times as friction burns on soft play equipment can occur. Take extra care in hot weather as the soft play equipment can also become very hot to touch.

2. Prohibited Items Terms and Conditions:

It is the hirer's responsibility to ensure that;

A) NO type of footwear is to be worn on any of the Hire Equipment at any time this also includes adults.

B) Socks MUST be worn at all times on any of the Hire Equipment this is for both hygiene and health & safety reasons.

C) Smoking or any other type of cooking equipment are NOT permitted anywhere near any of the Hire Equipment.

D) NO pets are permitted to be allowed near or on any of the Hire Equipment.

E) Adults are NOT permitted to use any of the Hire Equipment with exceptions to the ball pit as this causes them to lose their shape and firmness therefore causing damage.

F) Adults are NOT permitted to sit on any of the Soft Play Equipment, the Soft Play Surrounding Borders/Barriers or the Ball Pit Walls as this causes them to lose their shape and firmness therefore causing damage to them. If sitting inside the ball pit please sit on the matting on the floor not on the balls.

G) Sharp objects such as but not limited to jewellery, belts, badges, key-rings, metal studded clothing and any other sharp objects liable to catch on other users/children's clothing MUST be removed before they can use any of the Hire equipment; avoiding injury to themselves or other users/children and to prevent the Hire Equipment from being damaged.

H) NO coloured dyes objects/items such as but not limited to henna, glitter, silly string, party poppers, confetti and children with face paint on are permitted anywhere near or on any of the Hire Equipment as all of these items CAUSE permanent stains on the Hire Equipment therefore damaging the Hire Equipment.

I) NO food, sweets including chewing gum are permitted anywhere near or on any of the Hire Equipment therefore eliminating choking hazards and mess.

J) NO drinks or any other fluids or liquids are permitted anywhere near or on any of the Hire Equipment therefore eliminating choking hazards and mess.

3. Equipment and Equipment Location Terms and Conditions:

A) It is the hirer's responsibility to check and ensure that there is adequate space required for their chosen Hire Equipment. All of our Hire Equipment description can be found on our website www.funnybunnies.com.au Upon delivery, if the Hire Equipment does not fit into the space provided by the hirer; you, the hirer are still liable to pay the total outstanding amount of the hire purchase. Funny Bunnies cannot be held responsible if the Hire Equipment does not fit in the space provided by the hirer.

B) Once all of our Hire Equipment is set up it is the hirer's responsibility to avoid damage to any of the Hired Equipment. Any damages caused to any of the Hire Equipment will result in the hirer being held responsible for paying the full manufacturer's retail cost for repair or the full cost of replacing the damaged equipment/items. Funny Bunnies reserves the right to invoice the hirer within seven (7) days to recover any outstanding balance owed.

C) No large Hire Equipment SHOULD BE MOVED once it has been set up by Funny Bunnies as this can cause wearing and tearing of the fabric/material. Funny Bunnies will not place any Hire Equipment in a position where users/children have the potential to become injured or where the Hire Equipment could be damaged.

D) Please DO NOT attempt to pack any of the Hired Equipment away, as upon collection Funny Bunnies need to carry out a damages and prohibited items check in order for you, the hirer to receive your Maintains Deposit back.

E) Any unsatisfactory working Hire Equipment must be notified to Funny Bunnies Soft Play Hire team without delay. The hirer must not attempt to repair any of the Hire Equipment.

4. Outdoor Hires Terms and Conditions:

A) It is the hirer's responsibility to ensure that location of the Hire Equipment when being used outdoors MUST be suitable; by this we mean the area MUST be flat, level (no steep slopes or gradients) and be clean of any mess or debris including oils etc. Upon delivery Funny Bunnies can refuse to set up the Hire Equipment in a location that they deem to not be clean or suitable for our Hire Equipment. You, the hirer are still liable to pay the total outstanding amount of the hire purchase.

B) All outside bookings are subjects to last minute cancelations (up till the day of the hire) in the event of adverse weather conditions if Funny Bunnies Soft Play Hire deems necessary due to Health & Safety Risks and for the protection of our Hire Equipment.

C) On the day of the Hire it is up to Funny Bunnies discretion upon delivery whether our service are able to continue as an outdoor hire/event in relation to bad weather, if our services are unable to continue as an outdoor hire we will try our upmost to find a suitable indoor venue at short notice between us or we will offer to rearrange the booking for another suitable date.

D) If after the Hire Equipment has been set up and it begins to rain, we do not offer any discount or refunds.

E) In the event of rainfall during your hire, the Hire Equipment MUST NOT be used by any users/children at any time owing to Health and Safety Risks associated with rainfall. Therefore preventing and or avoiding injury as the Hire Equipment can become very slippery when wet.

F) It is the hirer's responsibility to cover over and protect all Hire Equipment in the event of heavy rainfall using the tarpaulin material provided by Funny Bunnies at the beginning of your outdoor Hire Agreement. Failure to cover over and protect any of the Hire Equipment during rainfall; will result in the Hire Equipment becoming water logged therefore damaging the Hire Equipment and you the hirer will be held responsible for paying the full manufacture's retail cost for either repairing or replacing the damaged Hire Equipment/items. Funny Bunnies Soft Play Hire reserves the right to invoice the hirer within seven (7) days to recover any outstanding balance owed.

G) When the rainfall has subsides any wetness on the Hire Equipment can be dried off with a towel and play can reassume when the hirer certifies that the Hire Equipment is safe to use and is no longer slippery, dangerous and is not deemed a Health and Safety Risk.

5. Delivery and Collection Terms and Conditions:

A) We offer 50km Free Delivery Services as standard in all our Hire Packages. Deliveries outside the 50 km allocated allowance will incur a delivery charge of \$0.50 per km.

B) You, the hirer will be available upon delivery to sign our Short Hire Agreement Terms and Conditions and Disclaimer and to check that you are happy with all the Hire Equipment supplied by Funny Bunnies Soft Play Hire and that all Hire Equipment corresponds to your Hire Purchase.

(C) A pre-arranged date and time will be agreed between the Hirer and Funny Bunnies Soft Play Hire for the delivery and pick-up of the hired Equipment.

(D) The Hirer grants Funny Bunnies Soft Play Hire the right to enter the property at the street address specified by the Hirer for the delivery and subsequent collection of the Equipment at the pre-arranged time.

It is the hirer's responsibility to ensure that there is adequate access and parking (a minimum of two car parking spaces) to the agreed venue/location for the delivery, unloading and the collection and reloading of the Hire Equipment.

(E) The delivery and collection times may change as Funny Bunnies Soft Play Hire deems necessary to accommodate additional hires for the same date as the Hirers. While Funny Bunnies Soft Play Hire will endeavour to deliver and collect equipment as close as possible to the agreed hire allocation, Funny Bunnies Soft Play Hire will deliver the equipment to the address specified by the Hirer up to two hours prior of the pre-arranged delivery time, and collect the equipment up to two hours after the hire termination time.

However we cannot and or are not responsible for any delay incurred through unforeseen circumstances these included; unforeseen traffic problems, adverse weather conditions or incorrect address given etc. Funny Bunnies Soft Play Hire cannot be held responsible or liable for any consequential expenses, liability losses, claims or proceeding whatsoever caused by or arising out of late delivery or non-delivery. The Terms and Conditions of Hire for the equipment are applicable from the delivery time to the pickup time.

(F) It is the Hirers sole responsibility to ensure that the delivery address provided is correct. Funny Bunnies Soft Play Hire will not be held liable for late or non delivery due to incorrect address information provided. Should the Hirer provide an incorrect address or is not at the specified address within 2 hours of the scheduled delivery time, Funny Bunnies Soft Play Hire are not obliged to deliver the equipment or allow the equipment to be used and all monies paid will be forfeited. Funny Bunnies Soft Play Hire shall not be liable for any loss or damages arising out the provision of incorrect address details or should the hire be cancelled due to Hirer not arriving at the specified address within the 2 hour window.

(G) Funny Bunnies Soft Play Hire reserves the right to charge a Late Fee if the Hirer fails to make the Equipment available for pick-up at the pre-arranged time. The Late Fee shall be equivalent to \$200 per hour (or part there-of) and be charged hourly until the Equipment is available for pick-up.

(H) The Hirer must ensure that suitable access to and from the site of the proposed set up of the Equipment is adequate to suit the mode of delivery and collection. Funny Bunnies Soft Play Hire reserves the right to request further information about an event or require an inspection prior to delivery to ascertain suitable access. A high risk delivery fee of \$180 will be charged should it be deemed necessary.

HIRE AGREEMENT CONT...

(I) The hirer is responsible for arranging vehicle access with local government or facility management booking departments for all parks and open spaces that allow such access. Should vehicle access not be arranged or granted Funny Bunnies Soft Play Hire reserve the right to refuse to offload, set-up and allow the equipment to be used should the booked area/zone/facility be further than 20m from the delivery vehicle and the hirer is unable/unwilling to relocate to a suitable site. All monies paid will be forfeited and Funny Bunnies Soft Play Hire shall not be liable for any loss or damages arising out of the enforcement of this clause.

(J) The Hirer is to declare any stairs or long distance walk between our trailer and your chosen venue/location. Should there be more than 10 stairs and no alternative entry to a facility and this has not been declared on your booking nor have you paid the high-risk delivery fee, Funny Bunnies Soft Play Hire reserve the right to refuse to offload, set-up and allow the equipment to be used. All monies paid will be forfeited and Funny Bunnies Soft Play Hire shall not be liable for any loss or damages arising out of the enforcement of this clause.

K) Funny Bunnies Soft Play Hire accepts no responsibility or liability for any damages that may occur to the hires chosen venue/location during the delivery, set up, use and collection of the Hire Equipment.

L) The hirer MUST inspect all Hire Equipment supplied and to have agreed that all Hire Equipment supplied is in a good, condition unless he/she brings to the attention of Funny Bunnies when the Hire Equipment is set up and checked over by the hirer when coming into possession of the Hire Equipment any faults noted by the hirer that they were not informed about during the booking stage.

M) ONLY Funny Bunnies are authorised to deliver and collect the Hire Equipment and under no circumstances should any of the Hire Equipment be handed over to any other personnel other than them.

N) The hirer hereby authorises any Funny Bunnies Soft Play Hire employee (upon production of the Short List Hire Agreement Terms and Conditions document; signed by the hirer on the day/date of hire) to enter upon any premises wherein a Funny Bunnies Soft Play Hire employee reasonably believes any of our Hire Equipment or part thereof to be, and if, in so far as the owner in his/her absolute discretion deems necessary, to inspect, repair, replace or re-possess the same.

Please refer to our website (<https://funnybunnies.com.au/delivery>) for information regarding delivery, access and what may be deemed high risk.

6. Booking/Payment Terms and Conditions:

A) The Hirer is required to pay \$50 of the booking (inclusive of equipment hire value and delivery fee) via direct deposit to secure the hire. The Hirer is required to pay any remaining balance in full, 5 days prior to delivery of the Equipment.

The hire will not be secured until the \$50 payment has been received and you have received a confirmation email of your booking from Funny Bunnies Soft Play Hire Team.

B) If the remaining invoice balance is not received in full 5 days prior to delivery, Funny Bunnies Soft Play Hire are not obliged to deliver the equipment or allow the equipment to be used. Any monies paid will be forfeited.

HIRE AGREEMENT CONT...

(C) Our Hire Equipment prices are quoted for (3) hours hire only; unless the hirer's has purchased extra additional play time (\$50.00 per hour) upon booking.

(D) Late collection services; time/slots past 19:00 will incur a late night pick up fee at an additional \$35.00 per hour; the total amount will be added to the hire purchase total balance as agreed at the time of booking.

(E). Any obstructions made by the hirer or the hirer's guests causing unnecessary delay in the collection of the Hire Equipment will result in the hirer being charged at \$50.00 per hour or part of. Funny Bunnies Soft Play Hire reserves the right to invoice the hirer within seven (7) days to recover any outstanding balance owed.

(F) Funny Bunnies Soft Play reserves the right to cancel any Hire Equipment purchase and to offer an alternative Hire Equipment supplement should the original Hire Equipment purchase no longer be unavailable relating to circumstances cause by and beyond the control of the Funny Bunnies Soft Play Hire.

(G) In the event that the equipment that has been hired becomes unavailable due to damage or theft, Funny Bunnies Soft Play Hire reserves the right to substitute the equipment with a product that is comparable and similar in functionality to the current item(s) hired. If comparable and similar equipment is not available, Funny Bunnies Soft Play Hire will process a full refund. Funny Bunnies Soft Play Hire shall not be liable for any loss or damages arising out of Funny Bunnies Soft Play Hire's inability to provide equipment due to damage or theft.

(H) Re-hiring of any of our Hire Equipment to a third party is expressly forbidden.

7. Promotional and Discount Offers Terms and Conditions:

(A) Only ONE qualifying promotional and discount offer can be redeemed per booking and therefore cannot be used in- conjunction with each other unless stated otherwise by Funny Bunnies Soft Play Hire.

(B) NO promotional and discount offers have any cash value.

(C) Promotional and discount offers can ONLY be redeemed ONCE and are only valid until the offers expiry date ends; detailed of which can be found on each promotional and discount offer's own Terms & Conditions; unless published otherwise on either Funny Bunnies Soft Play Hire website www.funnybunnies.com.au or our Facebook business page <https://www.facebook.com/funnybunniessoftplayhire>.

(D) ONLY qualifying promotional and discount offer codes are redeemable and MUST be presented/used at the time of booking. Funny Bunnies Soft Play Hire reserve the right to refuse invalid codes.

(E) Qualifying promotional and discount offers cannot be redeemed once a booking is confirmed.

(F) Funny Bunnies Soft Play Hire reserve the right to withdrawn and or cancel any promotional and or discount offer without prior notice.

HIRE AGREEMENT CONT...

8. Maintains Deposit

(A) A cleaning, minor damages and Ball Pit “balls” deposit of \$50.00 (here on after referred to as “Maintains Deposit”) is required on all hire purchases and is payable on the day of your hire as a cash payment. The Maintains Deposit will be returned to the hirer at the end/termination of the Hire Agreement so long as both the Short List and Full Terms and Conditions set out by Funny Bunnies Soft Play Hire Terms and Conditions have been adhered to.

(B) We expect to collect all of our Hire Equipment with NO Prohibited Items on them and for them to be free of damaged caused by any of them (Prohibited Items are detailed above in the prohibited items section. All Hire Equipment should be arranged in a clean and tidy condition; the way it was left prior to Funny Bunnies departing from the hirers venue/location after setting up the Hire Equipment.

(C) Any Hire Equipment that is collected and or returned to us with Prohibited Items on them, will result in the hirer incurring a cleaning penalty charge/fine starting at a minimum of \$50.00 that will be deducted from the hirer’s Maintains Deposit. The hirer agrees to pay Funny Bunnies all/full costs incurred in rectifying the condition of equipment returned damaged by prohibited items or excessively unclean.

(D) Any Hire Equipment that is collected and or returned with prohibited items on them that have caused permeate damage to the Hire Equipment will result in the hirers being held responsible for paying Funny Bunnies Soft Play Hire the full manufacture’s retail cost for repair or the full cost of replacing the damaged equipment/items. Funny Bunnies Soft Play Hire reserves the right to invoice the hirer within seven (7) days to recover any outstanding balance owed.

(E) If there are insufficient funds to cover the penalty charges/fines set out above Funny Bunnies Soft Play Hire reserves the right to invoice the hirer within seven (7) days to recover any outstanding balance owed.

9. Cancellations Terms and Conditions:

(A) Cancellation terms apply once a booking has been accepted, by accepting the written quote provided by Funny Bunnies Soft Play Hire.

(B) Cancellations must be made in writing, via email, to Funny Bunnies Soft Play Hire.

(C) The following cancellation terms apply;

(D) If the booking is cancelled in excess of 7 days prior to the hire date, the Hirer will be issued a full refund of any monies paid.

(E) Cancellations made by the hirer within twenty four (24) hours of the hire date will result in the hirer being held responsible and liable for paying 50% of the total hire purchase. Funny Bunnies Soft Play Hire reserves the right to invoice the hirer within seven (7) days to recover any outstanding balance owed.

HIRE AGREEMENT CONT...

(F) Cancellations made by the hirer within six (6) hours of the delivery time or upon delivery will result in the hirer being held responsible and liable for paying 100% of the total hire purchase. Funny Bunnies Soft Play Hire reserves the right to collect full payment upon delivery or to invoice the hirer within seven (7) days to recover any outstanding balance owed.

(G) During periods of severe or poor weather conditions (rain, electrical storms, high winds, flooding etc), Funny Bunnies Soft Play Hire reserve the right to cancel a booking. If Funny Bunnies Soft Play Hire deems your location unacceptable due to poor weather or imminent poor weather conditions, or any other reason Funny Bunnies Soft Play Hire deems unsuitable and a new suitable location cannot be located, Funny Bunnies Soft Play Hire reserves the right to terminate the booking. In this instance, a full refund will be issued or a change of date will be offered if the date requested is available. Funny Bunnies Soft Play Hire shall not be liable for any loss or damages arising out of Funny Bunnies Soft Play Hire's decision to cancel a booking in these circumstances.

(H) If the Hirer cancels due to undesirable weather, this will be handled as per clause 10.

(I) For active bookings that are subject to a postponement agreement such as;

- i. government-mandated restrictions,
 - ii. agreed on postponement due to illness, or
 - iii. any other reasons agreed to between Funny Bunnies Soft Play Hire and the Hirer,
- no further cancellations will be accepted and all monies will be forfeited.

10. THEFT OR DAMAGE TO EQUIPMENT

(A) Funny Bunnies Soft Play Hire shall not be liable for any loss or damages arising out of the misuse, or abuse of the Equipment by the Hirer and the Hirer agrees to keep Funny Bunnies Soft Play Hire indemnified in respect thereof.

(B) In the event of undesirable weather conditions, it is the responsibility of the Hirer to ensure adequate, safe coverage of the Equipment to avoid damage to the Equipment.

(C) It is the responsibility of the Hirer to ensure that the Equipment is secure at all times and where being stored in an unlocked premises, supply such security as to ensure its safekeeping.

(D) In the event of damage* to the Equipment, the Hirer agrees to pay Funny Bunnies Soft Play Hire an amount equal to:

- 1) all costs associated with replacing the Equipment plus a 6% administration fee, or
- 2) all costs associated with the repair of the Equipment plus a 6% administration fee (if deemed repairable).

(E) *Damage includes but is not limited to;

- tears in vinyl,
- stains left on vinyl due to food or face paint,
- damage to equipment due to being left in rain or direct sunlight,
- damage to the structure of equipment due to incorrect or malicious use
- damage to EVA mats caused by high heel shoes, chairs or gazebo/tent legs or pegs

HIRE AGREEMENT CONT...

Funny Bunnies Soft Play Hire will notify the Hirer in writing within 7 days of the hire period of any claim of damages.

(F) In the event of theft of the Equipment supplied, the Hirer must immediately notify Funny Bunnies Soft Play Hire, and the Hirer will be responsible for all costs associated with the replacement of the Equipment. Funny Bunnies Soft Play Hire is under no obligation to provide replacement Equipment.

11. LIABILITY AND INDEMNITY:

(A) Funny Bunnies Soft Play Hire are only liable to the Hirer to the extent permitted by law.

(B) The Hirer acknowledges and accepts that persons using the Equipment can be injured.

(C) Funny Bunnies Soft Play Hire are not liable to the Hirer or anyone else for any expenditure, injury, loss or damage:

- arising out of the hire and use of the Equipment,
- arising from late delivery of the Equipment,
- arising from an inadequate amount of space for the Equipment to be used safely,
- arising from the Hirer ordering the incorrect Equipment, or insufficient quantities of the Equipment, or where the Equipment is hired for a purpose which is outside the Equipment's specifications.

(D) The Hirer indemnifies Funny Bunnies Soft Play Hire against any liability to any third party who suffers injury, loss or damage where such injury, loss or damage is caused wholly or partly as a consequence of any negligent act or omission or other failure on the Hirer's part to ensure the Equipment is used, stored, erected or transported safely.

12. PRIVACY:

(A) Funny Bunnies Soft Play Hire respects the Hirer's privacy and complies with the Privacy Act 1988 (Cth). Any personal information the Hirer provides Funny Bunnies Soft Play Hire in order to supply Equipment according to this agreement, will be dealt with pursuant to the privacy laws.
