PASTOR REPORT

2023 Annual Report
To the Congregation of Resurrection Evangelical Lutheran Church

"Blessed are the flexible, for they shall not get bent out of shape."

- not Jesus, but sounds like him.

As I reflect on the last 10 months of serving as your Transitional Pastor, I have been heartened by the flexibility of this congregation and its leaders. Coming out of COVID, the mainline church in North America (of which we are a part) has faced tremendous challenges, with lower worship attendance and flagging program engagement.

I have been privileged to learn about the history and traditions of this congregation, and what programs and ministries have been important to you over the decades. However, I am also amazed at the level of experimentation and change you have undertaken in such a short amount of time. My goal as your Transitional Pastor is to provide leadership stability, but also raise questions about changes we can make in our ministry to help reduce stress on our volunteers and office staff. In this time where you are preparing for the call process, the preparation work we are doing now will be of benefit to this church and your newly called minister.

Vitality Initiative for Congregations Program

Currently a team of individuals from Resurrection are taking part in the Nebraska Synod **Vitality Initiative for Congregations Program**. I am proud of the dedication and hard work of this team. Their work is a three-step process.

- They have already gathered information about this congregation's history. That
 has been valuable in understanding how God has been at work for decades in this
 church.
- 2. Currently, they are interviewing people of the congregation to hear their perceptions of our church and how they see God at work here.
- 3. The next part of the process will include a discernment of the "vocation" that God is calling us to embrace as we live into the future.

The Vitality Initiative process will conclude in March of 2025. I know this is an extended timeline, but I am glad Resurrection is taking time to slow down, engage deeply with the Vitality Initiative process, and prepare the ministry for future opportunities and the call process.

Pastor's 2023 Project Report

During these past 10 months, as your transitional pastor, I have been focusing my time and energy on the following areas:

1. Working with leaders to change our Sunday morning worship schedule and encourage new times and formats for Sunday school.

- 2. Attending ministry team meetings to introduce myself and learn each team's purpose and mission.
- 3. Attending Worship and Music Committee meetings and working closely with Dr. Matt Hill to create a quality and uplifting worship experience.
- 4. Catching up with "pastoral acts" (baptisms, new member recognition, etc.) that have been on hold during the absence of a called pastor.
- 5. Working with the elected leaders to develop transitional "core values" (see page 40) to guide us in this interim time.
- 6. Being a part of the Vitality Initiative for Congregations process and a member of our team here at RELC.
- 7. Leading the hiring process for a Social Media & Web Coordinator and helping our new staff member Bridgid Agosta to develop content for a new website.
- 8. Streamlining and administering our 6th Grade Mentoring, Confirmation and High School Youth Ministry in the absence of a paid staff member being responsible for these areas.
- 9. In the absence of a High School and Children's Ministry director, working with our High School and Middle School parents to have social and service events that help keep our youth engaged.
- 10. Interviewing candidates who have applied for the positions: Director of Children's Ministry and Director of Youth Ministry.
- 11. Gathering a current list of our members who are "shut ins" and unable to come to church on a regular basis.
- 12. Working on our administrative processes and staff interaction to create an efficient and collegial work environment.

Pastor's 2024 Focus Areas

In 2024, would like to focus my work on some of the following areas:

- 1. Promote new approaches to **stewardship** to encourage congregational generosity.
 - a. Personal testimonials on Sunday morning
 - b. Work with the Council on an *extra mile* special gift opportunities list / project list that impacts the budget or needed areas not in budget.
 - c. Continue pre-offering messages connecting donations with programs / ministries.
 - d. Conduct a specific and tracked end of year / holiday giving campaign.
 - e. Study the feasibility of integrating a "subscription style" giving opportunity that donors can control.
 - f. Visibility of stewardship consultants in the cafe on a regular basis to help people administer their giving through Stripe and Vanco (increase / decrease / add new).
- 2. Help to restart a formal home visitation team for our shut ins.

- 3. Promote a congregational wide Bible reading spiritual practice during Lent and Advent.
- 4. Work with the elected leaders to determine the feasibility of restructuring and streamline some of our boards and committees.
- 5. Form High School Youth and Middle School Youth parent ministry planning teams.
- 6. Develop new approaches to acolyting, including using families in service roles for the worship service.
- 7. Have a summer service day for youth.
- 8. Teach an adult education class.
- 9. Work with our Social Media and Web Coordinator Bridgid Agosta to publish a new website and increase our social media presence.

I want to thank the people of Resurrection for your acceptance, generosity and hospitality. You provided me with a warm welcome when I first arrived here in March, 2023 and I have felt your love and support when you celebrated with me my 25th anniversary of my ordination and pastoral appreciation month in October. I am truly blessed to be your Transitional Pastor and thank you for the opportunity to serve you.

May God's blessings be upon us, the people of Resurrection, as we continue to prepare our congregation for the call process with faith and **flexibility!**

2023 Annual Report Reflection and Vision

We welcomed Pastor James Lindberg as our Transitional Minister on Wednesday, March 1, 2023. It was a day full of questions, to-dos, introductions, confirmation programming realignment and to top it off, it was the first Wednesday of Lent. After an incredibly full and overwhelming day, Pastor Lindberg introduced himself to the congregation and led our first midweek Lenten service of the season.

I was alongside him through all the first day "stuff" and I was exhausted. Yet sitting down for service that evening, I distinctly remember the calmness and connection he delivered. I may have been the only one who knew how crazy the day had been, but the takeaway was monumental. If our new leader could go through a day like that and still provide a meaningful experience, despite the typical "first-time" pressures, we were in good hands. I was energized and excited to begin a new chapter at RELC.

We expected two major tasks in 2023 as outlined in Bill Schwarten's 2022 Council President Report: 1) the formation of a call committee and 2) to begin revisiting our Strategic Long-Range Plan last updated in 2015. Both of these tasks are multifaceted and require considerable volunteer commitment.

After finishing the program year and letting the dust settle, the council held a retreat in June 2023. Two major decisions came out of the summer retreat. First, we would delay beginning the call process and partake in an 18-month long Vitality Initiative led by the NE Synod with a cohort of other congregations. This process aims to solidify who RELC is today and will assist in our call process at its conclusion. The council also elected to adopt operational core values in support of our existing SLRP plan to guild us in making decisions during this time of transition. A list of operational core values can be found at the back of the annual report.

If you dare to think movement did not occur in 2023, you would be mistaken. A theme running deep in 2023, but also since I joined council in 2021 is the need to adapt. Sometimes the need to adapt is forced upon us such as was the case with the covid pandemic or Pastor James Sells announcing his departure from RELC. At other times, adaptation is the deliberate decision by our leaders to move things in a new direction. Your Congregational Council, in consultation with ministry leaders, made the careful decision to adapt in many areas this year: keeping worship times at 8:30 a.m. and 10:00 a.m., offering Sunday School during worship services, making a choral shift to a 6-week Christmas Cantata experience for the community and bringing mid-week meals back in a new format...to name a few. Additionally, we carried out the sale of our two rental properties as approved by the congregation during the 2023 annual meeting. You can find a detailed distribution of the sale proceeds in the treasurer's report.

Our world IS different, our kids and families ARE stretched thin, our volunteer base IS smaller than it was 20 years ago. This year we took deliberate action to ADAPT.

It has been an honor to serve and lead our congregation as your council president in 2023! As my term on council comes to an end, I look forward to teaching Sunday School more regularly and serving God and our community through the eyes of children.

Annual Report 2023

The first part of 2023 was so exciting for the congregation and for myself as I finished my time at RELC. We started the year off without a transitional minister so many of us, but especially the office staff, did our best to pick up the slack. We were so fortunate to have Pr. Al Hansen commit to be our supply pastor for January and February (much longer than any of us expected) in order to provide some consistency for our worshiping community.

From January until the end of the school year I was able to take on the responsibility of leading confirmation for our seventh and eighth graders. I'm so grateful for the flexibility on the part of both the parents and the confirmands as we figured out what confirmation would look like for the rest of the year. I'm glad to have had the time to get to know the confirmands so much better.

One week during the summer we went out to Carol Joy Holling with some of the confirmands for a week of camp! We spent time learning about a few of Jesus' parables (led by Pr. James Lindberg). The parables are sometimes difficult to understand but the group took them by storm and even wrote their own parables to conclude the week. I also had the pleasure of continuing to lead the high school youth for the end of the school year. I'm so thankful for their flexibility as well as my focus was stretched to new areas. I always knew that I could leave Underground with renewed excitement for the future of the church.

Five of the youth were able to join us on a mission trip down to the Texas Border. Through a local group called Border Missions we were able to get to know some members of the community who were already doing great work and showing God's love to those immigrating to the United States, often with little more than the clothes on their back. Because of Border Missions we were able to peek into the complexity of the situation at the border by learning about the history and the real needs of the communities. At the end of the trip our high schoolers and adult leaders wrote reflections about their time on the trip. I was touched to see the way that our week had impacted their faith and understanding of the world.

I ended my time at RELC by leading Vacation Bible School hosted by our congregation in conjunction with the Methodist church. You can read more about VBS in the Children's Ministry report but I'm so glad I was able see you all off with such an exciting event (and outer space happens to be one of my favorite things)!

I have been fortunate enough to have been able to return to the congregation a couple of times since I moved to Minnesota for seminary. I am so thankful for my time at RELC in which I was able to see the congregation grow and adapt to changing circumstances. I hope that I am able to take that perseverance with me as I continue my journey. Thank you all for allowing me to be your director of youth and congregational life and I look forward to seeing how you continue to grow as a community of faith but also a community of God's love in the world.

CHILDREN'S MINISTRY REPORT

2023 Annual Report

"Start children off on the way they should go, and even when they are old, they will not turn from it." Proverbs 22: 6

Despite rebranding Sunday School to Resurrection Kids, we couldn't sustain offering the two options model for the students due to volunteer needs and inconsistent attendance numbers. We never had more than 12 students on a Sunday. It was changed to offering one option on the same topic for eight weeks. The two topics taught were <u>Holy Week</u> and Noah's Ark.

Resurrection hosted Vacation Bible School this year with 72 children attending and 42 volunteers. Most of the work was shouldered by RELC with limited input by the Methodist congregation. We went <u>Stellar</u> with the emphasis on "Shine Jesus Shine." We started off the evening with a meal and the numbers served increased as the week continued. Then the children gathered for an opening of songs and a video to introduce the topic of the evening. After the opening, the shepherd guides would take their group to different stations. The stations included snack, craft, Bible lesson and games. We ended the night with a closing in the Fellowship Hall with songs and a word from Pastor James. On the last night, everyone gathered in the green space to send our rocket blasting into space.

Sunday school went through a lot of changes this fall. It was decided that we try to have Sunday school during the church service. The students are dismissed after the children's sermon with a blessing and then dismissed at the end of the service when their parents pick them up. We kicked off Rally Sunday with 18 students attending Sunday school. We have averaged around 10 students every week. The students studied The Battle of Jericho for five weeks with five different teachers using games, drama, science, music and art. The next six weeks the students studied Feeding the 5,000 with five different teachers using science, art, food, drama, and technology. The excitement was contagious, so we added three more sessions using Advent as our theme. Lessons were chosen by the teachers. They decided to teach Jesus as the Light, the Nativity story and the shepherd's role on Christmas. These lessons have a craft for the students to take home.

Plans for spring 2024 include topics of <u>David and Goliath</u> and <u>The Lord's Prayer</u>. We will have Sunday school starting January 14 – March 17 and April 7 – April 28. The hope is that we will hire a children's director for 2024. The planning for spring semester is well under way and a discussion about plans on VBS with the Methodist church are underway.

TREASURER REPORT

2023 Annual Report

2023 Operating Results

We set a target of \$372,000 for our primary source of income, local offering. This reflected a 12% increase over giving totals of 2022. Based on the congregations vote during the 2023 Annual Meeting, we sold our rental properties in the first half of 2023, generating \$414,000, which was distributed in the following manner:

- 30% to pay down our mortgage
- 25% to the endowment fund
- 25% to the general fund for property improvements
- 20% in a mission investment fund

Our efforts to expand alternative sources of income, such as fundraising and hall rental, have been successful, yielding over \$10,000.

It is with excitement and hope for expanded opportunities in 2024 that I report the following financial results for 2023.

While we did not quite hit our offering goal of \$372,000, we had an overall increase in giving of nearly 7%. Giving to the building fund in 2023 was down versus prior years and was a conscious decision by a large donor, given the immediate needs of the church. With our enhanced monthly repayment schedule, large payment from the rental house proceeds, and relatively low balance at a low interest rate, it is advantageous to funnel more income toward offering. The Resurrection Run & Breakfast netted \$3,271 and income from hall rental was \$4,710 and we feel these will be on-going for years to come.

An increase in giving, successful fund raising and hall rental opportunities, proceeds from the rental property sales, and expenses landing 5% below budget translates to a solid year! Although our overall net income was \$-10K for the year, we were ahead of our budget and were able to give to the synod and other charities at historical levels, while making key investments in our beautiful church. A couple of situations that are one-time in nature occurred this year:

- 1. Property We replaced a furnace in November.
- 2. Staffing we had a few staffing changes in 2023.
 - a. Bill Schwarten joined as Business Administrator, replacing Desiree Stednitz
 - b. Pastor James Lindberg joined as Interim Pastor.

- c. Hannah Grove, Youth Director, departed and Pastor James, Deb Wallman and others are filling in.
- d. We added a Social Media/Web Administrator.

With a mortgage prepayment of nearly \$125,000 from the sale of the rental properties, plus our increased monthly mortgage payments, and continued giving to the building fund, our Mortgage/Building Fund position is in a good place. Our fund balance is \$100,392.28 and our loan balance is \$134,480.06 and is due on 6/1/2029.

The Memorial Fund is in good shape with a balance of \$122,743.40. We have no large projects on the horizon, outside of what was planned and funded using the rental property proceeds.

The General Fund is strong with a balance of \$230,850.10. A strong fund is incredibility important as we embark on our call process in 2025. Having a reserve of capital will help ensure adequate office staffing funding of our transitional minister and eventually our new pastor.

A new fund that has been put in place this year, post rental property sales, is the Mission Investment Fund or MIF. This fund has a fixed return of 5.05% and has a balance of \$85,040.85.

2024 Budget

We are setting an income goal of \$380,000, which is an increase of 7% vs. 2023. This figure reflects the level of support necessary to maintain RELC's physical assets and continue carrying out our mission. The generosity of our congregation is amazing and so important to meeting our goals.

The fundraising and hall rental budgets have been increased in an effort to reinforce the alternative revenue stream and build on the successes in 2022 and 2023.

Budgeted administrative expenses for 2024 are +26% or \$74K higher than 2023. The budget includes a full year of staffing for Pastor Lindberg, music director, two part-time office staff and a part-time web/social media specialist. 2023 expenses were lower due to staff openings with the departure of Hannah Grove, Youth Director and only a partial year of Pastor Lindberg expenses. To further preserve resources in 2024, we have chosen to delay the hiring of the Youth and Childrens Ministry leader until 2025. Pastor James, Deb Wallman, Becky

Wagner and others are leading these important ministries in the short term with great enthusiasm and success. Utilities & services are projected to increase by 2.5%. Additionally, the 2024 budget includes raises for our staff.

Ministry team budgets remain very lean. The Worship & Music ministry has a need for a wiring overhaul for the projectors in the Fellowship Hall and the council has found alternative sources to fund the project through a special donation, using rental house sale proceeds and some additional fundraising. Worship & Music is also taking a 'wait and see' approach to the potential replacement of the Sanctuary piano. As you will recall, we replaced the digital piano in the fellowship hall in 2023 and a family covered the \$3,500 expense. Last year we also replaced the two digital projectors. The Worship & Music ministry leaders are confident the wiring and other minor fixes will ensure our projectors will work seamlessly. All our AV equipment has been wonderfully maintained and will be used for the foreseeable future.

We have stretched where we can, and our 2024 budget shows a net income of -\$19,845. This budget enables us to continue our donations locally and through the synod and carry out our mission of Sharing God's Word, Showing God's Love and Serving God.

Closing

Thank you for the honor of serving as your treasurer this year. We finished the year financially strong and, because of the generosity of our congregation, have a very bright future, as we **Share God's Work, Show God's Love, Serve God. Amen Alleluia!**

The Endowment Fund was established in 1990. The Endowment Fund's principal has been funded by charitable contributions from members of the congregation and proceeds from the sale of church rental properties. The purpose of the Fund is to distribute the available investment income each year to enhance the mission of RELC apart from the general operations of the congregation for the following purposes as described in the Endowment By-Laws:

- a) For major capital improvements, debt reduction, or building programs of RELC.
- b) For scholarships or grants to members of RELC for the purpose of attending college, seminary, nursing or medical school; for church related camping or leadership conferences; or such other training which enables members of this congregation to grow in Christian faith and service to God's people.
- c) For outreach into the community including, but not limited to, grants to ELCA colleges, seminaries, social services agencies, institutions and agencies to which this congregation relates and to special programs designed for persons in our parish area who are in need.

Since its inception, the fund distributions have been exclusively used to fund scholarships. In the future, as the fund grows, more investment income will be available to potentially support other approved purposes. Below is a summary of the current Endowment Fund balance and disbursement activity.

HEALTH MINISTRY TEAM

2023 Annual Report

Blessings to you from your Health Ministry Team!

Your Health Ministry Team is comprised of trained Faith Community Nurses and several dedicated health professionals and lay members who have an interest in health promotion and wellness.

Health Education – We continue with newsletters in the Messenger, offering timely information for whole-person health. In November, the Health Ministry Team received \$2500 from UNMC's Nebraska's Health Matters program and United Healthcare to provide education on prediabetes and provided all adults at church an opportunity to complete a brief prediabetes risk test. Any adult completing the risk test received a \$10 gift card to Fareway. Education packets and the risk test were also provided to adults picking up food on November 18th at the Gretna Neighbors, along with one \$10 gift card to Fareway for each family picking up food that day.

Medical Supply Closet – The Medical Equipment Closet has moved to the room on the northwest end of the education wing. If you need like-new medical equipment, you can borrow any item from the closet <u>at no charge</u> for as long as you need it. You are now able to check out equipment on your own. Step-by-step instructions are provided. You can also donate your gently used equipment for others to use. Contact Linda Anderson if you have any questions or do not see equipment that you need.

AED & First Aid Kits – The Health Ministry Team maintains the AED and First Aid Kits at Resurrection. The team also coordinates regular CPR/AED training for ministry leaders and staff at Resurrection. A big Thank You to LaRene Walker for providing this instruction for us!

Prayer Shawl Ministry – Dozens of prayer shawls have been distributed throughout the year to members and loved ones in our congregation, individuals in area hospitals, and veterans and others who are receiving hospice care. In addition, wash cloths and hot pads are being made and donated to Least of My Brethren and other organizations supporting the underserved. Feel free to stop by the office anytime to pick up a prayer shawl, prayer square, or lap robe for someone who is going through a difficult time. The group is currently meeting monthly - if you would like more information, contact Karen Hitz.

Physical Activity Classes –

• Tai Chi Class – We continue to offer two 12-week sessions of Tai Chi a year on Mondays and Wednesdays from 9:00-9:45 a.m. The average daily attendance at our Tai Chi class is 16. We concluded our 12-week session on Wednesday, November 22nd, and plan on starting the next 12-week session on Monday, January 15th. The class is FREE for participants. Please join us...and bring a friend!

- Falls Prevention Awareness National Falls Prevention Awareness Week is recognized each year on the first day of fall. This year, the Health Ministry Team partnered with the Nebraska Older Adult Falls Coalition to raise awareness about this important health issue. On Wednesday, September 20, our Tai Chi class attendees provided a Tai Chi demo in Peterson Park, to educate the public that Tai Chi is the best practice to reduce fall risk in older adults. There were 13 in attendance at the event, including several members of the community who came to learn more. Everyone enjoyed the event, and we hope to plan another Tai Chi in the Park opportunity for the community in 2024.
- Low-Impact Exercise We also offer a FREE Low-Impact Exercise class on Friday mornings at 9:00 a.m. Attendees exercise together at their own pace. Please join us...and bring a friend!

Blood Pressure Screenings – The Health Ministry Team is currently providing monthly blood pressure screenings between services on the 2nd Sunday of each month. Come and see us in the office between services, and get a gold star for taking charge of your health!

Colon Cancer Screening – In March, we partnered with the Great Plains Colon Cancer Task Force to distribute FREE colon cancer screening kits in the congregation. We also provided information about colon cancer prevention and screening to the Gretna Neighbors Food Pantry. The information was shared during a food distribution day, and provided information about how they could request a free colon cancer screening kit via the mail.

Earth Day Education – Team members worked with Hannah to offer an Earth Day activity for the Sunday School kids in April. The activity encouraged the kids to think about how we can all be good stewards of God's creation.

Nursing Students – We continued to partner with nursing students from Clarkson College and Creighton University. The students learn about Community Nursing and provide health education to members of our congregation and the community.

VBS Health Table – Nurses from the Health Ministry Team covered the Health Table at VBS this year. The team provided first aid assistance to kids and adults during VBS.

The Outreach team's purpose is to facilitate community outreach and events that introduce Resurrection Evangelical Lutheran Church and invite members of the community through the RELC website, marketing, and social media. MUSIC DIRECTOR

2023 Annual Report

The year began after a tumultuous Advent/Christmas season as we transitioned from supply pastor coverage to our new interim pastoral leadership in the first quarter of the year. My primary goal was to ensure as much continuity in the corporate worship experience as possible, which I think we achieved.

Now, with Pastor Lindberg firmly ensconced as our Pastor, I have experienced a level of joy in ministry that I didn't know I could still have. Pastor Lindberg is a welcome colleague and spiritual leader, and I am grateful for his guidance and partnership as we work together to craft Spirit-filled services each week.

As I share every year, worship is at the heart of congregational life and we are blessed to be called to lead in this ministry.

Musical ensembles continue to be the lifeblood of the weekly music ministry at Resurrection.

The 10:00 a.m. music team is as faithful as any I have ever worked with. These musicians and our technical support volunteers work diligently to refine familiar songs and to introduce new selections in the worship flow throughout the year, with six new congregational songs added to the 10:00 a.m. catalog in 2023.

The Bell Choir continues to meet enthusiastically from September to April and has grown in number and ability in the last year. We are finally back to pre-Covid strength.

Due to a decline in participation in the Chancel Choir in recent years, we decided to employ a new strategic approach in hopes of attracting more singers for a short-term high-reward experience. The 2023 Gretna-Area Christmas Cantata Choir quadrupled the size of our Spring 2023 Chancel Choir, and provided worship-filled music making for Resurrection members and nonmembers alike. I am grateful to the Worship and Music Committee and to our Council leadership for their partnership, and to you for your support of our ministry.
