WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

Waiver must be signed by everyone participating in the event.

(All participants must be at least 18 years of age or older or have parental signature.)

In consideration of receiving from TREC and/or Badlands Promotion permission to enter upon the premises of the off-road and/or racing facility, the receipt of such permission being hereby acknowledged, and in further consideration of receiving permission to participate, in ANY CAPACITY, including but not limited to watching or as a spectator or to enter the off-road and/or racing facility for ANY REASON, I, the undersigned participant hereby understand and agree as follows:

I HEREBY ACKNOWLEDGE, AGREE, AND REPRESENT that this off-road and/or racing facility offers racing and other activities associated with racing including but not limited to participating, observing, and/or spectating, which are inherently dangerous and risky with many hazards that can cause **property damage, bodily injury, infectious disease, strains, fractures, partial or total paralysis, and death**. I hereby acknowledge the risks and hazards inherent upon entering said premises and/or in participating in or observing any of the events, races, or driving held at said premises and voluntarily elect to enter upon said premises, knowing its present condition and knowing that said condition may become more hazardous and dangerous during the time that the undersigned is upon said premises.

I HEREBY RELEASE, WAIVE, DISCHARGE, AND AGREE NOT TO SUE TREC and/or BADLANDS PROMOTION and ANY OTHER ENTITY OR PERSON involved in the racing event, including but not limited to the owner(s) of the property (hereinafter jointly referred to as the "Releasees"), and their officers, directors, shareholders, managers, members, owners, insurers, agents, servants, employees, and licensees, from and/or related to ANY AND ALL LIABILITY including but not limited to any and all claims, demands, actions and causes of action whatsoever, arising out of or related to any loss, damage or injury, including paralysis and death, that may be sustained by any or each of the undersigned, leased to, owned by, sanctioned by, related to or under the control or supervision of the Releasees, or in route to or from the off-road and/or racing facility or any other premises owned, leased, or under the control or supervision of the Releasees, **which release includes the negligent acts of omission or commission of any or each of the undersigned and Releasees and their officers, owners, managers, directors, agents, servants, employees, and licensees or any other participants or others on or involved with the premises or related to the racing event.**

I HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES and their insurance carriers and each of them, personally and/or professionally, from any loss, liability, damage, or cost they may incur including but not limited to all debts, obligations, contracts, expenses, legal fees, legal representation, expert witness fees, attorney fees, acts, damages, litigation costs, personal injury, wrongful death, medical bills, liens, lost wages, permanent injury, and causes of action of every nature, character, and description, whether known or unknown, asserted or unasserted, fixed or contingent, accrued or unaccrued arising out of or related to the event(s), participation and/or observation of ANY ACTIVITY OR EVENT OR PREPARATION FOR SAID ACTIVITY OR EVENT including but not limited to racing, whether caused by the negligence of the Releasees and/or negligence of any other participant, or each of the undersigned or any entity or person. Jurisdiction and Venue of any suit relating in any way to the race or event or the premises or involving this Agreement or any of the Releasees, shall be brought and heard solely in the Fountain Circuit Court, County of Fountain, State of Indiana.

I HEREBY FREELY ACCEPT AND VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR THE RISK OF LOSS, DAMAGE, OR INJURY, INCLUDING INFECTIOUS DISEASES, PARALYSIS, OR DEATH, that may be sustained by any or each of the undersigned, or any property of any or each of the undersigned while in, on, in route to or from or upon the premises, including but not limited to any loss, damage, or injury caused as result of or by the negligence of the Releasees and/or negligence of any or each of the undersigned.
