General Counsel

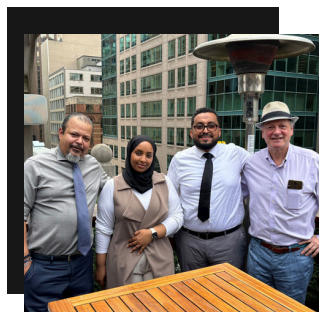
