The 9-0 Supreme Court Smackdown

In a landmark decision in *Ellingburg v. United States*, the Supreme Court unanimously ruled that federal restitution is criminal punishment. Period.

Writing for the unanimous Court, Justice Brett Kavanaugh completely dismantled the government's lies. The Court looked right at the Mandatory Victims Restitution Act and exposed the obvious truth: it is a "penalty" for a criminal "offense." It is imposed at sentencing, and the government, not the so-called "victims"—is the one running the show.

But the real fire came from Justice Clarence Thomas in his concurring opinion. He pointed out exactly how the government hides behind "civil" labels to bypass your constitutional rights. He noted that today's fake civil penalties are purely confiscatory, writing: "Today's 'civil' penalties include confiscatory rather than compensatory fines, forfeiture provisions that allow homes to be taken, remedies that strip people of their professional licenses and livelihoods."

You cannot use rubber-stamped, fake civil math to confiscate everything a man owns and destroy his family's future.
