## 2023 Vending in the Courtyard Application & Contract

(5/23/2023)

*Akasha's Journey will be hosting several vendor events for 2023 and we are looking for a variety of local artisans and vendors. Products offered must not be currently stocked in the shop. The following are already covered: Psychic Readers, CBD, essential oils, crystals, & Barefoot Books. Reiki, and Massage, are by invitation only. Jewelry spaces are limited to one per artist's style and limited to two jewelry vendors per event date.*

### **Hours are 2pm-6pm**

**First and third Saturdays of the month, outside, weather-permitting.**

### **Space fees:**

Standard Space:

\$15 per table space (6' x 3').

2pm-6pm

Porch Space (3 available per date):

\$20 per table space (6' x 3')

**12pm**-6pm

Tent Space (3 available per date):

\$30 per space (10' x 10')

2pm-6pm

Vendors must bring their own tables, chairs, and linens.

We have a limited number of tables that may be available for rent if you need one or if you forget your table that day. Table rental fee is \$10 per table per event day. Vendors are responsible for setting them up and putting them away at the end of the event.

Events are “weather-permitting”, however, porch spaces are protected from weather. Vending fees are NON-REFUNDABLE, however, in the case of inclement weather, any fees paid will be applied toward a different date of your choosing within the same season.

Our events are open to the public and are marketed to our customers and the local communities.

Interested vendors must complete & submit this application. If your application is approved, payment must be received within 3 days. Vending fees are NON- REFUNDABLE. The number of vending spaces is limited and fees must be paid in advance to secure your space.

Spaces are assigned on the basis of a first-paid, first-assigned basis. No particular space can be guaranteed. Reasonable accommodations can be made for those who have special needs. Please notify management in advance.

This is a carry-in, carry-out event. Please take any garbage with you when you leave.

NO NARCOTICS ARE PERMITTED ON PREMISES. No smoking near our doors.

We are accepting applications from local crafters, artisans, & vendors.



BY COMPLETING THIS APPLICATION AND SIGNING THE AGREEMENT, THE VENDOR AGREES TO:

- Bring your own tables, chairs, and table coverings.
- Use of picnic tables by vendors and their representatives is strictly prohibited, as they are there for plaza patrons only. Please keep these clear until Ritchie's Deli closes for the day. No vending from these tables.
- Set-up for porch spaces starts at 11am. Set-up for all other spaces starts at 1pm. Please be set up no later than the event start time (12pm for porch spaces. 2pm for courtyard spaces)
- You may pull up to the building to unload, however, please move your vehicle across the lot to one of the spaces facing Route 22 immediately after unloading.
- Remain set up for the entire length of the event unless otherwise advised by Management.
- Take and dispose of any trash you generate.
- Enforce state and local executive orders as they pertain to COVID-19, your business, and your customers while on our premises.
- Withdraw any material found objectionable by management. Sell ONLY THE PRODUCTS AND SERVICES LISTED on the application.
- If a vendor has products not listed on the application that are in conflict with nearby vendors, you may be asked to remove those products. (This will be enforced).
- No loud speakers or PA systems
- Indemnify, defend and hold harmless Akasha's Journey, Marco Sartori, its agents, officers, employees and representatives for all claims of bodily injury, property damage and bodily injury including all consequential financial loss resulting therefrom as well as all legal expenses involved in handling such claims.
- Collect and pay all municipal state and federal taxes related to all sales made.
- Vendors must cease sales when the event ends.

I, the undersigned, have read the Rules and Regulations and do agree to abide by all the rules and regulations.

I agree to attend the dates as selected above. I agree to have my booth set up no later than the event opening. I agree to keep my booth set up until the end of the event. I agree to operate my booth in a safe and courteous manner. I agree to bring positive energy to the event.

I agree to refrain from bringing any drugs and illegal substances onto the properties including my own vehicle, which may be parked on the premises.

I agree that if I do not notify management & fail to show, I forfeit my right to vend at all other Akasha's Journey events and I also forfeit the remainder of any deposit paid.

I understand that failure to comply with the rules and regulations could result in dismissal from the event.

I understand the booth size and hours of operation are determined by the Akasha's Journey and even if I do not agree with them, I will abide by them.

I understand that events are rain or shine, and I will prepare accordingly. If management cancels because of weather, vendor fees will be applied to a future event date. In the case of inclement weather, management will post intentions to the Facebook event, Akasha's Journey Facebook Page, social media, and will also call vendors. If the weather forecast calls for extreme conditions, a decision may be made to cancel that day's event. I understand that management is not responsible for the weather. Any payments made will be applied to a future event of the vendor's choosing. I verify that all information I have provided about my business and products for sale is true.
