**Old Business** – At the 2013 members meeting the board was asked to revise the roofing policy and add more shingle choices. Unfortunately the board was unable to get enough information to bring to the members meeting to make any changes at this time.

The front wall along 45<sup>th</sup> had to be replaced due to gas line work. The wall cost \$10,000 and is the responsibility of the HOA. In 1993 the board made an agreement with the utility company that if there was ever a problem that the wall would have to be taken down and the HOA would have to pay for it. This year the gas company found a problem with the line and had to dig it up resulting in the removal of the wall. Over the past few years the board has been saving money for other improvements and thru these savings the wall was replaced with no special assessments from the members.

James Schmidt asked about the mowing and if the board was getting new bids and if so to add 4 Star Lawn Care to the bid list. Jake Jones added that we were putting all of it up for bid. The board was also asked to add a late fall leaf clean up to the bids.

Carol Dreifort brought up the rip rap around the pond, if it would be cheaper to pull some out of the pond vs putting in new. Jack Jones noted that it would cost the same either way.

Jackie Little asked if the HOA has anyway to stop rentals in the neighborhood due to some of them not being taken care of. Jack Jones has looked into this with the HOA's attorney and at this time there is no way to stop homes from becoming rentals, but the board will continue to monitor and address the covenant violations.

James Schmidt would like to have grass put on the dam to help keep it from eroding and if the board was going to stock the pond.

Jack Jones brought up that several people have asked about a fountain in the pond to control algae. In checking on this it cost \$2000 to \$3000 plus getting electric run to the fountain, this does not include yearly maintenance and it will not control the algae. At this time the board does not want a fountain in the pond.
