The 2025 Annual Colored Pencil Show is a non-juried colored pencil art exhibition hosted by the DC103 Chicago chapter of the Colored Pencil Society of America (CPSA).

Eligibility: Artists must be 18 years or over. Non-members and DC103 Chicago CPSA chapter members are invited to participate. Members of the DC103 Chicago CPSA who have paid their chapter and national member dues for the 2025-2026 year will receive a discounted entry fee.

Specifications: Artwork must be **predominantly colored pencil**. No artwork may have been exhibited at a prior CPSA Chicago District Show. Entries cannot have won a prize at the CPSA International Exhibition and must have been completed within the last 3 years.

All artwork must be original in concept. If drawn from a photo, the photo must be taken by you. Photos taken by others, even with permission, are not allowed.

Entry Fees: DC103 CPSA members pay \$25 for the first piece and \$5 for each additional artwork up to three pieces entered (\$25, \$30, \$35). Non-members pay \$30 for the first piece and \$5 for each additional piece up to three pieces (\$30, \$35, \$40).

Fees and email entries (with JPEG images and artwork info) are due by **September 8**, **2025**. Entry fees will be paid through our website at www.cpsadc103.org.

Artwork Identification: Each artwork must be identified with the artist, title, size of artwork without mat or framing, medium/media used, and pricing or NFS (not for sale)

Sale of Artwork: Artwork will be marked with the price specified in your entry or NFS (not for sale). All artwork will remain on the website for the duration of the exhibition and possibly beyond. Financial transactions related to the sale of artwork will be the responsibility of the artist.
