JUDGE

Pamela Hamilton studied at the Art Institute of Chicago. She is a Master Pastelist with the International Association of Pastel Societies and a Signature Member of the Pastel Society of America and Chicago Pastel Painters. Pamela teaches classes from her private studio in Geneva, Illinois.

ELIGIBILITY

- Artists must be 18 years or older
- Open to CPSA DC103 members and non-members
- Membership discount applies for those who have paid their chapter and national member dues for the 2026 - 2027 year
- Artwork must be **predominantly colored pencil**
- Work must be completed within the last 3 years
- Artwork may not have been exhibited in a prior CPSA Chicago District show
- Entries may not have won a prize at the CPSA International Exhibition or CPSA Explore This!
- All artwork must be original in concept — if drawn from a photo, the photo must have been taken by you (photos taken by others, even with permission, are not allowed)

ARTWORK REQUIREMENTS

- Must be framed, wired, and ready to hang with a maximum size of 32" x 40" (framed)
- No sawtooth hangers (wire only)
- Simple wood or metal frames or cradled panel in a neutral color (no clip-on or self-standing photo frames)
- If matted, color should be neutral (white, off-white, tan, gray, or black)
- Protective glazing required (glass, acrylic, plexiglass, or a suitable protective final layer)

ARTWORK IDENTIFICATION

Each artwork must include a label on the back (upper right corner) with the following entry information

- Artist name
- Phone number
- Title of work
- Size (without mat or framing)
- Medium/media and surface used (e.g., colored pencil and marker on drafting film)
- Date completed
- Price or NFS (Not For Sale)
- Declared value (if NFS)

This same entry information should also be emailed with your digital image.

All artworks must remain for the duration of the exhibition. A 10% donation from any artwork sale goes to CPSA DC103 to cover exhibit costs. Please factor this into your pricing.
