I/We agree to have dog vaccinated annually with necessary inoculations (DHLP-P) and vaccinated against Rabies, as local ordinances require. I/We agree to provide essential veterinary care, as needed. If said dog becomes lost or stolen, I/We agree to notify Harvey's Heroes Dog Rescue immediately.

\_\_\_\_\_ I also agree not to sell, trade or dispose of this dog. **If, at any time, I/We are unable or unwilling to care for this dog, I/We agree to contact and return said dog to Harvey's Heroes Dog Rescue.**

\_\_\_\_\_ I also agree that there are no refunds on adoption fees. All fees will go towards the rescue as a donation if the pet is returned for any reason.

\_\_\_\_\_ I agree that any returned dog should allow the rescue two weeks to find a new foster home. If a foster cannot be found in those two weeks, I/We agree to pay for boarding until a safe place for the dog to go is found.

\_\_\_\_\_ I agree that Harvey's Heroes Dog Rescue may examine and make inquiries about said dog at any time. If not satisfied with the condition of the dog or the conditions in which it is kept, said dog can or may be removed immediately and placed in a different home. Any veterinary services needed due to negligence or lack of care, will be the adopter's responsibility and payable to Harvey's Heroes Dog Rescue.

\_\_\_\_\_ I/We promise and agree to be solely responsible for this animal, and to indemnify and hold harmless Harvey's Heroes Dog Rescue from any and all claims of liability for the conduct of this animal on or after the date of this adoption. This Release of Liability and Indemnification shall apply to all known, unknown and unanticipated damages resulting from my/our adoption, ownership or control of such animal.
