

OTSA BOARD OF DIRECTORS, OFFICERS, AND ATA DELEGATE

DUTIES OF BOARD OF DIRECTORS, AS PER ARTICLE IV OF BY-LAWS

- Appoint a willing member in good standing, or Board Member, as Chairperson of Trapshooting Committee for State Shoots, and other shoots held at the Home Grounds of the Association.
- Each Director carries one (1) vote at all regular and special meetings of the Board of Directors.
- Delegate authority to the Officers of the Association to manage, operate and execute the business affairs of the Association, and administer all matters of governance of the Association.
- Designate: time and place of registered ATA tournaments held in the State of Oklahoma; prescribe championship requirements; allot, donate, and distribute trophies and cash contributions for events.
- Aid in activities that ensure business operations and property of the Association are efficiently managed.
- Serve in directing shoot-offs related to events of registered shoots at the Home grounds of the State Association; volunteer to serve as directors of shoot-offs at other registered shoots within the State of Oklahoma at which they participate.

DUTIES OF PRESIDENT (1ST DIRECTOR), AS PER ARTICLE VI OF BY-LAWS

The President: is the principal executive officer of the Association and subject to the control of the Board of Directors; supervises and controls all business affairs of the Association; when present, presides as Chairman of meetings of the Board of Directors and of the membership; signs or delegates authority to other officers to sign, any deeds, mortgages, bonds, contracts, or other instruments; performs all duties incident to the office of President and such other duties as may be proscribed by the Board of Directors from time to time; has full power and authority to represent the Association at meetings inside and outside the State of Oklahoma; appoints all committees determined to be necessary to operate the Association; approves requests of gun clubs in the State of Oklahoma for dates for registered trap shoots, in consultation with the Secretary.

DUTIES OF VICE-PRESIDENT (2ND DIRECTOR), AS PER ARTICLE VI OF BY-LAWS

In the absence of the President or in the event of his/her death, inability, or refusal to act: performs the duties of the President, having all powers of, and be subject to all restrictions upon the President; perform other duties as may be assigned to him by the President or the Board of Directors.

DUTIES AND QUALIFICATIONS OF ATA DELEGATES, AS PER ARTICLE X OF BY-LAWS

To be eligible as a nominee to the office of ATA Delegate, or Alternate Delegate, nominees must be a current annual or life member in good standing with the State Association, and be a life member of the Amateur Trapshooting Association. Delegates must also meet the requirements listed in ATA Rules and By-Laws, Section 1.C. (pg. 4), and fulfill the following obligations and requirements: a) represent the State Association at the annual meeting of the Amateur Trapshooters Association, Annual ATA Grand American; b) assist in classification and directing of shoot-offs at the ATA Grand American, as scheduled for the SW zone; c) if the Delegates intend to bring up subjects for discussion at the ATA directors meeting other than regular business, the Delegates must discuss the issue with the President and Board of Directors before the meeting; c) abide by decisions and instructions of the President of the State Association and Board of Directors; d) ensure that all gun clubs holding registered shoots in Oklahoma are properly classifying and handicapping attendees of shoots, and that clubs make all attempts to ensure legal targets are thrown in events; e) certify new or existing gun clubs within the State of Oklahoma seeking to begin registered ATA shoots; undertake all efforts possible to be present for the purposes of classification and directing shoot-offs of registered events undertaken at the Home Grounds.
