Old Business:

Beach Vitex Update—Bud Nusselt reported that he, Neil and Eva took a ride up to MP 19 to check growth of Beach vitex on property located at 1921 Sandpiper. The property owner allowed application of lyfosate and procedures for scraping plant. Carol Slamowitz emphasized the need to notify property owners before taking action. Bud indicated adjacent property owners were supportive. Beach vitex is an invasive species and we are acting on behalf of the NC Dept. of Agriculture and Consumer Services, we are not required to contact homeowners in order to eradicate the plant, however it its a nice courtesy to do so. Bud indicated 10 to 20 needed to help with project. Bud gave a slide presentation.

Social Media- Eva Casola- FBCA Facebook page active. Approximately 170 active participants.

Carova Beach Volunteer Fire and Rescue----Jennifer Early

Jennifer reported on updates for Stations 7 & 7-2; Craft Fair/Bake Sale.

Work with County is ongoing for equipment upgrades. CBVFR looking at several fund raisers, including upcoming Donkey Derby. Board voted for \$100 donation to Station 7; Station 7-2. Discussion—Carol Slamowitz raised question for donation to Donkey Derby fund raiser. Jennifer stated that perhaps donations should go to Auxiliary for use as needed. Motion to rescind motion by Tom Hudak, seconded by Jennifer Early to amend to redirect to CBVFR Auxiliary Donkey Derby because all funds benefit Fire Dept. in lieu of donations to Station 7 & 7.2 All in favor, Motion Carried.

CWHF News and Upcoming Events----Carol Slamowitz

Carol reported that Chris Winters is the new CEO. Chris possesses a wealth of knowledge for non-profit funding. He is interested in the acquisition of property to create a corridor for the horses. Information regarding adoption of horses off farm was discussed. Eva Casola announced Board approval to donate \$100 to the CWHF.

Mid Currituck Bridge----Connie Johnson reported that the estimated cost for the bridge is now \$1 Billion Dollar. NCDOT has applied for a federal grant and updated project schedule. Environmental approvals pending and planning will continue.

Spongy Moth Update- Bud Nusselt reported that aerial spraying of affected areas has been completed. No plans in place for another application.

Network for Endangered Sea Turtles (NEST)---Cathie Blanton

NEST covers area from Nags Head to Virginia State Line. Cathie reported that turtle season runs from May thru September. Volunteer teams have been combing the beach before sunrise. She mentioned that Most of our turtles come ashore at night to nest and urged care in driving on beach, and taking care so as not to disturb nest. Kemps Ridley sea turtles nest during the day, with one be recently spotted. NEST website www.nestonline.org. Eva Casola announced Board approval for donation in the amount of \$100 to Nest.

New Business

Trash Bin Ordinance in Progress---Carol Slamowitz mentioned county ordinance requiring secure garbage coral is in effect for all homes in 4x4 area. Homeowners have 6 months to comply. Complaints to Public Works Director Leighton Garwood.

Plug for Donkey Derby- Carol Slamowitz enthusiastically provided an overview of the Fund Raiser, and encourage all to participate. Sponsors welcomed. Event scheduled for July19th 3pm till 6pm with silent auction.

Other Pertinent Matters

Board approved sending a letter to Board of Commissioners pertinent to hours of operation for Horse Tours, Traffic on Beach, Unified Development Ordinance. Submit letters to commissioners Leann.Walton@cc.nc.gov.

Motion by Eva Casola, seconded by Cathie Blanton to form an Out Reach Committee that would be co-chaired by Carol Slamowitz and Jennifer Early. The committee would be involved with review of community-based projects to be approved. Discussion—Carol Slamowitz suggested additional FBCA sponsored activities in 4x4 area; other comments included property for horses, different passes for ramp access; support for active air down station. Jennifer suggested community meeting with Sheriff. All In Favor. Motion Carried.

Subsequently Eva Casola nominated Carol Slamowitz as activities chairperson, seconded by Jennifer Early All in Favor Motion Carried.
