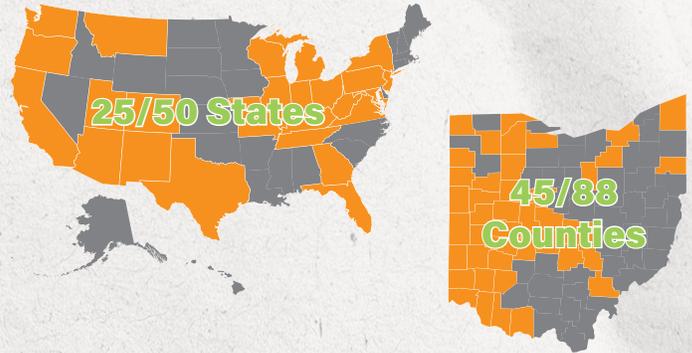

The Piqua Arts Council is dedicated to making the arts accessible to our community through education, support and presentation.

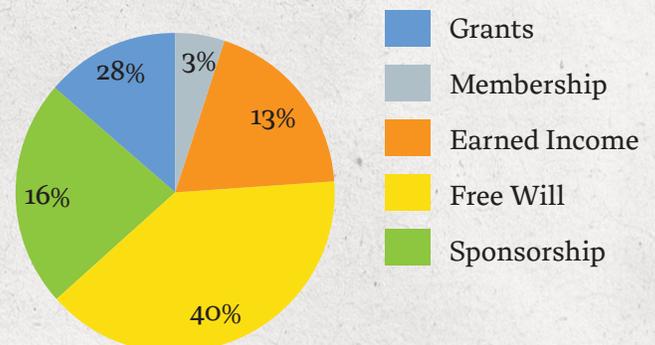
Vision

Income Stream Breakdown

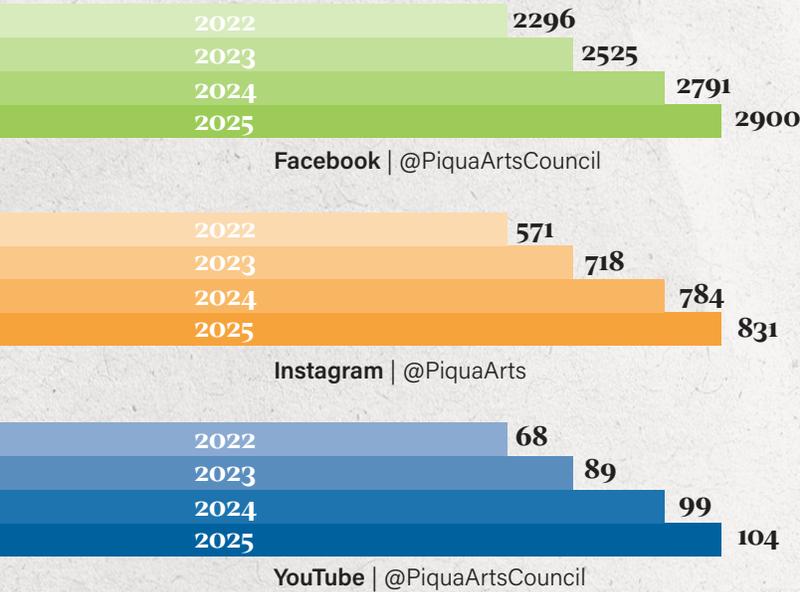
