# WORLD WAR II GOLD STAR BOYS



OSCAR C. BAKER

Address: Route #5, Fayette, Alabama.

Killed in Action, September 16, 1944.

Decoration: Distinguished Service Cross. "For extraordinary heroism in action on September 16, 1944, in the vicinity of \*\*\*\*. While driving his company commander along a road in front of the forward elements of his organization, his vehicle was suddenly caught in a blast of sniper fire. Requesting permission to make his way forward alone in an attempt to rout the enemy, Private First Class Baker, in the face of enemy small arms fire, fearlessly advanced toward an abandoned American tank. Manning the machine gun mounted on the tank, he directed heavy fire into the enemy positions which immediately replied with terrific machine gun fire. Then armed with hand grenades, he courageously crawled forward in the face of intense enemy fire, to within ten feet of the enemy. Fearlessly exposing himself, he then hurled hand grenades at almost point blank range until he had successfully neutralized the enemy machine gun emplacement. While attempting to reach an adjoining area which afforded a better field of fire, Private First Class Baker was mortally wounded by an enemy sniper. His extraordinary heroism exemplifies the finest traditions of the Armed Forces of the United States."
