

LEILANI ESTATES NEIGHBORHOOD WATCH MEETING MINUTES – November 27, 2018

The meeting was called to order at 7:00 pm by Greg Armstrong. Greg noted that the Community Police Officer was unable to attend and that no Puna crime statistics had been provided.

The October 30, 2018 Neighborhood Watch Meeting Minutes were provided as handouts and reviewed. Ross made the motion to approve the October minutes and James seconded the motion. All attending were in favor.

Greg gave the Treasury Report, indicating a balance of \$2,034.57 as of 11/26/18 but the monthly bank statement has not been received. Richard made the motion to approve the Treasury Report subject to reconciliation with the bank statement, Jay seconded the motion and all attending approved.

Richard presented the November Loose Dog Report, noting that enforcement of the Leash Law resumed after the last LENW meeting. Thirteen dogs were observed off-leash this month – 8 photographed, 3 first warnings and 1 repeat offender referred to HIHS. Also, 16 new volunteers signed up in October and 11 have been trained to date in November.

There was some discussion regarding signage for bikers other than LENW tee-shirts. Also, bikers with specific shifts will be listed on the Driver schedule along with vehicle drivers. That opens up several time slots for new volunteer drivers.

The issue of squatters/trespassers was also discussed. Greg noted that the new Police Chief was invited to the LENW meetings but so far has not attended. A number of people volunteered for a task force to come up with some suggestions on this topic. Alice Lindahl will coordinate with those volunteering.

Greg noted that the LENW active members list is being updated since the evacuation.
