SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Get medical advice/attention if you feel unwell or are concerned.

Skin Contact

Take off contaminated clothing, shoes and leather goods (e.g. watchbands, belts). Wash gently and thoroughly with lukewarm, gently flowing water and mild soap for 5 minutes. Thoroughly clean clothing, shoes and leather goods before reuse or dispose of safely. If skin irritation occurs get medical advice/attention.

Eye Contact

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. Remove contact lenses, if present and easy to do. If eye irritation persists, get medical advice/attention.

Ingestion

Rinse mouth with water. Do not induce vomiting. If vomiting occurs, have victim lean forward to reduce the risk of aspiration. Seek immediate medical attention.

Precautions for Safe Handling
