CONGRESSIONAL INTRODUCTION

Mr. [Sponsor], for himself and the co-signing Representatives and Senators, introduces the following bill:

“To end systemic corruption and exploitation, to restore moral law in governance, to reestablish American sovereignty in economic and civil affairs, to uplift the family and the laborer, and to renew the soul of the Republic by constitutional authority, biblical justice, and generational legacy.”

SHORT TITLE

This Act may be cited as the:

“American Restoration and Accountability Act of 2025”

or simply, “The Restoration Act.”

PREAMBLE

We, the representatives of the sovereign people of the United States, do solemnly declare:

That the Republic has strayed from its foundations. That her institutions are captured by deceit, indulgence, and lawlessness. That her youth are disoriented, her veterans neglected, her churches mocked, and her laborers defrauded that the political class has grown rich in decay. That her cities lie in ruins and her conscience lies asleep. We do not rise in rebellion. We rise in repentance. This Act is our first act of obedience—not merely to the Constitution, but to the God from whom all rights derive. Let this be remembered not as the hour we fell but the hour we stood.





OPENING PRAYER

O God of Justice and Mercy,

LEGISLATIVE PURPOSE

The purpose of this Act is sixfold:

- 1. To restore public morality and eliminate federally sanctioned sexual exploitation through the prohibition of state-funded pornography, the criminalization of digital sex trafficking platforms, and the establishment of family-anchored education standards;**
- 2. To establish full-spectrum public transparency and accountability through real-time financial disclosure, insider trading prosecution, and biannual integrity audits of all elected, judicial, and executive officials;**
- 3. To streamline and sanctify federal governance by eliminating agencies that do not serve the national interest, consolidating duplicative bureaucracies, and anchoring public administration in moral and constitutional principles;**
- 4. To rebuild the American city, not only in infrastructure but in soul—through architectural renewal, housing dignity, public order, and beauty-based zoning policies that inspire citizenship and community;**
- 5. To reward and reform national service, including VA transformation, CCC-style job programs for citizens, and a new emergency-ready civil guard known as the Patriot Reserves;**
- 6. To reclaim American economic sovereignty by replacing debt-based Social Security with Sovereign Trust Accounts, eliminating exploitative taxes, redistributing monopolized investment assets, and protecting American capital from foreign ownership and internal betrayal.**

OVERVIEW OF RESTORATION STRATEGY

A Republic is not restored by rhetoric but by policy, principle, and providence.

The American Restoration and Accountability Act rests on six structural pillars:

1. MORAL LAW RESTORED

Eliminates all federally sponsored pornography, trafficking platforms, and sexual indoctrination in public education. Replaces it with a national moral education standard rooted in family, virtue, and spiritual truth.

2. PUBLIC OFFICE SANCTIFIED

Mandates full disclosure, criminal penalties for insider trading, audits of judges and Congressmen, and creation of a real-time public Transparency Ledger.

3. THE FEDERAL GOVERNMENT RIGHT-SIZED

Eliminates bloated, ideologically captured agencies; consolidates operations under efficiency law; and redistributes public employment to construction, conservation, and care.

4. CITIES REBUILT

Restores architecture, civic order, public beauty, and housing dignity to urban centers. Ends homelessness through work and restoration zones. Ends crime via enforcement and community defense.

5. SERVICE REDEEMED

Reforms the VA, raises military pay, and honors combat veterans. Reintroduces purpose-driven employment through the Civilian Conservation Corps and Patriot Reserves.

6. ECONOMY LIBERATED





Abolishes miscellaneous taxes, redistributes monopolized assets into public trusts and establishes Sovereign Trust Accounts to replace debt-funded Social Security.

TITLE I – MORAL ORDER AND PROTECTION OF HUMAN DIGNITY

A Restoration of Conscience, Law, and the Sacred Dignity of the Human Person





SECTION 101. PROHIBITION OF FEDERAL FUNDING FOR SEXUAL EXPLOITATION

(a) No federal funds may be used directly or indirectly to create, promote, subsidize, or disseminate:

1. *Pornographic or sexually explicit material;*
2. *Content promoting promiscuity, digital sex work, or sexualized ideological education in public schools;*
3. *Educational materials that contain sexually graphic images, transgender ideology, or unscientific representations of biological sex.*

(b) Applies to:

- *All federal education grants and school districts receiving federal aid;*
- *Public universities, libraries, arts councils, and broadcast entities;*
- *Contractors or nonprofits receiving HHS or Department of Education funds.*

(c) Enforcement and Penalty:

Non-compliant institutions shall:

- *Be suspended from federal funding for 5 years;*
- *Undergo public audit and inspection by the Office of Public Integrity (Title II);*
- *Be disqualified from tax-exempt status where applicable.*

SECTION 102. FEDERAL BAN ON DIGITAL SEXUAL COMMERCE PLATFORMS

(a) It shall be unlawful to operate, host, finance, or distribute any online commercial platform offering sexually explicit content by subscription, donation, or commission, including but not limited to OnlyFans, Fansly, or derivative services.





(b) Platform operators and hosting entities shall face:

- *Felony prosecution under enhanced digital trafficking statutes;*
- *Seizure of all U.S.-based financial accounts, domain assets, and IP;*
- *Permanent ISP-level bans enforced through DOJ technology regulation.*

(c) Content creators found in violation shall be offered amnesty conditional on formal exit from the platform, mental health evaluation, and transition into federally-supported work retraining programs.

SECTION 103. NATIONAL ANTI-TRAFFICKING AND EXPLOITATION STRIKE FORCE

(a) A federal agency shall be established under the DOJ titled the “National Strike Force for Human Exploitation and Digital Trafficking (NSFHEDT).”

(b) Mandate Includes:

- *Coordination of state and federal operations against human trafficking rings, grooming networks, and online predator groups;*
- *Deployment of undercover task forces in high-risk cities and online networks;*
- *Oversight of safe houses, shelters, and post-trauma care programs.*

(c) Funding Source:

\$1 billion annually from civil asset forfeiture of seized trafficking, pornographic, and black-market platforms.

SECTION 104. MORAL EDUCATION STANDARDS AND PARENTAL RIGHTS GUARANTEE





(a) The Department of Education shall enforce a National Moral Education Standard for all K–12 schools receiving federal support.

(b) Required curriculum components:

- *Human dignity and the sacred nature of life;*
- *Dangers of pornography, digital grooming, and ideological confusion;*
- *Purpose and integrity of natural marriage and family;*
- *The foundation of virtue, self-governance, and moral accountability under God.*

(c) Parental Rights Provision:

- *No child may be exposed to sexual content without active written parental consent;*
- *Any institution retaliating against a parent’s objection shall forfeit federal funding.*

SECTION 105. DESIGNATION OF PORNOGRAPHY AS A NATIONAL PUBLIC HEALTH CRISIS

(a) Congress declares pornography to be a public health epidemic that:

- *Contributes to depression, addiction, relationship breakdown, trafficking, and spiritual desensitization;*
- *Harms children, warps male behavior and promotes violence toward women.*

(b) The Department of Health and Human Services shall allocate no less than \$2 billion over 10 years to:

- *Develop recovery clinics for addiction and trauma related to pornography;*
- *Partner with churches and nonprofits to provide community-based spiritual rehabilitation;*
- *Educate parents and communities on digital purity and child protection.*

TITLE II – RADICAL TRANSPARENCY IN GOVERNMENT AND MEDIA

“Let there be no darkness in the house of the people.”

SECTION 201. MANDATORY BIENNIAL INTEGRITY AUDITS OF PUBLIC OFFICIALS





(a) All federal judges, Members of Congress, U.S. Attorneys, and executive appointees shall be subject to a biennial Integrity Audit conducted by the newly established Office of Public Integrity (OPI) under the oversight of the Comptroller General.

(b) Audit shall include:

1. *Full financial disclosure (spouse and dependent assets included);*
2. *Voting record and non-recusal review;*
3. *Lobbyist, donor, and foreign influence analysis;*
4. *Behavioral, procedural, and media activity summary.*

(c) Outcomes will be graded:

- *CLEAR — Compliant*
- *CORRECTIVE — Requires public response and ethics training*
- *CORRUPT — Referred to DOJ and/or subject to recall review by state or Congress*

(d) Three consecutive CORRUPT grades result in permanent disqualification from federal service.

SECTION 202. CREATION OF THE PUBLIC TRANSPARENCY LEDGER (PTL)

(a) The PTL shall be a centralized, public-facing digital portal managed by the General Services Administration and accessible to every American citizen.

(b) Required uploads (in searchable, printable format):

- *Congressional voting records within 24 hours;*
- *Campaign contributions (personal and PAC-linked) within 7 days;*
- *Official travel, housing, and expense reimbursements within 10 days;*
- *Stock trades, asset transfers, or blind trust updates within three business days.*

(c) Penalties for concealment or failure to upload:

- *\$50,000 civil penalty per occurrence;*
- *Immediate report to the Office of Public Integrity;*





- *Suspension of voting or confirmation privileges for 30 days (if elected/appointed).*

SECTION 203. FOREIGN AGENT IDENTIFICATION AND BARRING CLAUSE

(a) Any educational institution, nonprofit, or media outlet receiving funds from a foreign state, corporation, or entity shall be classified as a Foreign Influence Entity (FIE).

(b) FIEs must:

- 1. Register annually under the Foreign Agents Registration Act (FARA);*
- 2. Publicly disclose foreign contributors on their homepage and publications;*
- 3. Submit curriculum, research, and operational data to OPI for ethics compliance.*

(c) Penalties:

- *Loss of federal funding;*
- *Suspension of accreditation or broadcasting licenses;*
- *Seizure of foreign-controlled assets if FIE attempts election influence or public policy manipulation.*

SECTION 204. CRIMINALIZATION OF INSIDER TRADING BY GOVERNMENT OFFICIALS

(a) No elected or appointed official, federal contractor, judge, or staffer may:

- 1. Trade in stocks, bonds, options, or derivatives based on non-public information;*
- 2. Use committee access, agency briefings, or classified intelligence to influence personal or familial financial decisions;*





3. *Transfer assets into “safe” holdings to avoid temporary restrictions.*

(b) All assets not in blind trust or public mutual funds shall be divested or frozen within 90 days of taking office.

(c) Violations incur:

- *Minimum 5-year federal prison sentence;*
- *Permanent disqualification from public service;*
- *Civil forfeiture of all related profits.*

SECTION 205. WHISTLEBLOWER & CITIZEN OVERSIGHT SAFEGUARDS

(a) Any U.S. citizen or government employee reporting valid corruption under this Title shall receive complete legal protection and anonymity.

(b) Whistleblowers who expose felonies resulting in financial restitution or public savings shall receive:

- *5% bounty of recovered funds, up to \$5 million;*
- *Priority security clearance for future service roles if desired.*

TITLE III –

EFFICIENCY BY ELIMINATION (DOGE)

Department of Government Efficiency: Cutting Waste, Restoring Honor, Enforcing Order

SECTION 301. ESTABLISHMENT OF THE DEPARTMENT OF GOVERNMENT EFFICIENCY (DOGE)

- (a) A temporary executive body titled the “Department of Government Efficiency” (DOGE) shall be established under the Office of Management and Budget (OMB).**
- (b) DOGE shall operate with sole authority to:**





1. *Audit, evaluate, and eliminate federal departments, agencies, boards, and offices that fail performance, duplicity, or relevance tests;*
2. *Recommend reorganizations, mergers, or sunset procedures for programs no longer aligned with constitutional governance or fiscal necessity;*
3. *Enforce compliance across all three branches through interdepartmental executive order enforcement, public transparency, and Congressional reporting.*

(c) DOGE shall terminate its independent charter on July 4, 2027, unless extended by a two-thirds Congressional majority.

SECTION 302. PERFORMANCE AUDIT AND SUNSET MANDATE

(a) Within its first 12 months, DOGE shall audit every federal agency, scoring them across three metrics:

- *Mission Integrity: Does the agency fulfill a necessary constitutional role?*
- *Functional Redundancy: Does it duplicate state, local, or private-sector operations?*
- *Fiscal Justifiability: Can the output be publicly defended as worthy of its budget?*

(b) Any agency receiving failing marks in 2 of 3 categories shall enter “Sunset Status.”

(c) Sunset Status agencies will be:

- *Defunded in 12 months if no Congressional override is passed;*
- *Offered reorganization into high-performing departments;*
- *Required to submit complete employee redeployment plans or closure logistics.*

(d) Departments prioritized for audit and potential dissolution include:

- *Department of Education (non-technical divisions);*
- *Department of Housing (non-veteran or non-infrastructure arms);*
- *DEI offices in all agencies;*
- *Non-essential arts, gender, or climate boards;*





- *Redundant agriculture and energy regulatory sub-commissions.*

SECTION 303. EMPLOYEE TRANSITION AND ETHICAL REALIGNMENT

(a) All federal employees displaced by DOGE recommendations shall be offered:

- *Retraining and employment in the Civilian Conservation Corps II (Title V);*
- *Reassignment into essential services (Veterans Affairs, infrastructure, law enforcement);*
- *Early retirement with a capped pension based on performance metrics.*

(b) Political appointees and ideologically hostile actors are ineligible for priority placement.

SECTION 304. EXECUTIVE REVIEW BOARD (ERB) OPERATIONS

(a) An Executive Review Board shall be convened to review DOGE recommendations before final execution.

(b) ERB shall consist of:

- *Director of DOGE (Chair);*
- *Two members from OMB;*
- *One member appointed by the Speaker of the House;*
- *A two-thirds vote confirmed one member of the Senate;*
- *One citizen selected by national civic exam and ethical screening*

(c) a simple majority must pass ERB votes and may be overturned only by two-thirds of the Congressional joint resolution.





SECTION 305. BUDGET REDUCTION AND CODE SIMPLIFICATION MANDATE

(a) DOGE shall achieve by December 31, 2027:

- *A reduction of \$300 billion in annual discretionary federal spending;*
 - *Sunset or absorption of at least 50 federal offices or programs;*
 - *A 25% reduction in the Federal Register and administrative code volume;*
 - *A complete publication of “The People’s Ledger of Federal Waste,” listing all dissolved entities and justifications.*

TITLE IV – URBAN RENAISSANCE AND CIVIC BEAUTY

“Let the cities of man reflect the order of Heaven.”

SECTION 401. FEDERAL URBAN RENEWAL INFRASTRUCTURE INITIATIVE (FURII)





(a) The Department of Housing and Urban Development (HUD), in coordination with the Department of Transportation, the Army Corps of Engineers, and the Department of Labor, shall administer the Federal Urban Renewal Infrastructure Initiative (FURII).

(b) FURII shall receive \$400 billion over 10 years to fund infrastructure, beautification, and housing development in distressed American cities.

(c) Eligible projects include:

- *Modern rail, tram, and street systems*
- *Rebuilding water, broadband, sewer, and electrical grids*
- *Restoration of abandoned or dilapidated blocks into walkable zones*
- *Low-income housing built in classical or heritage American architecture*

**** (d) All FURII projects must follow a “Dignity by Design” clause:**

Construction must feature human-scaled architecture, heritage materials, and public civic or spiritual-value inscriptions.

SECTION 402. SAFE STREETS AND CIVIC ORDER COMPACT

(a) Cities receiving FURII funds must sign a Safe Streets Compact with DOJ and DHS.

(b) Compact cities must:

1. *Reopen local precincts and foot patrol substations*
2. *Enforce quality-of-life ordinances (vagrancy, drugs, loitering, vandalism)*
3. *Remove open-air homeless encampments in designated renewal zones*
4. *Post quarterly crime statistics, prosecutorial logs, and police staffing levels*

(c) Non-compliance shall suspend FURII access and trigger redirection to compliant counties within the same state.





SECTION 403. NATIONAL CIVIC ARCHITECTURE GRANT PROGRAM

(a) \$40 billion shall be allocated over 10 years to restore and erect civic architecture that reflects American identity and spiritual dignity.

(b) Grants may fund:

- *Restoration of courthouses, churches, schools, and historic markets*
- *Construction of new libraries, civic halls, and squares in neoclassical or Romanesque styles*
- *Apprenticeships for stoneworkers, muralists, builders, and heritage artisans*

(c) Inscriptions Requirement:

All funded buildings must feature a verse of Scripture, a quote from the Founders, or a dedication to liberty and justice.

SECTION 404. HOMELESSNESS RECOVERY & TRANSITION ZONES (HRTZs)

(a) Each FURII-funded city shall establish at least one HRTZ—a federally backed, faith-partnered urban compound providing:

- *Emergency housing and meals*

(b) Eligibility Criteria:

- *5+ years community ministry in education, shelter, or mentorship*
- *Affirmation of moral, biblical, and constitutional alignment*
- *Support from local officials and law enforcement*

(c) Churches and ministries may receive federal protections, zoning priority, and matching grants to serve as neighborhood renewal anchors.

(a) The Department of Veterans Affairs shall undergo a comprehensive 36-month reformation and digitization led by a new Office of Veterans Integrity and Access (OVIA), under oversight of the Senate Committee on Veterans' Affairs.

(b) All veterans shall be guaranteed:

1. *Appointment scheduling within 14 business days*
2. *Access to private-sector medical services when government care is delayed*
3. *Portability of mental health and rehabilitation services across state lines*
4. *A personal digital VA dashboard, secured and encrypted, for all claims and care data*

(c) Noncompliant facilities shall be:

- *Assigned temporary federal oversight*
 - *Partnered with nonprofit hospital networks*
 - *Potentially replaced by regional veteran service hubs (military-university centers)*
-

SECTION 502. MILITARY COMPENSATION AND RETIREMENT STRUCTURE MODERNIZATION

(a) A national military compensation modernization plan shall:

- *Increase base pay for enlisted service members by 25%*
- *Guarantee family housing stipends indexed to regional cost of living*
- *Offer full tax exemption for active-duty combat income*

(b) Honor Retirement and Inheritance Plan:

- *Veterans who served in combat or hardship deployment may retire at 55*

SECTION 503. CIVILIAN CONSERVATION CORPS II (CCC-II)

(a) CCC-II shall be reestablished as a national service and employment program under the Department of Labor, with interagency deployment support.

(b) CCC-II shall employ up to 500,000 citizens per year in:

- *Reforestation and wildfire defense*
- *Rural water and broadband expansion*
- *Restoration of historic infrastructure (bridges, courthouses, parks)*
- *Disaster relief, food security, and agricultural revival programs*

(c) Participation Benefits:

- *Wages set at 115% of federal minimum wage*
- *Full healthcare during service*
- *One year of tuition forgiveness for every 12 months served*
- *Direct transfer pipeline to federal, state, or local employment*

(d) Priority applicants include:

- *Veterans, honorably discharged*
- *Formerly incarcerated citizens with completed rehabilitation*
- *Homeless or unemployed citizens enrolled through HRTZ programs (Title IV)*

SECTION 504. ESTABLISHMENT OF THE PATRIOT RESERVES





(a) The Patriot Reserves shall be a volunteer emergency civil corps authorized by Congress and overseen jointly by DHS and the Department of Defense.

(b) Patriot Reservists shall be trained and certified in:

1. *Emergency response and disaster logistics*
2. *Civic communication and public safety*
3. *First aid, civil defense, and spiritual guidance for crisis zones*

(c) Activation occurs via Presidential or Gubernatorial emergency declaration, and includes:

- *Flood/fire response*
- *Infrastructure breakdown*
- *Urban evacuation support*
- *Election security and integrity monitoring*

(d) Benefits include:

- *Monthly readiness stipend (\$300/month)*
- *Tuition credit for each year of service*
- *Priority public hiring and civil servant fast-track credentials*

(a) Every American citizen, upon reaching the age of 18, shall be granted a Sovereign Trust Account (STA), a government-secured asset dividend system designed to replace the tax-dependent Social Security model.

(b) STAs shall be funded by:

1. *Returns from national infrastructure assets (ports, railways, leases)*
2. *Dividends from public equity trusts (see Section 604)*
3. *Penalties, fines, and recovered federal funds from fraud enforcement*

(c) Withdrawals:

- *Begin at age 62 or upon medical exemption*
- *Tax-free up to a federal limit indexed annually*
- *Rollover and inheritance options allowed with no penalty*

(d) Existing Social Security participants remain grandfathered into current benefits unless they opt in to STA conversion with bonus incentives.

SECTION 602. ABOLITION OF MISCELLANEOUS AND PREDATORY TAXES

(a) The following are hereby eliminated:

- *Marriage license fees*
- *Internet access and wireless usage surcharges*
- *IRS non-criminal penalties under \$10,000*
- *Federal inheritance tax on estates under \$5 million*
- *Duplicate state-federal compliance fines for small businesses*

(b) All remaining tax enforcement shall be simplified into:

- *A single individual flat tax*





- *A corporate value-add tax on foreign shareholders*
 - *Constitutional customs, duties, and legitimate sin taxes only*
-

SECTION 603. NATIONAL DEFICIT DISSOLUTION PLAN

(a) The United States shall commit to a 60% reduction of its national debt by 2040.

(b) Strategies include:

- *Strategic sale and lease of non-critical federal lands*
- *Forensic audit of pandemic-era spending and ESG funds*
- *Windfall profit penalties on foreign-influenced firms evading U.S. tax*
- *Sovereign gold and energy reserves used to back international trade credits*
- *Tightening of federal contractor payments and closure of overlapping programs*

(c) The Congressional Budget Office and Treasury Inspector General shall submit an annual Deficit Reduction Report by September 1st each year.

SECTION 604q. PUBLIC BUYOUT OF MONOPOLIZED INVESTMENT ENTITIES

(a) The U.S. Treasury is hereby authorized to initiate strategic buyouts of U.S.-held equity and pension funds from entities including BlackRock, Vanguard, and State Street.

(b) Assets shall be restructured into:

1. *State Citizen Trusts — Equity dividends paid to residents via annual disbursements*
2. *Veteran and Worker Ownership Pools — Micro-equity programs for working-class Americans*
3. *National Industry Reallocation Boards — Prevent monopolization of farmland, housing, and manufacturing*

(c) No entity may:





- *Own more than 2% voting shares in any publicly traded U.S. firm*
- *Control agricultural, housing, or energy supply chains across states*
- *Conduct proxy voting in more than one industrial sector*

(d) All restructured funds must post quarterly transparency reports.

SECTION 605. AMERICAN ECONOMIC INDEPENDENCE CLAUSE

(a) Henceforth, all strategic sectors must be:

- *Domestically owned by 75% or more U.S. citizens or registered citizen trusts*
- *Insulated from foreign hostile or adversarial ownership by federal oversight*
- *Nationally preferred in federal purchasing contracts (America-First Supply Chain Act)*

(b) A Sovereign Audit Bureau shall be formed to ensure economic independence in:

- *Defense*
 - *Energy*
 - *Agriculture*
 - *Pharmaceuticals*
 - *Digital Infrastructure*

SECTION 701. AUDIT AND PUBLIC ACCOUNTABILITY OF FEDERAL JUDICIARY AND PROSECUTORS

(a) A permanent division of the Office of Public Integrity shall be established for Judicial Review and Accountability.

(b) Mandates include:

- *Annual ethics audit of all federal judges and U.S. Attorneys*
- *Publication of prosecution/refusal statistics in violent and trafficking-related crimes*
- *Disclosure of any political donations, affiliations, and recurring private legal firm connections*

(c) Findings will be classified:

- *Faithful — Constitutionally aligned*
- *Activist — Deviates from precedent or text*
- *Corrupt — Evidence of political interference, bribery, or prosecutorial neglect*

(d) Judges found “Corrupt” three times shall be disqualified from federal bench and referred to state bar associations and DOJ for disbarment proceedings.

SECTION 702. MORAL CIVIL CODE REVIEW AND RESTATEMENT INITIATIVE

(a) Congress hereby commissions the Moral Civil Code Review Panel, composed of legal scholars, clergy, veterans, parents, and constitutionalists.

(b) Objectives:

1. *Review federal civil statutes for alignment with natural law, biblical justice, and family integrity*
2. *Identify and recommend repeal of laws that undermine parental rights, religious freedom, or biological truth*
3. *Codify protections for the unborn, the institution of marriage, and biological gender identity*





(c) Deliverables:

A Restated Moral Civil Code of the United States, issued as a formal declaration and proposed legal compendium by July 4, 2027.

SECTION 703. FEDERAL EDUCATION RESET INITIATIVE

(a) The Department of Education shall be stripped of all ideological offices, including DEI, gender-based research units, and CRT-promoting curriculum arms.

(b) In their place shall be established:

- *The American Classical Education Bureau (ACEB)*
- *Mandate: Support states and districts in returning to civic, historical, moral, and faith-compatible education*

(c) Curriculum content includes:

- *Western civilization and the Christian foundations of law*
 - *Constitution, Declaration, and primary American founding documents*

(a) The Federal Communications Commission (FCC) shall be restructured into the Federal Truth and Public Morality Commission (FTPMC), with new powers and duties to uphold decency, protect minors, and defend national integrity.

(b) FTPMC Mandates:

1. *Enforce decency standards across television, film, music, social media, and streaming platforms*
2. *Require explicit labeling of violent, sexual, occultic, or anti-American content*
3. *Fine or suspend any licensee found broadcasting child-inappropriate content during protected family hours (6am–10pm)*

(c) Platforms that distribute pornography, child grooming material, or ideological propaganda targeting children may:

- *Have all federal ad, research, or telecom funding permanently suspended*

SECTION 802. CREATION OF THE AMERICAN HERITAGE COMMISSION (AHC)

(a) The AHC shall be formed as a cultural preservation and promotion agency under the Library of Congress in partnership with the Departments of Education, Defense, and Interior.

(b) Objectives include:

- *Develop national curriculum materials on American history, Western civilization, and Christian philosophy*
- *Support local museums, monument restoration, and the arts through moral grants*





- *Reissue foundational documents, sermons, letters, and records to every school in the nation*

(c) Annual observance of “America’s Covenant Day” shall be established:

- *Celebrated July 3rd, it marks the spiritual and philosophical foundation laid before the Declaration*
 - *Schools, churches, and cities may host reenactments, public prayers, and displays of the Decalogue and Constitution side by side*

SECTION 803. SOCIAL MEDIA MORALITY AND MINOR PROTECTION ACT

(a) Any social media platform with more than 5 million users must:

- *Implement age verification systems verified by government-licensed third parties*
- *Allow parents full access to monitor minors’ accounts and content*
- *Disable all location tracking, suggestive advertising, and AI-tailored sexual content for users under 18*

(b) Platforms that fail to comply shall be:

- *Banned from U.S. app stores*
 - *Sued by the Department of Justice on behalf of parents and minors*
 - *Subject to civil damages and punitive restitution funds deposited into national child protection initiatives*

SECTION 804. PROTECTION OF AMERICAN SYMBOLS, ANTHEMS, AND SACRED SPACES





(a) The desecration, destruction, or governmental removal of U.S. flags, historic Christian monuments, war memorials, or founding-era inscriptions shall be punishable by law.

(b) All federal agencies must:

- *Display the U.S. flag, the Declaration of Independence, and the phrase “In God We Trust” in all publicly accessible locations*
- *Protect chapels, crosses, and religious symbols on federal land under the Sacred Sites Preservation Act*

(c) Historic sites and federal spaces desecrated during riots or ideological movements must be restored and rededicated with full federal protection and investment.

SECTION 805. THE GOSPEL BROADCASTING AND NATIONAL MORAL FOUNDATION INITIATIVE

(a) The National Endowment for the Gospel shall be created to:

- *Provide funding to broadcast the Bible, moral education, and faith-based content via radio, internet, and television*
- *Partner with churches and schools to deliver family-centered programming*
- *Sponsor “One Nation Under God” national broadcasts during Easter, Christmas, and Independence Day*

(b) Funding shall come from excise taxes imposed on pornographic content providers, social media fines, and broadcast license fees of non-compliant networks.

(a) The Department of Defense (DoD), under oversight from the Comptroller General and the Office of Public Integrity, shall initiate a 24-month comprehensive audit of:

- *All military spending, procurement contracts, and overseas bases*
- *All federal defense contractors and their political donations*
- *Non-classified weapons transfers and aid to foreign regimes*

(b) Objectives:

- *Eliminate waste, duplication, and mismanagement*
 - *Restore moral standards in command leadership and code of conduct*
 - *Prioritize readiness, troop care, and infrastructure over ideological training*
-

SECTION 902. AMERICAN SOVEREIGN MILITARY SUPPLY ACT

(a) All military uniforms, ammunition, equipment, and technology must be:

- *Manufactured in the United States*
- *Sourced from American-owned suppliers with national accountability clauses*

(b) Exceptions granted only in emergency war footing, requiring joint resolution of Congress.

(c) All contracts must publish unit costs, margins, and labor sourcing to the public Defense Procurement Ledger.

SECTION 903. STRATEGIC REDEPLOYMENT AND BORDER DEFENSE EXPANSION





(a) U.S. troops shall be gradually repositioned from non-critical overseas bases to domestic defense operations.

(b) Border defense reforms include:

- *Doubling of National Guard forces at the southern border*
 - *Use of military drones and surveillance for anti-cartel interdiction*
 - *Integration of border defense into the Patriot Reserves system (Title V)*

SECTION 904. MORAL MILITARY DOCTRINE REFORMATION

(a) All U.S. armed forces shall return to a values-based military ethic:

- *Service academies must reinstate instruction on just war, natural law, biblical morality, and Western strategic tradition*
- *DEI offices, ideological training programs, and sexual experimentation initiatives within the ranks are abolished*

(b) Chaplains shall be granted full constitutional freedom to pray, preach, and counsel according to their faith without retribution.

SECTION 905. GOSPEL DIPLOMACY AND CHRISTIAN PEACE PROTOCOL

(a) U.S. foreign policy shall be governed by the following:

1. *No alliance shall be formed with nations that criminalize Christianity or violate conscience rights*
2. *Economic and military partnerships shall prioritize religious freedom, moral decency, and non-hostility to the United States*





3. *U.S. embassies shall be permitted to host worship, Bible studies, and prayer without restriction*

(b) The State Department shall annually report global Christian persecution data and propose sanctions or incentives accordingly.

******(b) All federal oaths of office shall include the phrase:

(a) Federal law shall prioritize preservation of Christian civilizational institutions and artifacts, including:

- *Cathedrals, chapels, manuscripts, sacred music, and biblical archives*

(b) National Civilizational Preservation Trust Fund established under Library of Congress and Department of Interior.

SECTION 1003. PROHIBITION ON ANTI-CHRISTIAN GOVERNANCE

(a) No federal agency or contractor shall:

- *Mandate affirmation of anti-biblical doctrines for employment*
- *Penalize Christians for conscience-based refusal to endorse sin*

THE FOUNDERS’ CHARTER OF THE AMERICAN RESTORATION

“A Covenant Between the Government and the Governed, Sealed by Truth and Service”

PREAMBLE

Let it be known, in the year of our Lord 2025, that the People of the United States of America—having witnessed the corruption of public institutions, the erosion of liberty, the abandonment of virtue, and the capture of governance by private interests—do solemnly establish this Founders’ Charter as a spiritual and civic covenant between a restored government and a righteous citizenry.

This Charter is not a replacement for the Constitution, but a reaffirmation of its true spirit. It serves as a binding agreement between those who wield power and those who entrust it, clarifying the sacred principles that must govern every lawmaker, judge, soldier, and servant.

SECTION I — AFFIRMATION OF MORAL ORDER

1. *We affirm that law is not created by man, but discovered through reason, tradition, and divine revelation.*
2. *We affirm that all legitimate authority comes from God and is accountable to truth.*





3. *We affirm that the dignity of the human person, created male or female in the image of God, is inviolable.*
 4. *We affirm that public power must be used not for self-enrichment, but for the flourishing of the nation and the protection of the innocent.*

SECTION II — PURPOSE OF GOVERNMENT

1. *To administer justice without favoritism.*
 2. *To protect life, liberty, and property from foreign and domestic threat.*
 3. *To reward the good and restrain evil.*
 4. *To create conditions for the cultivation of virtue, family, and faith.*
 5. *To operate transparently, honestly, and with a spirit of service.*

SECTION III — DUTIES OF THE CITIZEN

1. *To hold all leaders accountable without hatred or violence.*
2. *To obey just laws, resist tyranny, and protect the weak.*
3. *To labor honestly, raise families, and build community.*
4. *To speak freely and live peacefully without fear.*
5. *To give thanks to God and render Him the highest allegiance.*





SECTION IV — BINDING COMMITMENT OF THE RESTORED GOVERNMENT

By ratifying the American Restoration and Accountability Act, this Congress and all future officials swear to uphold:

- *Truth before politics.*
- *Service before profit.*
- *Virtue before popularity.*
- *Constitution before globalism.*
- *God's justice before man's applause.*

This Charter shall be read publicly each July 4th by members of Congress and inscribed in all federal buildings erected or restored under the Act.

FINAL CLAUSE

This Founders' Charter shall bind every office of public trust—judicial, legislative, and executive—to a standard greater than itself. Where this Charter is violated, the people shall have lawful recourse. Where it is honored, the Republic shall endure.

- *The right to speak, believe, assemble, and worship*
- *The right to defend life, home, and family*
- *The right to due process, equal protection, and honest governance*

Q8: Who grants these rights?

A: *Not the government, but God; the government may only recognize and defend them.*

PART IV — THE VIRTUES OF THE CITIZEN





Q9: What virtues must a free people possess?

A:

- *Faith, to see beyond fear*
- *Hope, to endure suffering*
- *Charity, to lift the broken*
- *Justice, to punish the wicked*
- *Fortitude, to stand when others bow*
- *Prudence, to choose wisely*

Q10: What virtue is the heart of all others?

A: Humility, without which freedom becomes pride and justice becomes vengeance.

PART V — THE CITIZEN’S CREED

I believe in liberty, but not license.

I believe in rights, and in the responsibilities they demand.

I believe in God, who gives what no man can take away.

I believe in my neighbor, who is not my enemy.

I believe in the Constitution, not as paper, but as a promise.

I believe in my duty to speak, build, serve, and sacrifice.

*I believe in my country—not for what she has done alone,
But for what she still must become.*

So help me God.

I. NATIONAL OATH OF OFFICE AMENDMENT

All federal oaths of office—from the President to local postmasters—shall be amended to include the following concluding phrase:

“...to uphold the Constitution of the United States and the moral law above it, so help me God, and may I serve the people with fear and not favor.”

This reaffirms that all civil power is under divine authority, and that office exists to serve—not to reign.

II. INTERGOVERNMENTAL REDEPLOYMENT ACT

- State and local governments may apply to absorb federal departments disbanded under Title III (DOGE), receiving block grants and implementation guides to handle responsibilities like infrastructure, emergency services, education, and veteran care.
- This prevents central power vacuums and affirms federalism.

III. PUBLIC COMMISSION ON RESTORATION HARMONY

- A rotating “Council of Twelve”, drawn equally from clergy, veterans, academics, and civic workers, shall convene annually in Washington, D.C., to assess moral and policy progress across the nation.
- They shall publish the State of the Covenant Report each Easter season, publicly critiquing both victories and failures in light of this Act’s mission.





IV. CIVIL DISOBEDIENCE AND PEACEFUL DISSENT PROTECTION

This Act shall not be interpreted to silence peaceful opposition.

Any citizen or leader may publicly disagree, file legal challenges, or vote against enforcement clauses.

However, no institution shall be federally funded if it uses that funding to undermine the Act's core principles:

- *Protection of children*
- *Sanctity of life*
- *Moral education*
- *Conscience and worship rights*
- *National sovereignty*

The Act demands no forced belief—but it does demand boundaries for the protection of the public good.

V. ENDOWMENT OF THE AMERICAN RESTORATION MONUMENT

A monumental plaza and temple of liberty shall be constructed on a hilltop site in the nation's capital—constructed of stone, oak, and marble—engraved with:

- *The full text of the Declaration of Independence*
- *The Ten Commandments*
- *The Sermon on the Mount*
- *The Preamble to the Constitution*
- *Excerpts from this Act's Epilogue and Charter*

This shall be a national place of remembrance, repentance, and renewal.

A civic sanctuary.

A silent sermon in stone.





CLOSING WORD

This Act is not a partisan project.

It is a moral emergency brake.

It is a covenant—not between political factions—but between generations.

It affirms that a government of the people must be governed by something greater than the people.

And it begins not in Washington, but in the home.

Not in speeches, but in service.

Not in bureaucracy, but in beauty, in order, in sacrifice.

Let this be the moment we chose truth.

Let this be the hour we reclaimed our soul.

So help us God.
