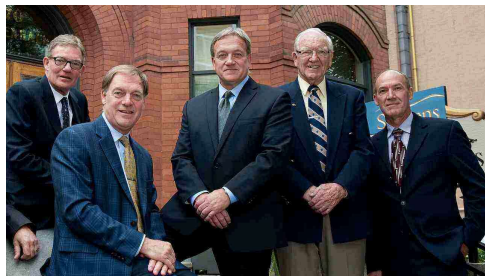
On the first page of the balance sheet it states 242000.00 Investment-Reserve-Interest Scrivens Reserve 8486.52.
