Closing Date- 12:00pm, September 16th, 2024 at the Test Secretary's home after which time entries will not be accepted, cancelled, altered or substituted.

Please use a separate entry form and check for each testing dog you are entering. **Entry Fee: \$30.00 per test per dog** in US funds to "GSMDCA," Indicate which test or both. You must pass two tests under two different judges to obtain a ATT Title.

**Prizes:** GSMDCA will award a ribbon to each qualifying dog for each leg and a rosette for greater swiss mountain dog titles.

**Eligibility of Dogs to Enter ATT Test.** The ATT test is open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners program. Clubs may not limit the test to certain

breeds except at a specialty club event which is limited to the specialty club's breed or a Group club may limit its event to breeds in its Group. Females in season may enter, but run last. Dogs with physical challenges (including amputees) are eligible to enter provided, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the test. A dog may enter only once per event. An event is defined by an event number. Entries accepted as first received until 50 dogs per test limit is reached. Entries open 7/01/2024.

**Directions**: From the **south** 89 N exit 12 take a left off the interstate onto VT-2A S go up the hill take a right onto Walker Hill rd in 0.6 miles turn left onto South Brownell Rd in 0.2 miles turn right onto Van Sicklen Rd then a left onto Blue Heron Dr. From the **North** 89S take Exit 12 take a right off the interstate and follow above directions.
