The **DATA** is self explanatory about the fact: Unless urgent, profound changes are in place, just in a few decades - **when children/grandchildren of today's adults grow up**, this incurable health calamity is to reach the widespread of pandemic, leading to the vast numbers of MCS victims, devastated by agony of painful affliction, **leaving fewer healthy enough people to take care of the sick**. And since such demographic change will collapse society, there is no time to waste: What seems difficult to change **NOW**, will soon become **IMPOSSIBLE**. Thus, the **LAST chance to shift from self demise NOW may not be missed**.

Urgent shift in prioritizing for **EFFECTIVE** protection of children from toxic exposures is **the key to reducing the risk from epigenetic triggers of genetic mutations from hormone disruptors, that had already predisposed majority of kids for being the high risk of MCS.**

**• That is why, forming community MCS TASK FORCES for independent oversight of this issue, based on the guidance of current carriers of MCS gift on detecting illegally legalized and normalized toxicants in many consumer products is the logical way of learning painful lessons to avoid and reduce similar suffering by the next generations.**

And likeminded parents may have better success by building camaraderie with committed to chemical safety folks for forming community MCS TASK FORCES to stop systemic malice against MCS victims.

And since this hideous pattern of gaslighting MCS victims is common, media exposure of its inner mechanism is to help break otherwise smooth operation of torturous pipeline, powered by unsuspecting **taxpayers' donations**. Seemingly "decent" individuals with the minds of thugs engaged, as well as condoned unprecedented **Death Row machine** for victims of MCS crisis,



shamelessly insisting on calling it “helpful services”. And how did city council respond to reported by her crimes? Urgent investigation will be the only logical response. But... NO, instead, more of life-threatening(!) hostility followed shortly in the form of grotesque acts of cruel liars and shameless evil doers... More recently, Ms. Gutman attempted to address the issues at the City Council, but bias-based lack of interest to the subject was expressed with no extension of minimal time of 3 minute. However, the unsolved problems for her MCS suffering won't discriminate against their OWN offsprings, as the result of the dangerous collective Blindspot. She hoped her earlier question to council Conrad would be finally heard and answered by city council, now led by environmental lawyer Silverstein in Mayor's chair, who is proud of being a loving father: **On what side of the Battle of Mindsets are you, when it comes to MCS risk for OWN offsprings & for the entire community?..** *Even crucifixion between two thieves (!) with the purpose of incitement of cruel bias and hatred by brutal liars & cruel power abusers against disabled by MCS teacher, scholar & author of the book on textbook-changing discoveries Rozalina Gutman* would not cancel the universal significance and urgency of her message, based on the MCS-stats.
