

Terms & Conditions

These terms and conditions apply to the contract between Beach Barkers Pet Services and the Owner to the exclusion of all other terms and conditions. Please note that no dogs registered under the Dangerous Dogs Act 1991 and hybrids registered under the Dangerous Wild Animals Act 1976 can be boarded.

Upon recruiting the services of Beach Barkers Pet Services, the Owner agrees to the following terms:

- 1. I agree that Beach Barkers Pet Services will not be liable for any claims of injury, illness, damage or death to my dog during its stay and that under no circumstances will Beach Barkers Pet Services be liable for consequential damages.
- 2. I certify that I have informed Beach Barkers Pet Services of all dog and human aggression. I agree that I am responsible for any harm caused by my dog while in the care of Beach Barkers Pet Services. I shall indemnify Beach Barkers Pet Services against any claims made against it or for losses or damages suffered by Beach Barkers Pet Services as a result of my dog.
- 3. I understand that, in the event my dog appears to be ill or at significant risk of experiencing a medical problem, Beach Barkers Pet Services will attempt to contact me for instructions prior to seeking veterinary care. If I cannot be reached, I agree that Beach Barkers Pet Services may use its reasonable discretion in seeking veterinary care on my behalf and I will be responsible for all related expenses. I understand that Beach Barkers Pet Services will use Coastway Vets, Freshfield Business Park, Freshfield Way, Brighton, BN2 0DF (including 24-hr on-site care). I agree that Beach Barkers Pet Services will not be liable for the actions and decisions of the veterinarian. I also agree to be responsible for any reasonable fees assessed by Beach Barkers Pet Services for emergency care and transportation. I understand this also applies to application of preventative treatment via Beach Barkers' chosen veterinary establishment.
- 4. I authorise my veterinarian to share the medical records of my dog with Beach Barkers Pet Services and other veterinarians. I assume full responsibility for payment of all veterinary services rendered, including, but not limited to, diagnosis, treatment, necessary grooming, medical supplies,

transportation and boarding. I agree to make such payments directly to the attending veterinarian or reimburse Beach Barkers Pet Services if direct payment cannot be made.

- 5. I give my consent for Beach Barkers Pet Services to allow my dog to share a designated space with dogs from other households also boarding in the location of and/or receiving daycare from Beach Barkers Pet Services. I also authorise Beach Barkers Pet Services to walk my dog outside the direct home environment, either solo or in a small group of dogs from other households (two 20 minute walks daily either on or off lead). Regarding walks, Beach Barkers Pet Services may use a crate for my dog for transportation via a vehicle, which I give my consent to. I understand and give my consent for all dogs to be fed at mealtimes together, as well as understand and give my consent for all dogs from different households to share the outside garden space together.
- 6. I allow my dog to participate in enrichment activities hosted/performed by Beach Barkers Pet Services, including (but not limited to) basic command training with treats, use of toys and foodbased activities designed for mental stimulation (e.g. 'licky mats' etc.) and use of basic agility equipment used on the premises (e.g. tunnel, adjustable hurdles etc.).
- 7. This agreement and waiver is valid from the date the registration form is signed and grants permission for future veterinary care without the need for additional authorisation each time Beach Barkers Pet Services cares for one or more of my dogs.
- 8. I will collect my pets promptly at the end of the boarding period and, at that time, pay any outstanding charges incurred during the boarding period. Failure to collect pets from Beach Barkers Pet Services on the due date unless an extension has been mutually agreed, Beach Barkers Pet Services reserves the right to place pets in boarding kennels at my expense.
- 9. Pets will arrive with their own bedding and food for the duration of their stay.
- 10. I give permission for any media footage of my pet taken by Beach Barkers Pet Services to be used on social media, the official Beach Barkers Pet Services website and any other literature and promotional material deemed appropriate by Beach Barkers Pet Services for no compensation. If I do NOT wish to consent to this, I agree to notify Beach Barkers Pet Services in writing at the time of booking.
- 11. I expressly waiver and relinquish any claims against Beach Barkers Pet Services except those arising from negligence on the part of Beach Barkers Pet Services. It is agreed that I will be liable for any damage to property or possessions of Beach Barkers Pet Services caused by my pet.
