

**CAIRNS SAINTS FOOTBALL AND NETBALL CLUB
PLAYER AGREEMENT AND CODE OF CONDUCT**



BETWEEN: CAIRNS SAINTS AUSTRALIAN FOOTBALL CLUB INC.

WHEREAS:

1. Cairns Saints has agreed to engage your services as a player for football season <insert year> where you will be regarded as "The Player" in terms of this agreement.
2. The player has agreed to accept the terms of this agreement as a player with the Cairns Saints.
3. Cairns Saints and the player have reached agreement as to the terms and conditions which apply to the player's playing with Cairns Saints.

IT IS AGREED AS FOLLOWS

- Cairns Saints appoints you as a player & member with the Cairns Saints Australian Football Club Inc in 2017
- The player agrees to be a financial member with the Cairns Saints in 2017 and undertakes to pay in full the annual fee to be a financial member prior to the first game. Payment can be made by instalments or lump sum.
- The player understands that any player who is not fully financial prior to first game, will not be selected until fully financial.

Duration

The player's agreement shall commence on 1st of March 2017 and continue until the end of the football season 2017 which will be on or about 30th of September 2017.

Duties and Accountability

The player shall be responsible for playing services with the Cairns Saints football team during football season 2017.

The player's duties include but are not limited to:

- Playing services as deemed appropriate after consultation between the player & the Senior Coach of Cairns Saints
- Implementing the directions as to playing provided by the Senior Coach of Cairns Saints

In performing his duties the Player must at all times:

- Serve the Cairns Saints faithfully and diligently and exercise all due care in the performance of his duties
- Act in the best interests of Cairns Saints at all times
- Refrain from acting or giving the appearance of acting contrary to the best interests of Cairns Saints
- Perform his duties to the best interests of Cairns Saints as and when required by the Senior Coach, President and the Committee of Cairns Saints
- Comply with all current club policies, rules and regulations

Playing Services

The player agrees that he is required by Cairns Saints to play as a Cairns Saints' Australian Football Club team member.

Remuneration

The player is entitled to and shall be eligible to receive game incentives on offer for each respective senior game as remuneration during football season 2017.

Discipline

If the player is deemed by Cairns Saints to have brought Cairns Saints into disrepute or to have discredited Cairns Saints by his actions, words, deeds or performance, Cairns Saints may, at their own discretion, impose a penalty upon the player. The player agrees the penalty may take the form of:

- A monetary fine which is calculated by the Senior Coach, President and Committee of Cairns Saints as a sum in accordance with the severity of the action of the player
- Disciplinary action that may also, at the discretion of Cairns Saints, include suspension from playing duties
- Suspension from frequenting club grounds or premises
- Termination of this Agreement by Cairns Saints

Where any member of the Cairns Saints is deemed to act in an unruly behaviour or it is brought to the Cairns Saints Committee's attention of such behaviour, players are at risk of suspension from playing duties for a time to be determined at the discretion of the Committee.
