Instructions Regarding Personal Guaranty

Should it become necessary to place my/our account with a collection agency or attorney for collection, I/we agree to pay all costs of collection, including court costs, and attorney fees in the amount 33.33%. You have my/our permission to contact any resources concerning the extension of my/our credit, and for any future updates to your files as may be deemed necessary from time to time.
