The risk of loss for all goods shifts to Buyer at the location of Deltana's warehouse. Buyer shall pay all of Deltana's costs, which shall include attorney's fees, associated in any way with enforcement of the Agreement, at all levels of proceedings, including appeals. Buyer waives trial by jury, consents unconditionally to jurisdiction in the State of Florida, agrees that all legal proceedings relating to any matter arising or related to the Agreement must be filed in Miami-Dade County, Florida, and agrees that any such proceeding shall be governed by Florida law. Buyer authorizes Deltana to obtain and Buyer's bank to release all bank account, loan and credit information regarding Buyer. Buyer authorizes Deltana to submit billing via regular paper mail or electronic media at Deltana's discretion.
