TERMS AND CONDITIONS

These terms and conditions apply to all products (collectively, the "Products") sold or otherwise provided by Kluden, Inc., a Florida corporation ("Company"), to customer ("Customer").

1. PRICES

The most recent prices provided in the most recent price guide for the Products of Company (the "Price Guide") prevail and supersede any previous prices for the Products. Prices are in United States Dollars and the prices can be modified at any time without prior notice to Customer. Company's prices in effect at the time Customer orders the Product shall supersede any price provided in the Price Guide unless Company has provided Customer with a written, firm price quote and Customer has placed an order for the Product causing the goods to be shipped within the time period specified in such written, firm price quote. Prices provided in the Price Guide do not include any taxes, shipping, or freight charges.

2. PAYMENT

Payment is due by Customer at the confirmation of Customer's order. Products will only be shipped once payment is received.

3. ORDERS

All orders must be in writing and indicate the name of the Product and the item code of the Product as provided in the Price Guide.

4. TAXES

Company will charge any applicable sales tax or other applicable tax to Customer unless sufficient proof of purchase for resale or an applicable exemption certificate is provided at the time an order is placed.

5. DELIVERY

Products ordered by Customer will be shipped through a carrier of Company's choice. All Products will be shipped at Customer's expense and risk, and Company does not insure any shipped Products. If Customer has placed an order for more than one Product, then Company reserves the right to ship the Products together in a single shipment or to ship the Products in separate shipments.

6. RISK

Company will not be liable, and Customer will bear the risk of loss, for any delay, damage, expense, cost, or loss which may occur beginning when the Products are given by Company to the carrier for shipment.

7. QUANTITY AND QUANTITY CLAIMS

Customer must inspect all Products immediately upon receipt from Company. Any claim by Purchaser regarding the quality or quantity of the Products must be reported to Company within eight (8) calendar days of Customer's receipt of the Products and prior to the beginning of the installation of the Products. Company shall have the right to deny any claim and, at its sole option, may either replace or complete the order as the case may be.

8. RETURN OF PRODUCT

No return of any Product will be by Company accepted unless the return has been explicitly authorized by Company in writing.

9. CHANGES TO PRODUCT

Company reserves the right to make changes without notice to the design of the Products or the packaging of the Products.

10. NO WARRANTY

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE PRODUCTS ARE PROVIDED BY COMPANY "AS IS" AND "AS AVAILABLE" WITHOUT ANY CONDITION OR WARRANTY WHATSOEVER. ALL CONDITIONS AND WARRANTIES, WHETHER EXPRESS OR IMPLIED, ARE DISCLAIMED BY COMPANY, INCLUDING, WITHOUT LIMITATION, THE IMPLIED CONDITIONS AND/OR WARRANTIES OF MERCHANTABILITY, TITLE, NON-INFRINGEMENT, AND FITNESS FOR A PARTICULAR PURPOSE.

11. SUCCESSORS AND ASSIGNS

All covenants of warranty and liability contained in these terms and conditions shall be binding upon Customer and their successors, assigns, transferees, and ultimate users.

12. FORCE MAJEURE

Company shall not be liable for any delay or for any failure to perform any of its obligations if the delay or failure results from events or circumstances beyond the control of Company (a "Force Majeure Event"). Such Force Majeure Events include, but are not limited to, acts of God, strikes, lock outs, accidents, war, fire, breakdown of plant or machinery, or shortage or unavailability of raw materials from a natural source of supply. Company shall be entitled to a reasonable extension of time to complete its obligations upon the occurrence of a Force Majeure Event.

13. GOVERNING LAW AND JURISDICTION






These terms and conditions and the interpretation of the rights and duties of the parties to these terms and conditions shall be governed by the internal laws of the State of Florida (without regard to conflict of laws or similar concepts). Customer and Company hereby irrevocably submits to the exclusive jurisdiction of the Twelfth Judicial Circuit in and for Duval County, Florida, or the United States District Court for the Middle District of Florida, in any action or proceeding arising out of, or relating to, these terms and conditions, or the relations between Customer and Company.

14. ENTIRE AGREEMENT












These terms and conditions constitute the entire agreement between Customer and Company and supersede all prior agreements and understandings, whether written or oral, between and among such parties relating or regarding the subject matter of these terms and conditions.
