

## The Basics of Firearms Training Packet

From the Instructor,

Welcome to Paladin Tower Tactics “The Basics of Firearms” course. My name is Scott Willey, and I want to sincerely thank you for trusting me with your firearms training needs. I applaud you for taking your first steps towards gun ownership and choosing to defend yourself and others with a firearm.

As you are aware our country was founded with a “Bill of Rights.” This was the first 10 amendments to our Constitution that the framers of our Government and Country deemed necessary to recognize. The 2<sup>nd</sup> of these amendments was a provision that directly relates to the right of the people to own firearms. As the second priority you will give an account to God for how you exercise your rights as it relates to your fellow humans. It is your responsibility to seek out the ability to use a firearm safely and competently. The ability to defend yourself with deadly force is incredibly sobering. ### Class overview:

The basics course exists to teach students about the “tools of Liberty.” You will learn about various types of firearms and how they function. The primary goal of this class is to teach students firearms safety and function. The goal of the class will be to build confidence in students through education and weapons familiarization. Ultimately Paladin Tower Tactics exists to teach students how to survive the Gunfight, the Legal Fight, and the Spiritual Fight. Therefore, we will touch on the legal and spiritual ramifications of a deadly force encounter. Class discussions and questions are encouraged!

***This class is four hours long and the price for Tuition is \$150 per shooter. Payment due prior to class using Stripe. You will not receive the location of the class or details for it without paying first. Tuition is non refundable. If you cannot make it to class you are encouraged to sell your slot to someone else. Please let us know if you do this, so that we can have the necessary paperwork ready for the change.***

**Prior to training:**

This section will include a list of items you will need to train and a YouTube video that is mandatory to watch prior to training.

The following is a list of gear that you will need to participate in class:

1. You do not need to bring a firearm to class with you. I will have a rifle and pistol ready for you to shoot.
2. You will need 50 rounds of 9mm practice ammunition for each shooter that will be participating.
3. You will need 50 rounds of 5.56x45 rifle practice ammunition for each shooter that will be participating. There will be no steel core ammo allowed on the range (green tip).
4. Hearing protection.
5. Eye protection – clear eye protection. Sunglasses and reading glasses are not adequate eye protection.
6. Appropriate clothing – no flip flops or tank tops. I recommend pants, t-shirt, and some type of boot or shoe. Ladies, please do not wear inappropriate clothing. The more skin that is exposed the more likely hot shell casings will find their way down your shirts, thus burning you and creating scars, just be modest for more than one reason. Remember rain gear, bug spray, or sunscreen – whatever the weather or season requires.
7. Bring a notebook and pen (preferably one that fits in a pocket). You will want to take lots of notes.
8. Please bring plenty of water for yourself.

**You will need to read, print, and sign the release of liability form that is on the last page of this packet and bring it to class to turn in. The other form on the second to last page is an application for training.
