- 3. A security/cleaning fee of \$400 and a nonrefundable rental fee of \$250.00 (even if party is cancelled) payable by money order for rental fee and personal check for the deposit, both are required prior to the party. <u>CHECKS</u>
  <u>PAYABLE TO: WESTWOOD COMMUNITY TWO.</u> It is understood and agreed that such security deposit and rental fee does not represent all nor limit the Associations recovery against a party or parties responsible for an event requiring use of all the security deposit proceeds. If the clubhouse is left in good condition, the \$400 deposit will be completely refunded upon inspection at the end of a party by a board member. If the clubhouse is in need of any cleaning, maintenance, or repair, the deposit will be forfeited.
- 4. The homeowner shall indemnify and hold harmless the Association from any cause of action which arises out of the serving or consumption of alcohol in the clubhouse or at the function for which the clubhouse is being reserved.
- 5. All trash must be removed from the premises completely.
- 6. Association may decline request for Clubhouse use as the Board of Directors deems appropriate at the Associations discretion. Such Board of Directors determination is without recourse, obligation or liability to the requesting party.
- 7. The homeowner assumes all responsibility/liability while using the clubhouse.
