NOTICE IS HEREBY GIVEN that the Stanislaus Council of Governments (StanCOG) will be the lead agency for the preparation of a Programmatic Environmental Impact Report (EIR) for StanCOG's 2026 Regional Transportation Plan (RTP) and Sustainable Communities Strategy (SCS). The Notice of Preparation (NOP) provides details of the project and upcoming opportunities for public comment. The 2026 RTP/SCS is an update to the StanCOG RTP/SCS that was previously adopted in August 2022. Pursuant to Section 15082 of the California Environmental Quality Act (CEQA), StanCOG is soliciting comments from all interested persons, responsible and trustee agencies, and organizations concerned with the project as to the scope and content of the EIR and the environmental information to be analyzed in connection with the proposed project.

We are soliciting comments on the issue areas you would like to have addressed in the Programmatic EIR. You will have an opportunity to comment on the actual Programmatic EIR when it is released for public comment.
