### 1. INTRODUCTION

- 1.1 The Navajo Division of Transportation is requesting construction firms interested in blading and placing gravel on 3.50 Mile of Earthen Road in To'Nanees'Dizi, Arizona, Navajo Nation. The road name and number is To'Nanees'Dizi N1012.
- 1.2 Construction Plans and Bid Forms is available at Navajo Division of Transportation Website at navajodot.org.
- 1.3 This project is subject to all provisions of the Navajo Business and Procurement Act, 12 N.N.C. §1501 et seq.
- 1.4 The selected firm shall comply with all provisions of the Navajo Preference in Employment Act at 15 N.N.C. § 601 et seq.
- 1.5 The selected firm shall contact the Navajo Nation's Source List of firms to be given priority in Firms' selection of subcontractors for this project.

#### 2. PROJECT DESCRIPTION

The Navajo Division of Transportation is planning improvements to To'Nanees'Dizi N1012 located in To'Nanees'Dizi, Arizona. Currently, the To'Nanees'Dizi N1012 is an earthen road that is routinely maintained by the Navajo Division of Transportation. The scope of work consist of blading, shaping road, placing gravel with chemical stabilizer along 3.50 Mile of To'Nanees'Dizi N1012 Route.

#### 3. PROJECT LOCATION

This project is located in To'Nanees'Dizi, Arizona. The length of Route #N1012 is 3.50 mile as shown on the attached Plans.

# 7. PROSPOSAL EVAULATION SCORING CRITERIA

- 7.4 Commercial Liability Insurance, Proof and Ability to get Performance Bonding. 10 Points
- 7.5 Experience working on Navajo Nation projects. Experience working with Navajo Nation 20 Points.

- 7.6 Qualification of Firm and Qualification of Key Personnel. 20 Points
- 7.7 A total of 100 Points Possible

#### 8. PROPOSAL CONTENT

- 8.1 A limit of 20 pages is required, 8 ½ x 11 size, double sided sheet counts as one page.
- 8.2 Proposal shall contain the following:
  - a. Cover Letter; clearly stating who the firm is. Does not count towards 20 page limit.
  - Proposal, 20 Page Limit (can be double sided) Introduction, Overall Road
    Construction Experience, Culvert Installation Experience, Heavy Earth Moving
    Experience on the Navajo Nation, Experience on Transportation Projects, Team
    Members, Firm's Qualifications, Plan of Approach, Heavy Equipment to be used.
  - Resumes of Key Personnel, Commercial Liability Insurance, Capability of Obtaining Performance Bonding, Navajo Nation Business Regulatory Certification, State Contractor License Does will not count towards 20-page requirement.
  - d. In **A Separate Sealed Envelope**: Completed Bid Form Sealed Bid

# 9. SCOPE OF WORK

- 9.1 According to the Plans the Selected Contractor shall blade and place gravel with chemical stabilizer on 3.50 Mile of earthen road along N1012 located in To'Nanees'Dizi, Arizona.
- 9.2 Selected Contractor shall follow the plans and specifications for this project.
- 9.3 Compaction water, mobilization and temporary traffic control will be incidental to the project. Selected Contractor shall obtain a water use permit for this project.
- 9.4 Selected Contractor shall set up a Construction Yard with the assistance of the To'Nanees'Dizi Chapter and Navajo DOT.
- 9.5 Traffic Control during construction operations shall be in accordance with the "Manual on Uniform Traffic Control Devices, 2009 Edition" by the Federal Highway Administration (FHWA).

#### **10. DELIVEREABLES**

10.1.1 A total of 3.50 Mile of N1012 road shall be bladed and gravel placed with chemical stabilizer on the prepared road surface according to the plans.

# **11. PROJECT MANAGEMENT**

- 11.1 Selected Firm shall prepare a regular progress reports with each invoice submitted; perform regular budget and schedule monitoring; coordinate with utilities, NDOT representatives and other project stakeholders; and manage sub-contractors.
