For Road Projects

AUTHORITY:

Attachment B is to be appended to the Master Intergovernmental Agreement (IGA), MOU 254, for road maintenance on Navajo Route N474 located in Ojo Encino Chapter, NM. and improvement projects between the Navajo Nation (NATION) and Sandoval County, New Mexico (COUNTY) as contemplated in Sections 1. Purpose, and 1.A Funding for Projects of the Master IGA.

SCOPE OF WORK

Routine Maintenance on Navajo Route N474, Ojo Encino Chapter, NM.

Routine maintenance activities on Navajo route N474 shall consist of patching and blade patching of existing pavement surface. The County shall clean and place bituminous patching material in potholes throughout the route. Blade Patching shall be performed in areas where the paved section has failed in long and wider sections. This shall be performed by cleaning (brooming) areas, placing bituminous patch material, leveling with approved equipment, and consolidated with rollers or other equipment. Traffic control shall be the responsibility of the County by use of signs and flaggers as needed.

Payment to the COUNTY:


Per section 5.A. of the Master IGA, the NATION shall provide the COUNTY **\$499,398.40** in funding for the PROJECT. This funding shall be placed in an account established by the COUNTY and will be utilized for the work described in the Scope of Work of this Attachment.

Upon mutual agreement of both parties, project termini may be altered that fall within the same scope as described in this attachment. **Altered PROJECTS would commence once upfront/startup funding has been received by the COUNTY unless there is sufficient funding remaining from the initial payment to the COUNTY.**






