Youth ACME Machine Firearms AR Build Class

May 9, 2026 - Begins at 9:00am

This event will allow your child (ages 10-18 only) to build an AR platform rifle with the assistance of ACME Machine, the manufacturer of the rifle. After building the rifle, your young shooter will go to the MCSA Range Complex and will shoot the rifle they built. After shooting, they'll be taught how to clean the rifle properly and then will take the rifle home with them. Lunch will be provided. The shooter will need to bring 50 rounds of ammunition in the caliber they select to the event. Application and \$500 purchase price must be received by MCSA before April 19, 2026. Each child must have their own application. Space is limited to the first 30 applicants.

**According to State and Federal law, the parent of the youth IS REQUIRED to have an FFL background check done. There will be an FFL on site to complete the background checks.**
