Opening

The meeting was called to order once all attendees arrived. Previous minutes were reviewed and approved by affirmation.

Financial Report

- Financials were distributed prior to the meeting.
- The food truck, which has visited three or four times, contributes 10% of its profits to the club.
- Receipts from recent visits included three checks for 10% and one for 6%.
- All financial statements were accepted without further comment.

Membership Report

- Two new membership applications were approved:
 - Ronald David Arnold (sponsored by Bob Meals and Tom Calp)
 - Joshua S. Johnson (sponsored by Tyler Norton and Ryan Gore)
 - Motion to approve new members was approved by Annette McClure and 2nd by Bob Meihls

Facility and Lighting Discussion

- Discussion centered on the trap range electrical and lighting systems:
 - Existing wiring is outdated ("from the 1930s") and presents safety risks.
 - Kester Electric previously serviced some lights.
 - Proposal to form a committee to plan rewiring and safety upgrades.
 - Discussion included burying lines properly, installing a new panel, and upgrading to LED lights.
- Members emphasized proper planning and doing the project correctly without piecemeal fixes.
- Suggestion to use the 200-amp barn service as the base for the new system.

Scout and Youth Group Use Policy

- Repeated damage and messes by certain Scout groups prompted discussion of requiring deposits.
- Incidents included:
 - Stones thrown into trap houses.
 - Children climbing on equipment.
 - Messes requiring paid cleaning services.
- Motion passed to require a \$250 refundable deposit for groups using facilities for free (e.g., Scouts, 4H).
- Deposit requirements will apply selectively based on group reliability and prior conduct.

Janitorial

- Bob Meihls motioned to pay Jennifer (cleaner) \$30/hour
- Ben Brown Second the motion

Exterior and Flag Lighting

- Proposal to keep porch lights on a timer or dusk-to-dawn sensor for safety and security.
- Plan to install a new LED light for the flagpole.
- Estimated timer cost: \$25-30; flagpole light ~\$400-450.
- Electrical work to be handled by members with relevant experience.
- Decision: Proceed with timer installation; further pricing to be gathered for flagpole lighting.
- Ben Brown to get quotes

NRA Grant Opportunities

- NRA grant applications open until November 8.
- Discussion focused on potential purchases for Youth Fest and Junior Rifle programs(jackets, mats, ammunition).
- Junior Rifle currently has ample .22 ammo stock dating to 2016, suggesting no immediate need for ammunition funding.

Law Enforcement Range Use

- Discussion on permitting law enforcement officers to conduct advanced training (shooting off pad, tactical drills).
- Other ranges (such as Salina) have restricted such usage.
- Proposal to let officers use the range under specific safety conditions was raised; topic tabled for further committee review.

Closing

- No further business was raised.
- Meeting adjourned following general discussion about safety improvements, maintenance scheduling, and facility use regulations.
