## MINUTES OF PREVIOUS ANNUAL MEETING

Annual Meeting, March 29, 2023

Park Avenue Community Center, 129 Park Avenue, Swarthmore, PA

Pizza and salad lunch was provided by SSCA prior to the meeting.

There were 38 attendees.

President Nancy Daniel welcomed the attendees at 12:30, and expressed her pleasure at having new members.

There was a moment of silence to remember Vimala Rajagopal, Madeline Iannucci, Sally Dow, Carolyn Stephens, and Peter Bloom, members who had died in 2022. Nancy remarked that most of the SSCA activities in 2022 were in person.

The minutes from the April 6, 2022 annual meeting were approved.

Two new members to the board were introduced: Jo Ellis and Bill Scarborough. Dan Snyder, Nancy Daniel, and Shirley Mitrovich, current members, were nominated for reappointment. All nominees were approved by the meeting attendees.

Nancy introduced Stephanie McDonough, SSCA administrator, and elaborated the many ways Stephanie has been a valued member of the staff.

Ann Foster, who is retiring as membership chair, was thanked for her excellent work. Louise Coffin was also recognized as a valued board member.

Nancy announced some upcoming plans for SSCA: ongoing Friday Friends at the Co-op from 2:00-3:00. Lunch & Learn programs are scheduled through June 7 before taking a summer hiatus. The annual picnic will be held June 14 at the Park Avenue Community Center, either indoors or on the lawn. Nancy asked the members to think of volunteer activities each would like to do, and which ones might they want to see put into action.

The meeting ended with a tribute to Louise and David Coffin, who are moving to Ohio. Their many contributions to SSCA were described, and they were given a gift certificate to be used at their new home.

Adjournment was 12:55, followed by dessert, and attendees were encouraged to socialize, and say farewell to the Coffins.

SSCA is on solid financial ground. Our revenues are sufficient to meet our current needs. They are provided through the generosity of past and present members, as well as the Borough. We have good control of our expenses. The Treasurer reports to the Board at monthly Board meetings.

## FINANCE

Following this overview and summary you will find independent accountant George Kaffes' Compilation Report which is derived from documentation of our accounts provided to him by our administrator and our treasurer.

Overview:

Income for the year 2023 was derived from interest and dividends from investments, tax deductible contributions from our membership, a generous grant from the Swarthmore Borough, and support from the community. Volunteer contributions from our membership remain a very important part of our support during the year.

SSCA has an invested fund created after a bequest of approximately \$300,000 from the late Irma Zimmer. We continue to maintain our investments at Vanguard, in mutual funds that are balanced to produce growth and preserve capital.

Summary:

Our financial status improved, roughly in line with the generally improving market. Our expenses in 2023 were covered by other income, plus a grant from the Borough. We see no reason to revise our investment strategy at this time. We are confident of our financial situation going forward.



## **BOARD OF DIRECTORS**

President: Nancy Daniel

SSCA's Board of Directors continued monthly meetings in 2023, made a strong presence at our varied activities, and provided a geyser of ideas for staying vibrant and connected to the community. The geographic representation in our membership continues to widen, as do our number of official dues-paying members. With welcomed input and support from general membership, the Board maintains a healthy schedule of relevant and supportive ventures.

With the decision to launch several half-day Wellness Workshops in lieu of an annual all-day Wellness Fair, SSCA has fostered consistent community interest and awareness of healthy aging. Continued partnership with the Park Avenue Community Center inspired the Center's creation of a series of weekly summer art activities, inspiring participants to try new things. We're most appreciative of this opportunity to reclaim creation as a vital process, regardless of the artfulness of the finished product!

While the Board voted to relinquish affiliation with the national Time-Bank movement, we are fortunate that our tireless Administrator, Stephanie McDonough, continued to maintain a network that connects our community members with local resources. We are grateful to Stephanie for the many ways she enhances and steadies our Board functions and SSCA activities. In addition she has smoothed the transition after three active board members left us unexpectedly this year: sadly our Treasurer, Gudrun Weinberg, died in the fall; Vice President Louise Coffin moved to Ohio in the spring; and past president Linton Stables moved to California in the summer. We miss them all – and they are part of the history that makes SSCA resilient and forward-looking.

We are again grateful to the Borough of Swarthmore for funding our request that supports salary for our part-time administrator, rent payments to the PAC Center, and in 2023 subsidized the series of wellness events, as well as contributing to honoraria for Lunch and Learn speakers.

My personal thanks to each of our Board members and Advisors, the PAC Center staff, our Swarthmore Borough partners, and all of our volunteer members for your amazing goodwill and support. Another great year!

## **MEMBERSHIP**

Acting Chair: Nancy Daniel

Membership total this past year shows a roster of 320 members, close to the previous year's total of 326. Our new member applications have continued to show between 3 and 7 new members joining each month.

Additionally, some nonmembers come to our programs, which are open to the public. We are appreciative that many people do choose to become members of SSCA. Our informative and weekly newsletter has continued to entice participation in our

activities. Most new members and many renewing members are using the option to pay online although paper registration is still used and appreciated. In the absence of a membership chair, a board member temporarily served in the role to welcome new members. The administrator also changed the confirmation email to provide more information to those who join online.

## **PERSONNEL**

Co-Chairs: Nancy Daniel and Dan Snyder

The Committee makes recommendations to the full Board regarding contracted personnel. The only contracted personnel in 2023 was our Administrator, Stephanie McDonough. No changes in our personnel arrangements were made in 2023. Committee members are Sheila Bell and Shirley Mitrovich, in addition to the Co-Chairs.

## **COMMUNICATIONS**

Chair: Louise Coffin, succeeded by Jo Ellis

The goal of SSCA communications is to inform not only seniors but also the general public about the activities and influence of the Swarthmore Senior Citizens Association. SSCA strives to be a vital force: one that is recognized and appreciated for what it offers all Borough residents.

2023 was a year of transition for communications, as our founding newsletter editor, Linton Stables, and our Communications Chair, Louise Coffin, moved away to new phases of their lives. Fortunately, the communications torch was handed to Jo Ellis, who took over as editor of the newsletter. In her capable hands, the weekly newsletter continues to be our most visible form of communication, being emailed to over 1,000 addresses including those of seniors, Borough officials, Community Directory contacts, and others who have expressed interest in our programs. In addition to describing our programs, the newsletter provides information about a variety of opportunities and news, such as Park Avenue Community Center activities, Rotary events, Borough events, and library updates. Art work and other contributions from readers also appeared in the newsletter.

We experimented with providing hard-copy of the newsletter each Monday in the Swarthmore Public Library for 3 months in the Fall. Library staff generously cooperated with this effort to provide the newsletter to folks who don't do email. Unfortunately, we had to discontinue the experiment, because of the difficulty of getting the printout into the Library promptly and reliably. We did invite the few readers who used the hard copy to contact our Administrator, who would then try to find a way of meeting their needs.

Our Lunch and Learn series is our most popular program, offering presentations on a wide range of topics, as well as musical performance and activities. We hosted 37 Wednesday Lunch and Learn sessions in 2023, which are listed in Appendix A. Each attracted from 20 to 40 attendees. Guest speakers shared information on a wide

variety of topics, including brain health, the private side of Andrew Wyeth, and the Chester/Upland youth soccer program. Suggestions for sessions are always welcome. Some presentations were live performance by the Strath Haven Silvertones and other local musical artists. All programs were publicized in our e-newsletters and in The Swarthmorean weekly calendar.

We initiated a new program in 2023, which we call Web Wanderings. We meet every other Monday, year round, to enjoy viewing pre-recorded videos (on a wide range of topics), or custom-made collections of short videos that we put together about a topic (such as old-time comedy, winter activities, and bird behavior). The full list of Web Wanderings programs is presented in Appendix B.

We continued to promote SSCA through our website, SwarthmoreSeniors.com. We also have a group on nextdoor.com and a Facebook page as well as a presence on Burbio.com, a community calendar. We had an outreach table at the May Swarthmore Farmers Market, and also communicated with our audience through articles and ads in the Swarthmorean.

## **NOMINATING**

The Board, as a committee-of-the-whole, acted as the Nominating Committee

During 2023, the Board lost the services of these four valued members (as described in the President's Report): Linton Stables, Louise Coffin, Ann Foster and Gudrun Weinburg.

The Nominating Committee proposes the following for election to the Board of Directors:

**Mary Payne**, election to a term ending in 2026.

Mary has resided in Wallingford since 1999. Her undergrad degree is from the College of St. Benedict in Minnesota, followed by two years in Guatemala as a Peace Corps volunteer, MSW and MBA degrees from Temple University, licensed nursing home administrator, and assistant professor at Temple University. For 20 years she was a management consultant working with health care providers and medical schools nationally. She has served on many local and national boards, including 4 years as president of the Steamship Historical Society of America.

**Maria Elia**, election to a term ending in 2026

Maria and her family moved here in 2016 from Wallingford. Her daughters were 6 and 7 years old at that time. Maria was thrilled to give them a childhood running the streets and creeks of Swarthmore until they graduated from SHHS. She has volunteered at our schools, local clubs and the PAC center. Maria has a BA in Journalism and Communications. She has a MA in Mass Communication and worked for years as a writer/editor for newspapers and magazines in the Washington DC area and Philadelphia. Currently she works full-time as an ASL

Interpreter and can be seen working at Swarthmore College, Swarthmore Presbyterian Church and other local events as well as a variety of settings in the Philly area. Maria has met life-long friends in Swarthmore and is looking forward to meeting more with SSCA.

## **WELLNESS**

Chair: Sheila Bell

The Wellness Fair Committee decided to replace full-day wellness fairs with a series of smaller workshops on topics that appeal to seniors as well as the larger community. In July, Mary Thompson, who teaches yoga at the Park Avenue Community Center, presented a workshop on balance to 25 participants. This was informative and interactive and included lunch. Ellen Williams of COSA and one of her volunteers offered a two-afternoon workshop on fall prevention for 20 participants in August.

Arrangements have been made to present a Brain Health workshop by Harvard Medical School Professor Steven Arnold in January 2024. The Wellness Committee is seeking additional topics to address on a regular basis, three or four each year.

## **WALKS AND TRAILS**

Chair: Nancy Daniel

The [resources](#) SSCA created in 2020 to facilitate taking local self-guided walks continue to be available in three ways: as [laminated map cards](#) that can be checked out from the Swarthmore Public Library, as [maps](#) that can be downloaded and printed from the Borough website, and in the [AllTrails app](#). Walks and Trails Committee members and friends continued to enjoy leisurely walks.

## **TRAVELS**

Administrator: Stephanie McDonough

We are pleased that we were able to increase our SSCA travels, although not quite back to pre-COVID frequency. Trips were taken to the Herr's factory, Painter's Folly, and Wharton Esherick Museum. We greatly appreciate the generosity of the Swarthmore Presbyterian Church for donating the use of their van, and a driver, that makes these trips so safe and enjoyable.

## **TECH HELP DESK**

Chair: Dan Snyder

We have been providing tech help for anyone requesting it since 2022. We mostly meet in person at the PAC Center, the Swarthmore Public Library or in the home. Usually requests are for help learning how to use a device, or to solve a tech problem.

Most requests are for help with Apple devices, which Dan Snyder addresses; Rich Conti helps those using Windows devices. Help sessions typically last ½ to 1 hour, but sometimes are as brief as showing someone how to accomplish a task on their iPhone while in an aisle at the Coop. In 2023 we helped 48 people in a total of 90 help sessions. The Help Desk is reached by emailing SwarthmoreSeniors@gmail.com.

## **SENIOR ACTIVITIES AT THE PARK AVENUE COMMUNITY CENTER**

The Park Avenue Community Center is our space in Swarthmore. Most of our in-person activities happen there. The PAC Center maintains an open door policy and warmly welcomes Seniors and Delaware County residents of all ages to visit its facilities during weekdays from 9:00 a.m. until 9:00 p.m. In addition to SSCA-sponsored activities, there are many classes, lectures, concerts, and other opportunities for our members to engage in the community. SSCA is a Founding Partner of the PAC Center.

## **LUNCH AND LEARN**

Our Lunch and Learn series is our most popular program, offering presentations on a wide range of topics, as well as musical performance and activities. Please see Appendix A for our 2023 topic list. Suggestions for topics are always welcome.

## **WEB WANDERING**

Co-Chairs: Sheila Bell and Dan Snyder

In 2023 we started a series of year-round, every-other-week informal gatherings at the PAC Center to enjoy recorded shows or presentations on a wide variety of topics. Attendees at each session choose the topic for the next session. We enjoyed 20 sessions in 2023; the topics are shown in Appendix B.

## **GAMES**

Games went strong in 2023. Our established bridge tables continue to play regularly. Mah Jongg and Samba also play weekly and new players are always welcome. Our Friday games group is always open to new games, too!
