

# **DESCRIPTION**

3 Harbour Exchange is an impressive glass clad building, providing bright and efficient office floors which are wrapped around an off-set core. The building offers high quality office accommodation, with stunning views towards the O2 at Greenwich Peninsular, together with the iconic towers of Canary Wharf.

The area benefits from an exciting mix of local coffee bars and restaurants. The South Quay DLR station is adjacent to the entrance of the site, whilst the Canary Wharf estate, which benefits from the Jubilee line and extensive retail amenities, is only a 10 minute walk away.

The estate has been comprehensively re-landscaped adding improved amenities which helps contribute to a tranquil business environment.


# 9TH FLOOR SUGGESTED OPEN PLAN LAYOUT




