



### **2019 AHA Convention Report**

President Nancy Harvey started out the "President's State of the Association Address" with

The PAT lawsuit is over! All legal fees have been paid out of AHA funds but unfortunately insurance would not cover the cost of the lawsuit.

The "USEF Ad Hoc Committee's" objective was to fully investigate, understand, and recommend what AHA would have to establish internally, source from others, or eliminate if the relationship with USEF was discontinued. The study included licensing of officials (judges, stewards/technical delegates), equine drug testing program (development, administration, violations, education, independent contracting testing options), rule book development, violation/penalty rules & administration, welfare of the horse issues, amateur/professional certification, awards program, and any other aspects affecting AHA's affiliation with USEF. It was decided that AHA remain affiliated with USEF and that AHA continue to study the viability of the relationship.

For 2020 the AHA strategic plan is to development a comprehensive marketing plan, efficient management to drive business productivity, fiscal responsibility, streamline the business of AHA, organization of local/regional/national events with logical progression, and breeding/registration expansion.

The local Involvement task force put together the "Meet the Arabian" pilot program for Sept 21 and there



were 40 events held Sept 1<sup>st</sup> – Nov 13<sup>th</sup>, reaching apr. 5,000 people. The program provided marketing and promotional material, financial support, and magazines. Plans are to schedule Arabian days again for May & September in 2020. In the "Time to Ride" meeting the WDHA "Meet the Arabian Day" held at the WDHA Festival Show was even a featured picture as one of the events. I missed taking a snapshot but fairly certain it may have been one similar to this.

Lisa Blackstone provided a Market Development and Promotion (MDP) committee report and reported there are now 18 Goldie Project horses.

Braveheart supports the Baby's Heart Fund, Galaxy sold at the Shatner auction for \$10,000, and Sundance Kid will be auctioned at the same event. Hero, Region 9, was donated to the 3<sup>rd</sup> Calvary Division at Fort Hood, and Region X's "Salute" represents the valuable resource of equine assisted therapy for veterans.

Salute was a featured site at convention and Region X was given the opportunity to speak about Salute's journey. In making Salute's project successful 1) Have passion 2) Create a team 3) Create a brand 4) Set a goal 5) Have activities.

The American Horse Council (AHC), your unified voice in Washington, reported horses are still considered livestock not pets.

The house lawmakers overwhelmingly adopted the PAST (Prevent All Soring Tactics) Act, by a vote of 333 to 96. The AHC and its allies are focusing efforts on the Senate Commerce Committee and urging the panel to adopt the bill as written.

To address the ongoing labor shortage, AHC has joined the steering committee of the broad-based "H-2B Workforce Coalition".

For two years in a row, Congress has increased funding for Equine Assisted Activities and Therapies (EAAT) within the Department of Veterans Affairs (VA) budget, demonstrating a commitment to enlisting horses to help America's heroes.

With the deferred maintenance of public trails projects, it continues to hinder us access to national parks. This year the horse industry has been advocating for the "Restore Our Parks Act (ROPA) of 2019" and lobbying efforts are paying off. To date ROPA has gained 318 cosponsors in the House, the senate version 5.500 has 43 co-sponsors, and the National Forest Service Officials informed AHC that they support expanding the scope of ROPA.

Keynote speaker was Christy Landwehr, CEO Certified Horsemanship Association (CHA), and proud Alliance Partner of AHA.

She explained key takeaways of the current equine industry economic impact survey are while the number of horses declined by 11% to 7.2 million the economic impact is higher than in the 2005 study of \$122 billion in value added. Interest in horses is strong with 38 million horse enthusiasts, 30.5% of the households in the US, and 38% of participants are less than 38 years of age. Land preservation is pegged at 80 million acres, roughly the size of New Mexico.

In developing your business outline determine what is your type of business, what people do you need, and what types of insurance you need. Before you start marketing your business make sure your product/services are the best it can be. Define your Unique Selling Proposition (USP). What do you do better than anyone else? What would your current satisfied clients say you do better than anyone else? Rethink how you describe your assets. Move from merely telling the features to selling the benefits of those features. Develop a marketing plan, what is your mission, purpose, and why. Target your customers.

The Arabian Horse Foundation, the philanthropic arm of AHA, reported its key focus is youth programs/scholarships, public education about the breed, and equine research with an emphasis on diseases affecting Arabians in particular.

It reported since 2007 over \$130,000 in scholarships have been awarded, with \$39,00 awarded to 41 youths in 2019.

Since 2007 over \$85,000 have been donated toward research funding to the following institutions; UC Davis, University of Florida, Cornell, and Morris Animal Foundations.

Projects included DNA tests for cerebellar abiotrophy (CA), lavender foal syndrome (LFS), and investigation of juvenile idiopathic epilepsy (JIE), occipitoatlantoxial malformation (OAAM), equine metabolic syndrome (EMS), and melanoma. The research impact of these tests in 2017 was no positives for CA or LFS and in 2018 no for LFS, only one for CA. Breeders are utilizing these genetic tests to help prevent production of affected foals!!

Future projects are intended to be aimed at conditions affecting our performance horses and the success of the Foundation is based on kind donations from the Arabian Horse Community. Online giving can be done at <a href="https://www.thearabianhorsefoundation.org">www.thearabianhorsefoundation.org</a> and register with Amazon Smile and designate The Arabian Horse Foundation as your charity of choice and a portion of your purchases goes to the Foundation.

Resolutions that were the most controversial were;

#15-19 "Rescind Resolutions 20-03, 18-09, and 33-15" from AHA BOD, with the argument that with awarding a Top Five or Top Ten in smaller classes at Regionals and Nationals the prestige has been diminished and there would be substantial cost savings to the Regions and AHA. This resolution was not well received and was withdrawn.

Resolution #18-19 "Allowing Board Modification to Resolution with Restrictions" from AHA BODs, with the argument that any AHA Convention resolution which has been active for a period of ten years or longer and has not been amended by an AHA Convention resolution during that period of time, shall be under the control of the AHA Board of Directors for any future BOD's motions to amend or rescind. It was the opinion of many delegates that this resolution would take the governing decision of organization away from the resolution process and gives the ability of the AHA BOD's to change rules w/o resolution. This resolution had been referred to the Bylaws committee.

Resolution #17-19 "Combine Regional Championships Shows/Rides" from Regional Review Task Force. This resolution allows any two regions to combine their Regional Championship Competitions. These combined Regional Championships would be governed and managed by the two Regions and each class having one set of judges, on set of awards, and one set of National qualifications. There were so many amends made from the floor on the on this resolution, in my opinion this resolution should have gone back to committee, but it was approved by majority.

Now, this led to the Regional Restructure draft. The goal of this regional restructure is to increase the importance, viability, and participation in these newly created show areas so as to aid in the promotion of the Arabian Horse. Here is a picture of the proposed new AHA Regionals Boundaries. Your opinion is important, whether you are in favor to not of the proposed regionals restructuring plan. Please let your WHDA BODs/officers know your opinion and you could also contact AHA regarding the restructure proposal. If you would like copy of the full report, please let me know and I can send it to you.





Thank you to WDHA for giving your delegates the opportunity to represent WHDA at the AHA convention. We placed our resolution votes how WDHA directed us to at the annual

meeting, attended many meetings, and are providing you a convention report. In closing, Gail and I could not pass on having our picture taking with Salute ②.

The WDHA Futurity offers both halter and performance classes for yearlings through five year olds. Foals are nominated in utero and maintained in the program through their five year old year with annual nominations. Through generous support of the annual Awards Banquet Silent auction, raffles, and drawings, every year supplemental funds are added to the nomination fees. For example, last year, **every entry** at the show had over \$50 added to its respective class.

Last year, and again for 2020, WDHA is adding \$100 per futurity class, plus the added per entry raffle money PLUS nomination fees to all Futurity classes.
