ENTRIES: BRING THE ORIGINAL COGGINS ON THE DAY OF THE SHOW!! Wisconsin requires a negative COGGINS TEST, dated within the current calendar year. Original report form or a health certificate with date of Coggins test must be presented prior to horse being unloaded at the show. Coggins must be legible. The State of Wisconsin requires a health certificate for all horses entering the state. For clarification, use horse's show name on the Coggins test and not his stable name. Send photocopy with entry form.

Equine Influenza & Herpes Virus Vaccine Documentation—Within the last 6 Months: Documentation of administration within the last 6 months for the Equine Influenza & Herpes Virus vaccines must be sent in with stall request form. A copy will also need to be presented and left in the Show Office if not sent in with stall request form. Horses will not be allowed off trailers without proper documentation. GR 844 (BOD 01/17/15 Effective 12/01/15)

**INCOMPLETE ENTRIES/COPIES:** Send copies of all association cards and certificates with your entry. Per USEF, you are now **required** to send a copy of your US Equestrian Federation card with your entry. Please include a copy of both sides of registration papers with your entry. **Incomplete entries will be assessed \$25.00.** No numbers will be given without a complete entry.

<u>ONLINE ENTRIES:</u> Because of COVID-19 social distancing and regulations, exhibitors are encouraged to do their entries online by registering at <u>www.equestrianentries.com</u>. At that website, please create an account, log in and look for our show to complete your entries.

<u>Arabian owners/riders/handlers:</u> Current Competition Level Membership is required for all owners, trainers, riders, drivers & handlers or a Single Event Membership must be purchased for \$35 per person. Single event membership is not applicable to regional classes.

AHA Member Statement: Each competitor (this includes at least one recorded owner and all trainers, drivers, riders, halter handlers, coaches, and the person(s) signing the entry blank) in an Arabian Horse Association recognized Arabian division, at the time of entry into a competition, must submit a copy of a valid AHA membership/competition card, join AHA or pay an AHA single event membership fee per competitor. When an agent signs for the owner at an AHA recognized competition, both the owner and agent must be members of AHA or pay the AHA single event membership. Single event membership is not acceptable at AHA regional or national competitions. Exhibitors in walk-trot classes are exempt from AHA membership requirements at qualifying competitions but must have an AHA membership with competition card at AHA regional and national competitions. Exhibitors in lead line classes or parents/guardians signing for minors are exempt from AHA membership requirements (BOD 5/12)

<u>Western Dressage:</u> Arabian competitors must be members of USEF and AHA (if applicable). **WDAA** membership is now required for all exhibitors, owners, trainers, coaches. A non-member fee of \$35 may be paid at the Show Office. From the WDAA website under show recognition: Western dressage shows or divisions that are USEF-licensed Regular or Local shows require that all riders, owners, and trainers are WDAA members or pay a non-member fee. Members may join WDAA at the show using a membership form to be provided at the show office. USEF Lite shows/divisions do NOT require WDAA membership. Membership in WDAA may also be completed at their website – wdaa.memberclicks.net.

Entry Fees: To be accepted, entries must be complete, correct and postmarked by the closing date. Entries must be accompanied by full payment in order to be processed. An entry form must be completed and fees paid for every horse on the show grounds. Entries must be signed by the owner/agent, the trainer, and by all riders/handlers. Juniors may not sign the entry form. Exhibitors are responsible for their own errors and those of their agents in the preparation of entry blanks. Exhibitor numbers will not be released until all entries are complete. Make checks payable to WDHA. Mail all entries to: Deborah Heier, Entry Secretary, P. O. Box 12812, Green Bay, WI 54307-2812. (Late entries may be permitted in Sport Horse classes after the deadline but no later than <u>June 10. 2022</u>, space/time permitting and payment of a late entry fee. Late fee is charged PER CLASS, in addition to the regular class fee. i.e. Class fee \$30 + \$10 late fee = \$40 for class). Entries may now be done online as well at www.equestrianentries.com

**Option Classes:** Option Classes may be purchased from the list provided for \$75.00, which includes one (1) entry into that class. (i.e. Prix St Georges Option fee \$35 + class fee \$40 = \$75). Any other entries into that particular class will be at the cost of the class. The cost for the class is listed in the fee list. Option classes will offered on both days and are listed on the class lists.

<u>Refunds:</u> Class entry fees and AHA 9-90/Post-Recognition fees will be refunded if written verification of unsoundness by a veterinarian is in possession of the Show Secretary **before the commencement of the show.** Stall fees and other related show fees will not be refunded.

<u>Arenas:</u> Competition arenas: The covered arena area is 150' x 220' with a sand footing. There is an attached warm-up ring of 150'x80', also with sand footing. Outdoor arena is 150'x 220' with an 80'x 150' holding pen; sand footing. For your protection, **No** grass warm up is available. Tests so approved by US Equestrian Federation may be held in a small arena.

**Stabling:** Stalls are 10 x 10 in size and located in Barns C and D. Stabling will be available **after 12:00 noon on Wednesday, June 15, 2022**. All horses must have a stall. There will be no showing out of a trailer. Please be considerate of your stall neighbors when arriving at the grounds. Do not change your stall location unless you check with the barn manager.

Stalls are box stalls with fixed fronts. Anyone bringing a stallion is responsible for bringing suitable equipment to close off the stall, if necessary. Stabling requests will be honored, when possible, but are not guaranteed. If you wish to be stabled with specific people, it is recommended that all entries be mailed together. Those making no requests will be considered as having no preference. Tack stalls may be limited if entries warrant.

<u>Stall Deposit</u>. A separate check for \$25.00 per horse stall is to be left in the show office to cover stall cleaning should you decide not to clean your stall. Your check will be returned to you once the barn manager has checked your stall. This check will only be deposited if your stall is not cleaned. SHOW MANAGEMENT IS REQUESTING THAT ALL STALLS BE STRIPPED PRIOR TO LEAVING TO HELP KEEP COSTS DOWN.

### THERE IS TO BE NO SMOKING IN THE BARNS.

**Bedding:** Bedding will be available on the grounds for your convenience at \$9 per bag. A minimum order of 2 bags. Order your bedding with your entry to the show and have it delivered to your stalls. If bedding is ordered after you get to the show, please do so early in the day.

<u>Camping fees:</u> \$40 per night. All camping is to be in Lot #2 and this is the only area available. Camping fees are to be paid with your entry to the show. There is to be no camping in areas that are not designated as camping. There is an on-site dumping station. There are also shower facilities. Fires are not permitted.

<u>PARKING:</u> All vehicles must use <u>Parking area #2, #3, and #4</u>. Parking on the roadways is not allowed and is posted. Violators may be ticketed by Oshkosh Police.

**<u>DOGS and OTHER ANIMALS:</u>** Please do **NOT** bring them. If you must, keep them on a **short leash** attached to a responsible adult. Waste must be cleaned up.

**EXHIBITORS**: Entering a horse in classes differing by more than one level (Dressage/Western Dressage) is prohibited. Junior exhibitors are able to enter both the Amateur to Ride/Handle classes as well as the Open classes.

**NON-COMPETING HORSES:** Horses that may be arriving early to compete at the Regional show only will need to pay the non-compete fees of \$115 (Stall and office fee). This includes horses who are stabled with and/or traveling with horses who will be competing at the WDHA show as well as Regionals. All horses must have a number while on the grounds. Non-competing horses cannot be exercised or ridden during competition hours in the official warm-up areas or competition rings.

<u>PROTECTIVE HEAD GEAR.</u> From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Please see the complete rule, USEF DR120.1.1.

**NSF CHECK POLICY.** There will be a \$50 penalty each time a check is presented to our bank and returned due to insufficient funds. Violators will be reported to US Equestrian Federation. Guaranteed funds will be required of violators in the future.

<u>RIDE TIMES:</u> Unofficial ride times will be posted to <u>www.foxvillage.com</u>. It is up to the exhibitor to notify show management of any conflicts as soon as possible after receiving the unofficial times. No calls will be accepted by exhibitors asking for ride times. The official ride times will be posted by NOON IN THE SHOW OFFICE the day before competition begins.

**WARNING:** Under the Equine Activity Liability Act, each participant who participates in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.

# "EVERY CLASS OFFERED, HEREIN, WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT FEDERATION RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH." BOD 1/16/05 Effective 12/1/05 GR1101 - Horse ID Number (HID):

- 1. All horses competing in Federation licensed competitions must be properly identified. For all such competitions, entries for each horse must include either a Federation-issued Unique Horse Identification Number or a registration number from a Federation Recognized Affiliate. Additionally, a Federation Recognized Discipline Affiliate may require horses to be registered with their organization, and if so, the entry must also include that registration number.
- 2. The Federation will issue only one Unique Horse ID Number per horse. This Unique Horse ID number must subsequently remain with the horse in perpetuity, and shall not be changed for any reason, including upgrade from Unique Horse ID to a Recording, change of ownership, change of name, or death.
- 3. Prior to submitting an application for a new Unique Horse ID number, it is the owner's responsibility to verify the current ID status of a horse through a Horse Recording/ID search, (the assistance of Federation staff may be requested). Anyone who knowingly seeks to obtain an additional Unique Horse ID Number for a horse which has previously been issued one is subject to disciplinary action.
- 4. The Federation must be notified of any change of ownership and/or competition name of the horse.
- 5. Owners are requested to notify the Federation of corrections to previously submitted information, e.g., names, addresses, breed registration, pedigree, or markings.
- 6. A Unique Horse ID number can be upgraded to Federation recording. The Unique Horse ID Number will remain the same.
- 7. Applications for Unique Horse ID Numbers and/or recordings can be completed online at www.usef.org using the Horse application form which can also be downloaded. The ID application form is also available on request from the Federation office, and from competition management.
- 8. Competition management is responsible for notifying exhibitors in their prize lists of the Unique Horse ID Number requirement, and availability of Horse ID Number application forms.
- 9. There will be no charge for Unique Horse ID Numbers that are issued via the internet to members of USEF or its affiliates for: 1) horses that are life recorded, registered or otherwise identified or listed with a USEF discipline affiliate, or 2) horses registered with a USEF breed affiliate. Horses not meeting the above criteria must have a completed USEF Horse application indicating on the application the request for a Horse ID before a number will be issued. This form can be completed on the internet, free of charge, at www.usef.org

### **GENERAL INFORMATION**

(Please read for information regarding classes, etc)

ATTENTION EXHIBITORS: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses, or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**PREMIUMS:** Ribbons through 6<sup>th</sup> place.

### **SAFE SPORT**

REMINDER: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

## **High Point Awards**

The high point awards given at the show, Purebred Arabian Open, HA/AA Open, PB/HA/AA Junior to Ride and Amateur to Ride are given to the highest scoring ride in each of these categories. There will be no duplication of awards (i.e. highest JTR cannot win highest ATR or Open award). The High Percentage Dressage Ride sponsored by Dah-Ban Arabians will be awarded to the highest overall dressage score and **MAY** duplicate a previously given high point award. This is the only award that may possibly duplicate another award.

## FOOD ON THE GROUNDS

Food services to be determined.

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").



<u>USDF Membership Benefits:</u> USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at www.usdf.org.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

### Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
  sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
  Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
  exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
  academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
  identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

### Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

## **USDF** Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a member-ship of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.
