**From the North:** Take I43 South (apr. 1 1/2 hrs. south of Green Bay); Exit 92 (Hwy 60 Grafton); Go West; Exit 92 (Hwy 60 – Grafton); Go West 3 miles to the 5 Corners area; Turn left onto Washington Ave.; 1 1/2 miles ahead turn left onto Cambridge and take and immediate right into Fairgrounds.

**From the South:** Take I43 North (approximately 25 minutes north of Milwaukee); Exit 89 (Hwy C – Cedarburg); Go West 3 miles to Washington Ave.; Turn right onto Washington Ave. Go through the historic shopping district. (4 stoplights); Turn right onto Cambridge and then take an immediate right into Fairgrounds.

**From the West:** Take Hwy 45 or Hwy 41; Exit Hwy 60 East (Jackson) exit; Continue East through Jackson to the 5 Corners area.; Turn right onto Washington Ave.; Continue approximately 1 1/2 mile south. Turn left onto Cambridge and take an immediate right into Fairgrounds.

**Show Office Hours** Open Thursday May 18th, 2023 at 2:00 p.m. to 8:00 p.m. Open one hour before the beginning of the show each day and remain open at least one-half hour after the end of evening/last session. Open all other times during all sessions. You may check out as soon as you entered your last class, but make sure it is your LAST class.

**Stabling and warm-up/competition rings:**

**Stabling:** Stalls will be available 9:00 am on Thursday, May 18th (not before)

**Warmup/competition rings:** Opens 1:00 pm, Thursday, May 18th (not before)

**Camping** Ozaukee County Horse Facility has 39 camping locations with electrical/water and shower location. Camping locations are on a first come basis. The fee is \$35 per night and must be paid to Leesa Berhow, show secretary. A permit will be given and it must be displayed in a very visible location on the trailer or vehicle.

## General Information for WDHA The Badger Show AVS

*All AHA classes will be judged by one judge and those placings shall prevail.*

- 1. Equine Influenza & Herpes Virus Vaccine Documentation—Within Last 6 Months:** Documentation of administration within the last 6 months for the Equine Influenza & Herpes Virus vaccines must be sent in with stall request form. A copy will also need to be presented and left in the Show Office if not sent in with stall request form. **Horses will not be allowed off of trailers without proper documentation.** GR 845 (BOD 01/17/15, Effective 12/01/15)
- 2. Cancellation or Substitution of Entries/Refunds:** All fees for entries including stall, office, AHA fees canceled before May 1, 2023 will be refunded in full. No horse will be excused because of sickness after the closing date of entries without a Veterinarian Certificate which must include the horse's name, classes entered, symptoms, diagnosis, treatment, the veterinarian's original signature, address and phone number. This will be reviewed by the Show Committee to determine if any refund will be given with exception to the 9-90 fee. **Stalls may not be resold for any reason except by Show Management.** No substitution of horses will be permitted. USEF GR 911. All refunds will be made by mail after the close of the show. In the event of cancellation of classes due to severe weather or other emergency, refund of entry fees for canceled classes will be made upon written request by the exhibitor within 30 days of the cancellation. USEF GR 832
- 3. Negative Coggins Test/Health Papers—Current Calendar Year:** A current year negative Coggins test (2023) is required for all horses on the grounds. The original Coggins report or an official Health Certificate with date of test and results must be presented at the Show Office with a copy left in the Show Office. Wisconsin law requires current health papers for all horses entering the state.
- 4. Officials:** If a show official fails to attend this show or to perform his/her duties for any reason, the Show Committee reserves the right to substitute a show official. USEF GR1211.2 (b)
- 5. Registration:** To be shown in the AHA classes, horses must be registered with the Arabian Horse Association Registry or the Canadian Arabian Horse Registry or the Canadian Half Arabian Horse Registry. If a horse is under one year of age, it must be eligible for registration and the registration must have been applied for.
- 6. Discipline:** Exhibitors are warned that any act of discourtesy or disobedience to the officials of this show on the part of the owner, lessee, trainer, groom, rider, driver or handler will disqualify the horse from adjudication. Show Management reserves the right to remove any of the above listed from the show without being liable for compensation or damages (GR 702). Any action(s) against a horse by an exhibitor which are deemed excessive by a judge, federation steward, technical delegate or show veterinarian, in the competition ring or anywhere on the competition grounds may be punished by official warning, elimination, or other sanctions which may be deemed appropriate by the Show Committee. GR702 & 703
- 7. AHA Member Statement:** Each competitor (this includes at least one recorded owner and all trainers, drivers, riders, halter handlers, coaches, and the person(s) signing the entry blank) in an Arabian Horse Association recognized Arabian division, at the time of entry into a competition, must submit a copy of a valid AHA membership/competition card, join AHA or pay an AHA single event membership fee per competitor. When an agent signs for the owner at an AHA recognized competition, both the owner and agent must be members of AHA or pay the AHA single event membership. Single event membership is not acceptable at AHA regional or national competitions. Exhibitors in walk-trot 10 & under classes are exempt from AHA membership requirements at qualifying competitions, but must have an AHA membership with competition card at AHA regional and national competitions. Exhibitors in lead line classes or parents/guardians signing for minors are exempt from AHA membership requirements (BOD 5/12)
- 8. Physical Inspection:** All animals are subject to a physical inspection at no charge by the Show Management at the discretion of the Show Committee as a safeguard against communicable diseases. Any horse who exhibits questionable symptoms must be immediately removed from the show grounds. Examination or treatment not requested by show officials shall be on a private practice basis.
- 9. Attendants/Grooms/Headers:** No person will be permitted to enter the ring except participants in the class, judges, their assistants, and show officials. Attendants, grooms, and/or headers may enter the ring only when summoned by order of the judge. Headers will be permitted in all driving classes.
- 10. Stallions:** Purebred Arabian Stallions may be shown by ladies and junior exhibitors in any class open to purebred Arabian stallions except Lead Line, Showmanship and Walk-Trot classes.
- 11. Class Size:** The Show Committee reserves the right to split any class with duplicate awards presented. Any class may be canceled, divided, or combined at the discretion of the show management.
- 12. Public Address System:** **Calls for classes are provided as a courtesy.** Classes will be called promptly. Up to two minutes may be allowed after the first horse enters the ring. If an exhibitor has a succeeding class, he/she must notify the person in charge of the gate that he/she may need more time. A three minute tack change may be allowed if the gate person has been notified at least two (2) classes in advance. Responsibility for entering classes rests with the exhibitor. In the event of failure of the sound system, exhibitors must be ready to enter the ring at the appropriate time.
- 13. Emergency Equine Surgery:** Wisconsin Equine Clinic, 39151 Delafield Rd, Oconomowoc, WI 800-564-1550 or 262-569-1550.
- 14. Warm-up Facilities & Competition Arenas:** The indoor ring is 76' wide by 196' long and the footing is sand mixture. Outside show ring is 250' wide x 150' long and the footing is a drained sand mixture. Warm-up show ring is 200' wide x 80' long and the footing is a drained sand mixture. **Warmup and competition rings are not available until 1 pm, Thursday, May 18th.**
- Ring Drags:** All warm-up arenas and competition rings will be dragged and watered a half hour before the start of each session or as needed.
- 15. Pets:** All pets must be on a leash at all times and are prohibited in the Show Arena. Pet owners are required to supply an official rabies vaccination certificate showing the date and serum used. Proof of service dog status is required and must be promptly shown when asked. GR1301.6
- 16. Campers:** Camping is available at the cost of \$35 per night. Payment can be made on entry blank or in person at the show office. A camper permit must be displayed on camper, auto or tent. Permit is obtained in the show office with a paid request.
- 17. Medical Waste:** All medical waste must be disposed of in accordance with Wisconsin medical waste guidelines. Sharps containers for the disposal of needles and syringes are located in front of each stalling barn.
- 18. Halter Classes:** Horses must be at the gate and ready to enter the ring when the exhibitor's number is called. Any horse not present and ready, will not be admitted to the class. Products may not be applied to hoof or hide to conceal a conformation defect. Clear or transparent products may be used on hooves for Breeding or In-Hand classes. All Halter classes will be judged comparatively and the In The Ring procedure will be used.
- 19. Stalls:** Stalls in the main barn are permanent box stalls constructed of metal frame and wood with doors and floor base is traffic bond. The Barn Manager will be available at 9:00 am on Thursday, May 18, 2023. Thereafter, the Barn Manager will be available from 7 a.m. to one-half hour after classes end until the close of the show. Stall assignments will be posted on the show office door after hours. **Bedding must be pre-ordered by May 10th, none available to purchase on the grounds.** No grain or hay will be available. No stalls will be reserved without payment. No changes in stabling permitted w/o the permission of the Barn Manager. No stalls may be resold. **Tack/Feed Stalls may be limited.**

**Stall Decorations:** All stall curtains and materials must be certified fire proof and/or a fire extinguisher must be present. **Damaged Stalls** will be charged a \$150.00 damage fee. **Arrivals & Departure Times:** Stalls will be available at 9:00 am on Thursday, May 18th, 2023. All horses and equipment must be removed from the fairgrounds by 10 p.m., Sunday, May 21, 2023.

**20. Open Checks:** No open checks will be accepted for pre-entry fees or stall reservations. All pre-entries and stall reservations **must** be accompanied by fully completed negotiable checks dated on or before the closing date. Entries received without such checks will be charged post entry fees. **All files must have an open check with the secretary during the show.**

**21. Minors and Motorized Vehicles** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will cause sanctions against the parent(s), guardian(s), and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. USEF GR 901.29

**22. Location of Classes:** Management reserves the right to hold classes or a portion of classes on the grounds at an appropriate location other than the arena, if necessary. Show Management reserves the right to make changes in procedures, rules & regulations as shall be deemed to be in the best interest of the show.

**23. Printing Errors:** The Show Committee is not responsible for errors in printing. Correction of any errors will be posted in the show office.

**24. Option Classes:** Option classes may be purchased by any exhibitor. All purchases must be completed by 7 pm on the day before the show begins. Other exhibitors may then enter the class at any time prior to the class being held with no post entry fee. Select the option class you want and request your first, second, and third choice for placing that class in the class schedule. Only 2 option classes per session allowed. Show management will make final decisions on placement. Email or mail the form to Leesa Berhow. Option class fee includes Class and AHA fees. Questions? Call Leesa Berhow at 715-643-2494.

**25. Determining Maiden, Novice, Limit horse/rider:** Ribbons won in one-horse classes do not count in reckoning the maiden, novice or limit status of either horse and/or rider/driver in any division. GR135.3. The status of Maiden, Novice or Limit entries is as of the closing date of entries, May 01, 2023. Maiden—no firsts, Novice—has not won three firsts, Limit has not won six firsts. **Do not count wins in one-horse classes.**

**26. Rules and Specifications:** Every class offered herein which is covered by the Rules and Specifications of the current USEF Rulebook will be conducted and judged in accordance therewith.

**27. Sport Horse Exhibitors:** All Exhibitors are encouraged to cross enter both arenas, and showcase the versatile Arabians/HA/AA, however, The Badger Show will do its best not hold classes in either arena due to entries' conflicting class in another arena. Please refer to AR-17 for Sport Horse class procedures, specification, or appointments. Bridles are mandatory on horses three years and older for In Hand classes (AR177.2). SHIH Classes may run out of order to accommodate entries. Check with the Office for Order of Go.

**28. NO:** Abbreviation for Non-Qualifying

**29. ACT/Academy Class Rules:** Show attire is not required and, in fact, full show attire should not be worn. Dark trousers and a light-colored (usually white) long-sleeved blouse or dress shirt, helmet, and boots are usual. ACTS/Academy classes are not open to riders participating in the regular riding classes at this show or at any previous show. Once you show "dressed" at a recognized show in a riding class, you are no longer allowed to show in ACTS classes. Lesson horses may be used and may wear work tack. Horses of any breed are allowed. All ACTS classes are to be judged on the ability of the rider to control and show his/her horse to its best advantage and upon the riding skills of the rider. Each class should be judged on the rider's basic equitation and horsemanship skills suited to the class discipline with emphasis placed on the rider's ability to control the horse at all times, identify correct diagonals and leads promptly, and control the horse's rate in a consistent manner. Riders should convey the impression of good posture, balance, and effective control while commanding the proper speed of gaits and show ring placement. Headers are allowed in the line up in all walk-trot classes. HORSES ARE NOT TO BE JUDGED, only the rider's ability to control themselves and their horses and present themselves to their best advantage.

**30. Open Classes Judging Criteria:** Saddleseat/Huntseat open classes will use USEF Chapter EP English Pleasure Division for Saddleseat/Huntseat. Western open classes will use USEF Chapter WS Western Division. Copy of these rules will be available at the show office.

**31. Photography:** Show management has contracted with a professional photography company to provide Official show photography services. Photographs will be taken of exhibitors/horses in each class and made available for purchase on the Official Photographer's website. No other person may photograph, sell, or give away images taken anywhere on the show grounds without prior written consent from the Official Photographer. Persons may, however, photograph family members and their own horses. Contact the Official Photographer with any special requests

## Complete Entry Instructions and Show Office Procedures

1. Include the complete name and address of owners, trainers, riders, handlers, drivers and walk-trot riders. The horse owner's name must be exactly as it appears on the registration papers. Leased horses need a copy of the lease agreement. No leased horses may exhibit in an Amateur Owner class. Enclose a copy of the registration papers for each horse and copies of AHA membership cards for each owner, trainer and exhibitor.
2. AHA non-members may pay a \$35 single event membership fee. Walk-trot 10 & Under, Lead line exhibitors, and parents who sign for their children are not required to be members of AHA.
3. The back of the entry form must have every exhibitor, rider, owner, driver, handler, coach and trainer (trainer in this sense means the person taking care of the horse) signature or his/her agent(s) must sign the entry blank. GR 908 A parent/guardian signature for all exhibitors under the age of 18 years is required
4. Include a photocopy of the horse's negative Coggins Test dated within the last 12 months. The original copy will be verified at check-in.
5. Include a photocopy of the horse's Equine Influenza & Herpes Virus Vaccine Administration within the last 6 months.
6. Enclose your check or other payment instrument made out to **The Badger Show**, signed, and dated. Also enclose the stall request sheet located within this booklet. People requesting stalling together must have each other's names listed on the "stall with" section and must get their entries in by May 1, 2023. **If a tack stall is being shared by two or more people, the cost of the stall must be paid in full by one person.**
7. Post-entered horses will be charged post entry class fees except for Option Classes.
8. No fee will be charged to change a class if a class is added **at the same time** a class is scratched. Scratched classes will not be refunded. The scratch and add must be completed in the show office prior to the classes scratched and added. **Any classes scratched or any class that the competitor doesn't show for without notifying the office or paddock manager will be charged a \$5.00 scratch fee.**
9. Settlements will be calculated and paid **in their entirety** by either the trainer or the owner. Settlement of fees and closing out open checks should be done no less than one hour after the last class ends. **You may check out earlier when you have entered the last class—but make sure it is the last class.**

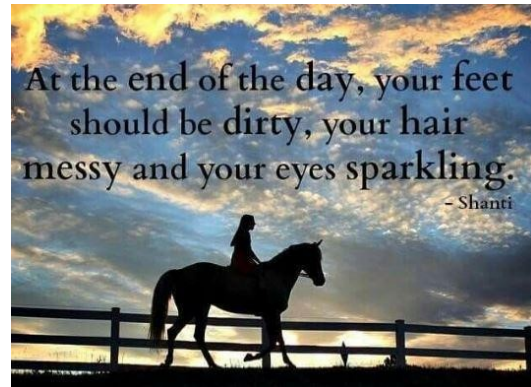

**I AGREE** that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. **I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.**

**I FUTHER AGREE** that by participating in an Amateur class that I am in compliance with the USEF Amateur rule.

**By signing below** as a parent or guardian of a junior exhibitor, I consent to the child's participation and agree to all of the above provisions, and further agree to assume all of the obligations of this AHA Assumption of Risk, Release and Indemnification personally and on behalf of the child.

**This AHA Assumption of Risk, Release and Indemnification** is governed by the Laws of the State of Colorado and is intended to be interpreted as broadly as possible. I agree that exclusive jurisdiction and venue (place) for any legal action against AHA, its officers, directors, employees, volunteers or agents shall be in the local district courts or the federal court of the State of Colorado. If any part of this agreement is determined to be unenforceable, all other parts shall remain in effect.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and The Festival Show AVS; I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

**A. RULES AND REGULATIONS:** I hereby agree to be bound and abide by the rules, regulations, and policies of USEF as published in the USEF Rule Book and on the website at www.usef.org, as amended from time to time.

**B.
